



# Minimum Standards for Privately Rented Housing

## Request Form for the Inspection of a Privately Rented Dwelling pursuant to the Housing (Standards for Rented Houses) Regulations 2019

### Before completing this form, please read and understand the following:

1. Your landlord has a legal obligation to ensure that your rented home is compliant with the minimum standards defined in the Housing (Standards for Rented Houses) Regulations 2019 S.I. No. 137/2019.
2. Your Landlord **must** be informed of any problems that may arise with your home. They must be given a reasonable opportunity to access the property to address the issue before contacting this office. This request form should only be submitted if you have been unsuccessful in having your landlord address the problem adequately.
3. Only complaints that specifically relate to suspected non-compliances with the Housing (Standards for Rented Houses) Regulations 2019 can be investigated. Complaints which do not relate to the Regulations cannot be investigated.
4. Only complaints from tenant's resident in the rented dwelling will be investigated. Complaints lodged by third parties cannot be entertained.
5. Inspections will be carried out at the discretion of Cork City Council.
