4.1.1 <u>PROPOSED SECTION 85 AGREEMENT WITH CORK COUNTY COUNCIL –</u> <u>FOR IMPROVEMENT WORKS AT THE JUNCTION OF SOUTH DOUGLAS</u> <u>ROAD/N40 OFF RAMP, DOUGLAS WEST, CORK</u>

On the proposal of Comhairleoir T. Shannon, seconded by Comhairleoir C. O'Leary, An Chomhairle considered and approved the request from Cork County Council to enter into an Agreement in accordance with Section 85 of the Local Government Act 2001 and further agreed to adopt the following Resolution:-

"Now Council hereby RESOLVES AS FOLLOWS

To facilitate the proposed modifications of the South Douglas Road/N40 off ramp Douglas West Junction and the removal of the roundabout at South Douglas Road as set out in the Schedule hereto so as to provide better distribution of time for all traffic at the junction and to provide safer access to schools for pupils and parents, by improving pedestrian facilities

at South Douglas Road and into the Douglas Village area which said proposed works are partly within the administrative area of Cork City Council.

Cork City Council is of the opinion that it would be more convenient that Cork County Council would carry out on behalf of Cork City Council its powers functions and duties as a local authority and or as a road authority insofar as they relate to concern and or involve the proposed works set out in the Schedule hereto, insofar as the proposed works shall be situated within the administrative area of Cork City Council and Cork County Council is able and willing to do so.

Accordingly, Cork City Council hereby resolves to enter into an Agreement with Cork County Council pursuant to the provisions of Section 85 of the Local Government Act 2001 and Section 14 of the Roads Act 1993.

SCHEDULE ("the proposed works")

The proposed works consist of the removal of the existing roundabout on South Douglas road at the junction with the N40 off ramp, Douglas west and Willow Park. The installation of traffic signals on three approach roads and revised layout of the road into Willow Park and Gaelscoil Na Doughlaise and the revision of the layout of lanes at the end of N40 off ramp.

The proposed works will also extend the existing footpaths and the construction of a traffic island.

The proposed works also consist of coordination of the new signalised junction with signals at the adjacent junction at West Douglas/N40 On Ramp.

6.2 <u>RESURFACING AND UPKEEP OF ROADS IN UAM VAR AND ELTON LAWN,</u> <u>BISHOPSTOWN</u>

In response to the following question submitted by Comhairleoir M. Shields, a written reply was circulated as outlined below:-

Re: Resurfacing and upkeep of roads in Uam Var and Elton Lawn, Bishopstown

The roads in the above area are in a dreadful condition and have been badly neglected despite the fact that these roads are extremely busy and at times congested, servicing C I T, Fas, Boston Scientific, many schools and indeed this area is a "rat-run" for most motorists in business on the north side of Bishopstown. A recent count done by residences revealed that in one hour on a given morning 800+ vehicles used the roads in the area and it is reasonable to assume the same number used the same route in the evening. The residents of these areas and Councillors in the ward have been highlighting the dangerous state of these roads to the Roads Dept of Cork City Council but little no action has been taken. What can be done to remedy the situation? In view of the fact that these roads are categorized "Estate Roads" when they carry far more traffic than many designated "Main Roads" could this area have the same status as the main roads with regard to the upkeep and maintenance of **their** roads infrastructure?

REPLY

Traffic calming measures have been introduced along sections of Uam Var to reduce speed and to deter the use of the route between Curaheen Road and Rossa Avenue as a 'rat run'. In addition requests for the renewal of signs and lining in the Um Var and Elton Lawn area are addressed on a regular basis. The elimination of through traffic travelling through Uam Var and Elton Lawn will only be achieved if the connection between Curaheen Road and Rossa Avenue is permanently removed. The procedures for same are set out in Section 38 of the Road Traffic Act 1994.

Sections of the roads in question at Uam Var and Elton Lawn have been attended to as part of road maintenance direct labour patching programmes in recent years. The Council has also identified further sections which require attention, and these will be addressed as part of the 2017 programme. The area will also be considered for inclusion in future roads resurfacing programmes.

6.3 WHITECHURCH ROAD SITE

In response to the following question submitted by Comhairleoir S. Martin, a written reply was circulated as outlined below:-

How much money was paid for the Whitechurch Road site. What additional works have to be carried out to make this site fit for development purposes?

REPLY

The land acquisition costs of the Old Whitechurch Road Site consisting of circa 22 hectares in total amounted to $\notin 25,034,235$. The largest parcel of these lands known as the O'Mullane lands cost $\notin 18,835,550$ and the value was ordered by an independent Arbitrator appointed under the Arbitration Act, 1954 following the completion of a Compulsory Purchase Order process. The costs of developing these lands was considered by the Arbitrator in his determination of the value of the lands.

The primary enabling infrastructure required to facilitate normal development of these lands which are in the City Council jurisdiction is the undergrounding of the linear national grid infrastructure which is estimated at \notin 4.8 million. This cost together with other infrastructural costs for works such as approach entrances, spine access route and provision of trunk drainage/utility services is included in the recently approved \notin 9.89 million by the City Council under the Local Infrastructure Housing Activation Fund (LIHAF) announced by the Department of Housing, Planning, Community & Local Government. The primary purpose of the Fund is to enable the delivery and provision of reasonably priced new housing to the marketplace; in this case the pent-up demand in the Northside of the City.

6.4 **DERELICT SITES REGISTER**

In response to the following question submitted by Comhairleoir T. Brosnan, a written reply was circulated as outlined below:-

Can the Chief Executive please provide an update in relation to the inclusion of St Anthony's, Ballyhooley Road, Cork on the Derelict Sites Register. It has already been notified to city officials by neighbouring residents. It appears to be in a state of near collapse and in recent days both its front door and rear door have been pushed open. Is the owner known to Council officials and can I please have an explanation of why entry onto the Derelict Sites register is taking so long. Are officials satisfied there is no danger to neighbours from possible gas or water leaks or from electrical fittings.

REPLY

The property known as "St Anthony's", Ballyhooley Road, was entered on the City Council's Derelict Sites Register on the 6th March 2017. The current owner, as listed publicly on the Derelict Sites Register, is Maria Colbert. Issues arising from possible gas or water leaks or from electrical fittings are a matter for the owner and the relevant service providers.

6.5 **PARKING IN CORK CITY**

Can the CE please advise the following:

The number of Public Disabled Parking Spaces in the City.

What funding has Cork City Council received in the past 5 years to upgrade or introduce disabled parking spaces?

How many disabled parking places are planned to be introduced in the next 12 months?

REPLY

There are approximately 112 disabled parking spaces across the City centre and this number is reviewed on an ongoing basis.

Cork City Council has not received any specific funding in the past 5 years to upgrade or introduce disabled parking spaces.

Requests for disabled parking spaces are assessed on an ongoing basis as individual levels of mobility and accompanying needs change. Subject to meeting all necessary criteria for the installation of a disabled parking space, the request is added to the Roads Programme and undertaken subject to resources and funding being available. It should be noted that a disabled parking space is not 'owned' or reserved solely for the use by a specific individual and therefore can be used by any motorist displaying a valid disabled parking permit.

Members will be aware that a number of public housing estates in the City are yet to be taken in charge. The works required to take these estates in charge are currently being costed. The City Council is currently in the process of re-lamping public lights in the Market Garden estate, where required. It is expected that considerable progress will be made in taking the estate in charge in the current year.

6.7 **<u>LIVING CITY INITIATIVE</u>**

In response to the following question submitted by Comhairleoir J. Sheehan, a written reply was circulated as outlined below:-

Can the CE please provide an update on the Living City initiative and its proposed extension to the Blackpool area.

REPLY

To date, the Planning Directorate has processed 14 no. applications for the residential element of the Living City Initiative.

On two occasions, Cork City Council has sought an expansion to the Special Regeneration Areas of the scheme. The first request was in writing in early July 2015. The accompanying map showed part of the Blackpool area as part of the proposed expansion. The Department of Finance replied some months later, post budget 2016, advising that the Minister decided not to change the Special Regeneration Areas of Cork City. In Budget 2017, changes to the Living City Initiative were announced which extended the eligibly of the tax incentive to landlords of properties in Special Regeneration Areas, as well as other changes to the scheme.

Upon this announcement, the City Council wrote to the Minister in mid-December 2016 to welcome the amended scheme and to again request for the same expansion to the Special Regeneration Areas. To date, no response has been received.

6.8 VACANT HOUSING UNITS IN KILBRACK LAWN

In response to the following question submitted by Comhairleoir K. McCarthy, a written reply was circulated as outlined below:-

To ask the CE for an update on the 9 vacant housing units in Kilbrack Lawn, off Skehard Road and plans for their future?; South East Ward Councillors in 2015 had asked for their selling off as affordable housing.

REPLY

Doorway to Life Limited (ABODE) have been granted a lease of nine units (Numbers 3, 4, 8, 16, 20, 22, 23, 29 & 30 Kilbrack Grove) for a five year term in consideration of it providing management services under a Service Level Agreement with Cork City Council. This lease arrangement was approved by the elected members of the City Council. The management of the tenancies (including the collection of rents) will be the responsibility of the Doorway to Life Limited. The properties are now tenanted and these housing allocations have enabled persons from the Social Housing Support waiting list, to be provided with permanent accommodation and have the on–site support of the services of Doorway to Life Limited. ABODE already manage accommodation (main residential building and 3 properties on the estate).

6.9 **LIABILITY FOR THE NON-PRINCIPAL PRIVATE RESIDENCE CHARGE**

To ask the Chief Executive how many properties are liable for the Non-Principal Private Residence charge; How much revenue was generated for the City Council in 2014, 2015, 2016 and projected for 2017 from this charge; What is the number of properties attached to each individual or entity registered for the charge by band e.g 1-5, 6-10, 11-20 etc; Is it known how many of these properties are registered with the RTB, and What is the level of communication and sharing of information between City Council and the RTB?

REPLY

The Local Government (Charges) Act 2009 and associated regulations gave effect to the introduction of a \in 200 charge on non principal private residences (NPPR).

The NPPR charge was effective for the years 2009 to 2013 only.

Part 12 of the Local Government Reform Act 2014 provided for the repeal of the legislation governing the NPPR charge.

As the NPPR was a self declaration tax, Cork City Council does not have details in relation to the number of properties that were liable to the charge

The revenue generated was as follows:

- 2014 €2,059,070
- 2015 €1,377,259
- 2016 €1,175,887
- 2017 € 600,000 estimated

Cork City Council does not know the number of properties attached to each individual or entity registered for the charge by band.

Cork City Council does not know how many properties are registered with the RTB. There has been no communication /sharing of information between Cork City Council and the RTB in relation to NPPR.

RESOLVED THAT "It is hereby resolved pursuant to Section 66(1) (a) of the Local Government Act 2001, that the asset known as the tourism train is to be disposed of to Mr. Pat Flynn and that the consideration to be paid by Mr. Flynn to Cork City Council in respect of the tourism train shall be payable by way of 6 monthly instalments of \in 3,834 over a period of five years following the commencement of trading, with a final cash payment of \in 5,000 to be made at the end of the first 5 years trading together with the execution of a Service Level Agreement between Cork City Council and Mr. Flynn which will accommodate capacity dedicated to Cork City Council for social inclusion and entertainment purposes on a yearly basis, in addition to free advertising spaces on the train for the use by Cork City Council. It is also resolved to make a cash contribution of \in 10,000 to Mr. Pat Flynn towards the cost of insurance of the Cork City Tourism Train in respect of its first year of operation"

9.6.1 PROTOCOLS IN RESPECT OF PUBLIC ENTRY TO THE ENGLISH MARKET

An Chomhairle considered and approved the report of the Director of Services on the following motion referred to the Committee by An Chomhairle:-

'That Cork City Council suspend "the Protocols" which officials agreed in respect of public entry to the English Market as there is widespread concern as to who actually requires these and why and also in line with previous commitments from City Management it is also appropriate the such protocols be reviewed by the elected Council in order to assess if they are in the public interest.'

(Proposer: Cllr. T. Brosnan 17/088)

The report of the Director of Services stated that The English Market is above all else a centre of commerce and trade. It is Ireland's oldest indoor food market and has become

increasingly popular as a visitor attraction in Cork City Centre. As a fresh food market, a heritage building, civic and meeting place, its unique offering and unmistakable atmosphere has made it world famous among customers and visitors alike and as a result is attracting a huge number of tourists.

With greater demand and footfall of tourists and a significant increase in groups visiting The English Market in the last number of years and in response to a survey carried out in 2016 among approximately 1,000 customers and tour groups, the issues of overcrowding and the potential for subsequent Health and Safety issues have become a major concern for everyone.

Following on from consultation between Cork City Council, The English Market Traders Committee and the English Market Management Company it was agreed that it was necessary to put in place a safer and more structured process as to how and when Tours operate within the English Market to ensure comfort for all those who have cause to visit and work in the Market.

The English Market sustains 450 (approximately) valuable city centre jobs and the Protocols, which are attached at Appendix A, carry the support of over 90% of the Traders.

The Applications of these Protocols will ensure a more effective and efficient management process in the English Market and these are attached at Appendix B.

Comhairleoir T. Brosnan proposed and An Chomhairle agreed that a related Report would be submitted to An Chomhairle at six monthly intervals.
