storey apartment block (comprising 20 no. apartments) and a four storey apartment block (comprising 27 no. apartments). 1 no. crèche, provision for the relocation of 2 no. utility buildings (gas and electricity) and all associated ancillary site development works including vehicular access, parking, footpaths, landscaping, drainage and amenity areas all at Bessboro Road, Mahon, Cork."

6. **QUESTION TIME**

6.1 **FIRE SERVICE**

In response to the following question submitted by Comhairleoir K. O'Flynn, a written reply was circulated as outlined below:-

- a) Could the CE please confirm how many times the fire services have been called out to Ellis's Yard to quench fire at the illegal dump there in 2011, 2012, 2013, 2014, 2015, 2016, 2017 & 2018?
- b) How many Garda escorts have been required to gain access? In this time.
- c) How many assaults that have been inflicted upon our fire fighter and support staff have been reported?
- d) How much has been spent on the cleanup of the site since 2008?
- e) How much has it cost to clean up this yard in 2018?
- f) Has the CE consulted with the environmental health services and carried out a risk analysis of carcinogenic chemicals that may have been dumped?
- g) Is CE aware of any dangers to fire services in dealing with such chemicals?
- h) Has there been a chemical and environmental inspection of the site?

REPLY

a) When mobilised to an incident in this area we are usually mobilised to the Spring Lane area. These calls can be either to the Halting Site or Ellis's yard. If you require which site it is in then we would have to examine each fire report for those details. We introduced our new Incident Recording system in 2014 and can provide you with the following data on calls attended in the Spring Lane area.

2018-25

2016-17

2017-40

2018-77 (up to 15/08/2018)

- b) During the period in question no Garda escort were required by the Environment and Recreation Directorate to gain access to the site. We did carry out a number of covert operations and we have also monitored the site from a distance. The Fire Department does not record this information on our incident recording system.
- c) No assaults have been reported.
- d) \in 183,965 has been spent since 2008.
- e) No public funds have been expended to date this year to clean up the yard.
- f) The Environmental and Recreation Directorate has not consulted with the Health services and is not aware of a risk analysis having been carried out.
- g) The fire service has in place a number of control measures to manage the risks of responding to incidents of this type. Standard Operating Guidelines would include Cork City Fire Brigade Incident Command System, safe systems of work, use of breathing apparatus and standard hygiene precautions. Our Brigade also operates hygiene stations on operational appliances, an option to place dirty fire kit in bags thus not bringing potential contamination into the appliance cab, a post incident cab cleaning protocol, a second set of complete fire kit with more available if necessary for all personnel attending an incident.
- h) From surveys carried out by the Environment & Recreation Directorate over the years we have found waste on site including, metal, plastics, tyres, furniture, domestic waste, electrical goods, timber and rubble.

6.2 <u>ST. LUKE'S CHURCH, SUMMERHILL NORTH</u>

REPLY

St. Luke's is currently under the management of Cork City Council. The Council makes it available to groups free of charge for cultural use. It has been used in the last year by a number of groups including the following:

The Good Room – Live at St. Lukes Music Generation Cork City Sample Studios Cork Orchestral Society Midsummer Festival

The Good Room – Live at St. Luke's

The Good Room – Live at St. Luke's have been using the venue since 2015 when the Council's Tourism Office agreed to fund a pilot summer and winter scheme of concerts in St. Luke's. This funding was continued in 2016, but not into 2017.

In 2017 The Good Room approached the Arts Office with a proposal for the management of St. Luke's on a full time basis. This included a large financial cost to the Council, and the Arts Office refused this option, but agreed that they could continue to use the venue for cultural use on the same basis as any other organisation.

The Arts Office indicated that they would consider a request from The Good Room for a pilot proposal to manage the building for an 18 month period, with a view to seeing of it is possible for the building to become a sustainable hub for cultural activity for the area.

The Arts Office is currently awaiting this submission.

Currently, The Good Room – Live at St. Luke's, do not have an agreement to use St. Luke's outside of the usual processes that other groups also comply with.

6.5 **PARK AND RIDE SERVICE**

To the Chief Executive, what existing proposals are available for a Park and Ride service for the Northside and if there are no proposals to begin the feasibility of such a service for the people of the Northside integrated to the City Centre Movement Strategy?

REPLY

The City Centre Movement Strategy is focused on the movement of traffic and reallocation of road space within the city centre area and the project does not cover the provision of Park and Rides.

The Cork Metropolitan Area Transport Strategy is currently being prepared by the National Transport Authority and once draft document is completed, a public consultation process will be undertaken. This Strategy will provide for a number of Park and Ride facilities to be provided once supporting public transport infrastructure is in place.

6.6 BARRACK STREET UG DUCTING PROJECT

In response to the following question submitted by Comhairleoir S. Martin, a written reply was circulated as outlined below:-

What action was taken by Cork City Council to correct the shortcomings of the above project:

- a) Ducts not following ESBN maps?
- b) Depth of cable ducts not to standard?
- c) Separation of ESB ducts from other ducts not to standard?
- d) Warning tape not installed at 300 m below ground?
- e) ESB heavy duty warning strips not present anywhere on site?
- f) Ducts not encased in concrete where required?
- g) ESBN earth not laid to standard?
- h) Bale filling not to standard?
- i) No mechanical protection around ducts where separation is not achieved?

REPLY

The undergrounding of ESB network cables on Barrack Street was very difficult due to the confined nature of the site and the multiple layers of existing utility networks. A final close-out meeting between representatives of the City Council and ESB is scheduled for the last week in September. It is expected that all outstanding areas of concern including some of the items listed above will be addressed to the satisfaction of both parties and the remaining overhead network cables will be removed thereafter.

6.7 TRAFFIC LIGHTS ON TOGHER ROAD

In response to the following question submitted by Comhairleoir F. Dennehy, a written reply was circulated as outlined below:-

Cork City Council some time ago adjusted the lights sequence at the traffic lights on Togher Road to allow additional time for motorists turning right off of the Clashduv Road and onto Togher Road. Has this sequence change been reversed and it is possible to put in place a permanent filter light at this location?

REPLY

The traffic signal controller will be inspected with a view to checking the detection equipment on approaches and settings as adjustments or modifications to the operation have not been undertaken at Clashduv Road – Togher Road.

In the interim it is to be noted that this location is being assessed repeatedly and a detailed design of the junction layout and upgrade to the traffic signals is being undertaken by the Roads Directorate with a view to issuing tenders for a works programme. It is only in the context of the proposed upgrade of the junction that significant changes to the phasing and right-turn filters can be implemented. A revised junction layout with the necessary dedicated lane assignments will facilitate the type of improvements proposed.

REPLY

Please see attached a list of properties on the Derelict Sites Register. There are a number of properties outstanding to be placed on the Register. Notices have been served on the owners and time remains for submissions to be made by the owners to the Notice issued. It is hoped approximately 5 more sites could be placed on the register by year end, pending the legal process and potential representations made by property owners. 19 sites have been placed on the Derelict Sites Register in 2018 to date and 3 have been removed. The total on the Derelict Sites Register is 91.

You will also see attached a copy of the sites on the Vacant Sites Register. The process of placing sites on the Vacant Sites Register allows for a number of appeals, this adds to the length of time involved before placement of a property on the Vacant Sites Register. The legislation does not set a time scale for valuations to be completed but it does allow for review every 3 years. We hope to have a number of properties valued over the coming months, these valuations will be added to the Vacant Sites Registers and land owners have the option to appeal same. We are currently working on a number of sites for inclusion onto the Register.

'That Cork City Council would commence a series of public workshops, meetings and public consultation for the new areas due to join under the extension to the city boundary to explore and understand local issues and how best to deliver public services in those areas.'

(Proposer: Cllr. J. Buttimer 18/213)

The Report of the Director of Services stated that in the first instance it is important to note that the services that will be provided to the new communities and businesses in the transition area by Cork City Council in the time period immediately after the transition date will be equivalent to the present service delivered in the area by the County Council at present. The resources available to the City Council will only equal those which are presently available to the County. As such the delivery mechanisms and in particular the level of service will not change. Over time, as the City develops towards our Ireland 2040 goals, additional resources will become available which will allow the City Council to review and improve service levels in the transition area.

The Local Government Bill 2018 was published on the 28th of July. It is anticipated that this Bill will be prioritised for adoption once the Dáil resumes from its summer recess on the 18th of September. Until this Bill is enacted the ability of Cork City Council to fully engage with communities and businesses in the new expanded City area is somewhat curtailed.

In preparation for the enactment of the Bill, the City Council have been engaging on a Directorate by Directorate level with the County Council over the past two months. This exercise involves the exchange of information and data pertaining to the level of service presently offered, the existing resources utilised in the area and details of the assets/infrastructure within the expansion area. This process is ongoing and it is expected to complete during October.

The City Council's Transition team is putting together a Communications Plan which will be rolled out once the legislation is in place and the data has been gathered from the County. This plan will include information prominently positioned on the new City Council website, the use of Facebook and Twitter, public information dissemination regarding the boundary extension and organisational reorganisation in the media, continued liaison with Councillors regarding the change process, communications with staff and their representative bodies in both Local Authorities, meetings and business and community representative organisations, a newsletter/mail drop to all households in the newly extended area as well as "Town Hall" Meetings held in the new communities.

Housing Ireland Society Limited for the acquisition of 50 no. units of accommodation at Milestream, Shanakiel, Cork subject to the terms of the Capital Advance Leasing Facility Scheme."

11.12 <u>DEVELOPMENT AT SHANDON STREET/JOHN PHILPOTT CURRAN STREET/CATHEDRAL AVENUE, CORK</u>

An Chomhairle considered and approved the Report of the Director of Services, Housing & Community Services dated 13th September, 2018 as required under Section 179 of the Planning and Development Act, 2000 as amended in relation to development at No.'s 5 & 6 Shandon Street and John Philpott Curran Street, Blackpool, Cork.

11.13 EMERGENCY HOUSING MAINTENANCE REQUESTS

An Chomhairle considered and approved the Report of the Director of Services, Housing & Community Services dated 13th September, 2018 on the following Motion referred to the Committee by An Chomhairle:-

'That Cork City Council have a contractor on standby to fix emergency housing maintenance requests (as well as, *urgent* or *routine housing maintenance* requests like replacing a cracked leaking roof tile, leaks, etc. as depot staff are already overloaded with the volume of housing maintenance requested. Funding also needs to be in place to sign off on these jobs very quickly.'

(Proposer: Cllr. T. Moloney 18/162)

The Report stated that the Council has resources and staff available to cater for emergency repairs on its built housing assets; this comprises a direct labour team and panels of term maintenance service providers. These panels are currently being added to by a further panel for 'Roofline Term Maintenance and Repair'. Funding is allocated annually for these necessary works by the Council.

12. <u>ROADS & TRANSPORTATION FUNCTIONAL COMMITTEE - 17th SEPTEMBER 2018</u>

An Chomhairle considered and noted the minutes of the Roads and Transportation Functional Committee from its meeting held 17th September 2018.

12.1 **ROADWORKS PROGRAMME**

An Chomhairle considered and approved the Report of the Director of Services, dated 13th September 2018 on the progress of the ongoing Roadworks Programme for the month ending July 2018.

12.2 HANOVER PLACE SECTION 38

On the proposal of Comhairleoir K. McCarthy, seconded by Comhairleoir C. O'Leary, An Chomhairle considered and approved the Report of the Director of Services, dated 13th September 2018 regarding Hanover Place Section 38.

12.3 <u>EXTINGUISHMENT OF PUBLIC RIGHT OF WAY AT THE LANEWAY FROM</u> MEELICK PARK TO CHAPEL GATE, BALLYVOLANE, CORK

An Chomhairle considered and approved the Report of the Director of Services dated 13th September 2018 regarding the proposed Extinguishment of the public right of way at the laneway from Meelick Park to Chapel Gate, Ballyvolane, Cork.

On the proposal of Comhairleoir M. Shields, seconded by Comhairleoir D. Cahill, An Chomhairle further agreed to adopt the following Resolution:-

"Now Council hereby RESOLVES THAT

One written submission having been received and considered within the prescribed statutory period setout in section 73 (1) (a) of the Roads Act 1993, it is now hereby Ordered that the Public Right of Way which runs from Meelick Park for a distance of approximately 130 metres in a westerly direction to the entrance gate to Leeds United bordering Chapel Gate, Ballyvolane, Cork, be extinguished forthwith."

12.4 <u>INCENTIVISED PARKING 2018</u>

An Chomhairle considered and approved the Report of the Director of Services, dated the 13th September 2018, on Incentivised Park 2018.

12.5 SURVEY BEAUFORT PARK AND ST. ANNE'S PARK

An Chomhairle considered and approved the Report of the Director of Services, dated the 13th September 2018, on the following Motion referred to the Committee by An Chomhairle:-

'That Cork City Council would survey Beaufort Park and St. Anne's Park with a view to reinstatement and resurfacing, Damage has been caused to these estates because of heavy vehicular traffic associated with redevelopment of Cork City F.C.'

(Proposer: Cllr. S. Martin 18/069)

The Report of the Director of Services stated that this area had been assessed but was not included in the 2018 road resurfacing programme. Extensive work is required and the area will be considered again for the 2019 road resurfacing programme.

12.6 **PUBLIC LIGHTING IN ROSELAWN, TOGHER ROAD**

An Chomhairle considered and approved the Report of the Director of Services, dated the 13th September 2018 on the following Motion referred to the Committee by An Chomhairle:-

'That additional public lighting be installed in Roselawn, Togher Road.'

(Proposer: Cllr. S. Martin 18/129)

The Report of the Director of Services stated that there are 4 public lights installed at Roselawn, Togher Road. DeadSure indicates that all lights are operational at the present time.

The location has been listed for a site inspection.

12.7 <u>REDUCE SIZE OF T JUNCTION BETWEEN KNOCKPOGUE AVENUE AND FAIRFIELD ROAD</u>

An Chomhairle considered and approved the Report of the Director of Services, dated the 13th September 2018 on the following Motion referred to the Committee by An Chomhairle:-

'That Cork City Council reduces the size of the T junction between Knockpogue Avenue and Fairfield Road as traffic calming measures.'

(Proposer: Cllr. K. Collins 18/185)

The Report of the Director of Services stated that the T junction between Knockpogue Avenue and Fairfield Road will be assessed to determine the extent of the problems that exist in order to identify any possible mitigation measures that can be provided there. Any identified solutions will be put forward for consideration to be included in the Roads Programme, in accordance with the available budgetary allocation.

12.8 **RESURFACE HOLLYMOUNT ESTATE**

An Chomhairle considered and approved the Report of the Director of Services, dated the 13th September 2018 on the following Motion referred to the Committee by An Chomhairle:-

'That Cork City Council will resurface Hollymount Estate and install traffic calming measures.'

(Proposer: Cllr. K. Collins 18/187)

The Report of the Director of Services stated that Hollymount Estate had been assessed but was not included in the 2018 road resurfacing programme. The area will be considered again for the 2019 road resurfacing programme.

Hollymount Estate will be added to the list of areas where a request for traffic calming has been received. The area will be assessed to determine the extent of the problems that exist

in order to identify any possible mitigation measures that can be provided there. Any identified traffic calming solutions will be put forward for consideration by Ward Members in accordance with the available budgetary allocation.

12.9 TRAFFIC CALMING MEASURES IN MCSWEENEYS VILLAS

An Chomhairle considered and approved the Report of the Director of Services, dated the 13th September 2018 on the following Motion referred to the Committee by An Chomhairle:-

'That traffic calming measures should be installed in McSweeneys Villas as a matter of urgency.'

(Proposer: Cllr. K. O'Flynn 18/196)

The Report of the Director of Services stated that McSweeneys Villas will be added to the list of areas where a request for traffic calming has been received. The area will be assessed to determine the extent of the problems that exist in order to identify any possible mitigation measures that can be provided there. Any identified traffic calming solutions will be put forward to Members at Ward level for consideration by Ward Members in accordance with the available budgetary allocation.

12.10 **RESURFACE FOOTPATH ON LOWER KENT ROAD**

An Chomhairle considered and approved the Report of the Director of Services dated 13th September 2018 on the following Motion referred to the Committee by An Chomhairle:-

'That the footpaths at the eastern side of Lower Kent Road be resurfaced as they are in very poor condition.'

(Proposer: Cllr. T. O'Driscoll 18/197)

The Report of the Director of Services stated that the footpaths at this location will be inspected and assessed to determine the extents of works required.

12.11 PREVENT PARKING ON BOTH SIDES OF ROAD IN ARBHAILE ESTATE, MAYFIELD

An Chomhairle considered and approved the Report of the Director of Services dated the 13th September 2018 on the following Motion referred to the Committee by An Chomhairle:-

'That measures will be taken to prevent parking on both sides of the road at Ardbhaile Estate, Mayfield following a recent incident in which an ambulance was unable to enter part of the estate due to badly parked cars, and a seriously ill person had to be stretchered from their home to the ambulance parked some distance away. Safety measures are required to control parking within the estate including a significant number of non-residents who are parking cars there and taking the bus into the city centre. Other measures required include the installation of speed ramps to slow down traffic in the estate, noting that a special needs school will be moving into the estate later this year.'

(Proposer: Cllr. T. Tynan 18/200)

The Report of the Director of Services stated that Cork City Council assessed Ardbhaile Estate as a result of a request from residents within the area to combat illegal parking.

The Transportation Depot renewed existing double yellow lines in Ardbhaile Estate on 4th July 2018 in response to that request. A further request was received by the Transportation Depot from residents in the area for additional double yellow lines to be installed namely outside the perimeter of No. 2 Ardbhaile on approach to the school entrance. This will be completed as soon as resources are available.

If any further lining is required at Ardbhaile Estate, Mayfield, it will be added to the Roads Painting programme and undertaken subject to suitable weather conditions, funding and resources being available.

12.12 MAINTENANCE AND UPKEEP OF THE BANDON ROAD ROUNDABOUT

An Chomhairle considered and approved the Report of Director of Services dated the 13th September 2018 on the following Motion referred to the Committee by An Chomhairle:-

'That Cork City Council would outline the parameters of the contract for the maintenance and upkeep of the Bandon Road Roundabout and approach roads to same and when the works will be undertaken and that Roads would meet with local residents who have serious concerns about the ongoing upkeep of the public realm.'

(Proposer: Cllr. J. Buttimer 18/205)

The Report of the Director of Services stated that TII's maintenance contractor (Egis Lagan) is now fully responsible for the maintenance of the entire N40 excluding some remediation areas at Sarsfield Road roundabout. The remediation areas will be included in the maintenance contact later this year following completion of work by SIAC construction Ltd. The maintenance contractor is responsible for the following items of work:

- Routine & ongoing maintenance including barrier strikes, potholes, lighting, landscape maintenance, litter collection, drainage etc.
- Winter maintenance
- Emergency and incident response
- Asset inventory
- Data collection & management
- Works programme development
- Pavement rehabilitation work
- Routine maintenance and rehabilitation of structures

There are different response intervals and trigger points for each activity, for example: grass is to be cut when it reaches 150mm in height. Typically full litter collections takes place every February with follow up collections every 13 weeks or sooner depending on the needs of the particular site.

12.13 MULTI-STOREY PARKING PACKAGE

An Chomhairle considered and approved the Report of the Director of Services dated 13th September 2018 on the following Motion referred to the Committee by An Chomhairle:-

'That Cork City Council immediately invite other car park owners into discussion with a view to presenting a vibrant multi-storey parking package compatible with enticing people back into the city centre.'

(Proposer: Cllr. S. Martin 18/154)

The Report of the Director of Services stated that this request can be considered through the Core Strategy group as part of the overall marketing strategy for the city centre. However, private car park operators do currently offer incentives for parking in Cork City Centre which falls under their overall corporate offering e.g. Q park.

12.14 **FOOTPATHS ON VICARS ROAD**

An Chomhairle considered and approved the report of the Director of Services dated 13th September 2018 on the following Motion referred to the Committee by An Chomhairle:-

'That City Council would inspect the footpaths on Vicars Road particularly near its own depot and outside houses 1 to 13 plus at the Junction with Togher Rd. (Lough side).'

(Proposer: Cllr. H. Cremin 18/192)

The Report of the Director of Services stated that extensive footpath works have been completed along Vicars Road and Vicars Court by Road Maintenance in July/August. The area around the Togher Road Junction will be assessed for future works.

12.15 SULKY RACING THROUGH THE CITY

An Chomhairle considered and approved the Report of the Director of Services dated 13th September 2018 on the following Motion referred to the Committee by An Chomhairle:-

'That Cork City Council introduce Bye-Laws to combat sulky racing through the city.'

(Proposer: Cllr. K. O'Flynn 18/222)

The Report of the Director of Services stated that this is a matter requiring national legislation and therefore will be forwarded to the Department of Transport, Tourism and Sport for their attention.

12.16 PUBLIC LIGHTS ON AISLEIGH GARDENS TO SKEHARD ROAD

An Chomhairle considered and approved the Report of the Director of Services dated 13th September 2018 on the following Motion referred to the Committee by An Chomhairle:-

'That the City Council work with Airtricity so that the two public lights on a laneway from Aisleigh Gardens to Skehard Road be fixed.'

(Proposer: Cllr. K. McCarthy 18/228)

The Report of the Director of Services stated that since the Motion was submitted fault Nr 9928 PL1 Aisleigh Gardens to Skehard Road has been rectified and is operational. An update on Fault Nr 9929 PL2 at the same location has been requested from SSE Airtricity.

12.17 ANTI SOCIAL BEHAVIOUR ON ROCKBORO ROAD

An Chomhairle considered and approved the Report of the Director of Services dated 13th September 2018 on the following Motion referred to the Committee by An Chomhairle:-

'That Cork City Council along with other responsible agencies take all necessary steps to alleviate and resolve the ongoing anti social behaviour, which includes drinking in public, drug distribution and drug taking on Rockboro Road. One of the measures that must be considered is the closure of the pedestrian bridge from Rockboro Road over to Anglesea Street.'

(Proposer: Cllr. T. Shannon 18/098)

The Report of the Director of Services stated that the proposed measure to close the pedestrian bridge from Rockboro Road to Anglesea Street will be added to the agenda for the next South East & South Central Ward Meetings. Anti social issues are a matter for An Garda Síochána.

12.18 HERITAGE PIECES UNDER CORK CITY COUNCIL CONTROL

An Chomhairle considered and approved the Report of the Director of Services dated 13th September 2018 on the following Motion referred to the Committee by An Chomhairle:-

'That Cork City Council would present Councillors with a written report on heritage pieces under control of the City Council. Per my Motion 13/380 which called for an annual audit of such pieces I have only heard reports of such pieces "going missing", cast aside in Kinsale Road and Mahon Dept (Limestone), cast aside in Fitzgerald's Park (Fireman's Hut and Horse Trough). It is certain that much other valuable heritage of the City has come to be neglected and shamefully cast aside. A group of interested Councillors must visit these sites asap.'

(Proposer: Cllr. T. Brosnan 18/189)

The Report of the Director of Services stated that this Motion has been referred to Strategic Planning, Economic Development & Enterprise Strategic Policy Committee.

12.19 INSPECT DANGEROUS BEND AT ROSSBROOK, MODEL FARM ROAD

An Chomhairle considered and approved the Report of the Director of Services dated 13th September 2018 on the following Motion referred to the Committee by An Chomhairle:-

'That City Council would inspect the very dangerous bend at Rossbrook Model Farm Road. With the new development nearby, this road has been widened and there's an urgent need to erect proper signage at this bad bend to inform drivers of the severity of it, as there are always people standing close by at the new bus stop.'

(Proposer: Cllr. H. Cremin 18/170)

The Report of the Director of Services stated that the area in the vicinity of Rossbrook, Model Farm Road can be assessed to determine the extent of the problems that exist in order to identify any possible mitigation measures that could be provided there.

If deemed appropriate, the measures will be put forward for consideration to be included in the Roads Programme and will be undertaken, subject to funding being available.

12.20 BOLARDS NEAR E.S.B. SUBSTATION AT WOODHAVEN, BISHOPSTOWN

An Chomhairle considered and approved the Report of the Director of Services dated 13th September 2018 on the following Motion referred to the Committee by An Chomhairle:-

'That City Council/County Council or the N.R.A. would erect bollards near the E.S.B. substation at Woodhaven Bishopstown to prevent this beautiful walkway being used by vehicular traffic as has happened recently which resulted in a burnt out car blocking the walkway for a week.'

(Proposer: Cllr. H. Cremin 18/191)

The Report of the Director of Services stated that Woodhaven is outside the City boundary.

12.21 SUSPENSION OF PATRICK STREET ROAD CLOSURE

An Chomhairle considered and approved the Report of the Director of Services dated 13th September 2018 on the following Motion referred to the Committee by An Chomhairle:-

'That Cork City Council extend the suspension of the Patrick Street road closure till 31st January, until full report is brought before Council including insight from; the Hotel Federation, Restaurant Association, Chamber of Commerce Cork, Cork Business Association, Bus Drivers Union, Cork Taxi Council, Cork City & County Business Federation and all other city trading groups.'

(Proposer: Cllr. K. O'Flynn)

The Report of the Director of Services stated that as agreed by Council, the bus priority measures were introduced on St. Patrick St on 9th August 2018. This was preceded by extensive consultation and undertaken in parallel with a range of supporting measures. Meetings will continue to be held and updates on the bus priority measures given to all Elected Members and the Core group.

12.22 **DOUBLE YELLOW LINES AT RINGMAHON ROAD**

An Chomhairle considered and approved the Report of the Director of Services dated 13th September 2018 on the following Motion referred to the Committee by An Chomhairle:-

'That Cork City Council paints double yellow lines along the Ringmahon Road, to the junction of Skehard Road to alleviate parking issues experienced during sports matches, in particular at the entrance to Ringcroft Avenue.'

(Proposer: Cllr. N. O'Keeffe 18/218)

The Report of the Director of Services stated that Cork City Council will assess the road painting request along the Ringmahon Road, to the junction of Skehard Road, in particular at the entrance to Ringcroft Avenue. If deemed appropriate it will be inputted into the road painting programme and will be undertaken subject to suitable weather conditions and funding being available.

In addition the Traffic Warden Service will be requested to pay additional attention to Ringmahon Road in order to deter any illegal parking incidents.

12.23 TRAFFIC LIGHTS ON UPPER FAIRHILL

An Chomhairle considered and approved the Report of the Director of Services dated 13th September 2018 on the following Motion referred to the Committee by An Chomhairle:-

'That Cork City Council will ensure that traffic lights on Upper Fairhill are in working order.'

(Proposer: Cllr. M. Nugent 18/219)

The Report of the Director of Services stated that the traffic signal installation at this location has been listed for inspection with a view to ratification of any faults or malfunction.

12.24 ERECTION OF SIGNS AT CASTLE CRESCENT AND RINGCROFT AVENUE

An Chomhairle considered and approved the Report of the Director of Services dated 13th September 2018 on the following Motion referred to the Committee by An Chomhairle:-

'That Cork City Council erect estate signs for

- 1. 'Castle Crescent' outside Castle Close on Ferney Road, Mahon. Castle Crescent was built behind the original estate (Castle Close) and the park is not directly visible from the road.
- 2. Ringcroft Avenue on Ringmahon Road. Both these estates do not have signage and this can cause confusion for emergency service personnel & other looking for the estate. Can the directorate outline the costs involved in the provision of these signs and the expected timeframe on their delivery.'

(Proposer: Cllr. N. O'Keeffe 18/220)

The Report of the Director of Services stated that Cork City Council has a small annual allocation to fund the erection of road and street nameplace signs within the city administrative area. This fund covers the costs for replacing old, damaged or stolen signs as well as the erection of new signs.

The appropriateness of signage for both Castle Crescent and Ringcroft Avenue will be assessed. If deemed suitable, it will be added to the list of requests for nameplates to be provided, subject to funding being available.

20.4 HOUSING CRISIS IN 2019 BUDGET

'Cork City Council notes that:

- Access to secure and affordable housing is increasingly out of reach for many people.
- From the locked out generation of students and young workers or unemployed people to older workers facing into retirement, high cost insecure accommodation is a reality for too many people.
- The failure of government to provide an adequate supply of good quality public housing in sustainable communities lies at the heart of the housing crisis.
- The most graphic symptom of this crisis is the growing number of children living in emergency accommodation.
- A new approach to housing is required to meet the housing needs of all those locked out of the private market including young people, those on modest incomes, those on low pensions, those on Council waiting lists, travellers, people with disabilities, older people and students.
- Important proposals to address the Housing crisis have been put forward by a wide variety of groups including the National Housing and Homeless Coalition and the Irish Congress of Trade Unions.

Cork City Council therefore calls on the current government, ahead of Budget 2019, to:

- Declare the housing and homeless crisis an emergency.
- Dramatically increase the supply of public, affordable housing, including publicly-provided cost rental housing by increasing capital spending on housing to at least €2.3bn in budget 2019.
- Build public housing on public land; and aggressively target the return of vacant houses to active use.
- Reduce the flow of adults and children into homelessness with emergency legislation to make it illegal to evict anybody into homelessness.
- Hold a referendum to enshrine the right to public housing in the Constitution.'
