## 5. EU BUDGET TO SUPPORT SOCIAL ECONOMY 2021-2027

EU budget to support and unlock investment in the social economy and social innovation during 2021-2027

During 2014-2020, the EU budget mobilised directly at least EUR 2.3 billion for the social economy and other related topics (e.g. microfinance, social innovation, inclusive entrepreneurship). Thanks to the multiplier effect of the financial instruments for microfinance and social enterprise, at least EUR 7.9 billion were mobilised from EU, national and private resources<sup>108</sup>.

Cohesion policy funds can be used to promote the social economy, including through support to social entrepreneurship, social innovation, education and training, experimentation and innovation in SMEs. Several Cohesion policy programmes support business development and promotion of cooperation for the social economy. For example:

- The European Social Fund Plus (ESF+), which allocates a budget of EUR 99.3 billion, will remain an important funding source for promoting the social economy and social innovation. Social economy organisations will be well placed to benefit from ESF+ support, because their activities can help to achieve the ESF+ specific objectives, notably the objective of enhancing the inclusiveness of labour markets and access to quality employment. National and regional authorities can use grants as well as financial instruments to build social economy ecosystems.
- At the EU level, the Commission can support transnational cooperation specifically with a view to accelerating the scaling up of social innovation.
- The European Regional Development Fund (ERDF) can provide support for the development and upscaling of social enterprises through developing new business models and innovative solutions to address societal challenges. The support can take the shape of business advice and guidance (business planning, coaching and mentoring, support with marketing), start-up centres and incubators, innovation activities to develop new products, services or ways of working, awareness raising, workshops, awards. In addition, ERDF-funded financial instruments can be used to provide risk capital to start-ups. Finally, ERDF makes available tools and measures to help mutual learning between different countries and regions in Europe.
- Specifically for the culture and tourism sectors, which suffered disproportionately from the COVID pandemic, the ERDF can support funding towards strengthening these sectors' capacity to drive economic development, social inclusion and social innovation, given the role that these sectors play in addressing socio-economic challenges at the local, regional, national and cross-border level.
- The new European Urban Initiative will provide space and resources for EU-wide urban experimentation to test suitability, feasibility and acceptance of social change and will support cities that can demonstrate their potential for social innovation and transformation.

<sup>108</sup> These estimates reflect only the dedicated support to social economy and other related topics. However the social economy also benefited from other broad EU measures (e.g. targeting SMEs or innovation) which are not reflected in these amounts.

# Regional Development (ERDF)

- The **European Regional Development Fund (ERDF)** can provide support for the development and upscaling of social enterprises through developing new business models and innovative solutions to address societal challenges.
- Through **Regional Operational Programmes** the support can take the shape of:
  - business advice and guidance (business planning, coaching and mentoring, support with marketing);
  - start-up centres and incubators;
  - innovation activities to develop new products, services or ways of working;
  - awareness raising, workshops, awards.
- In addition, ERDF-funded financial instruments can be used to provide risk capital to start-ups.

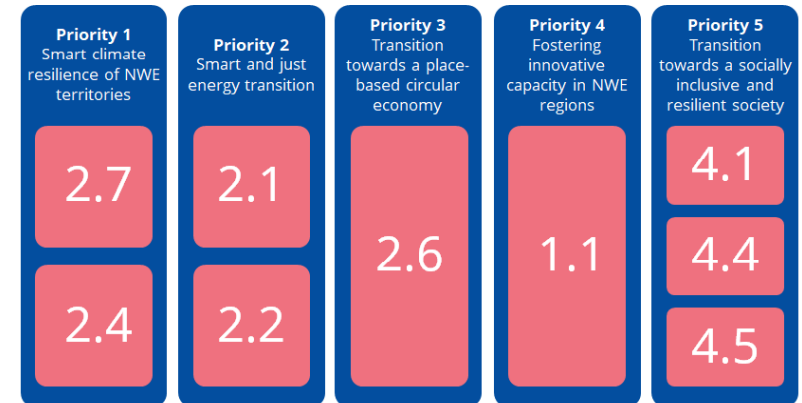

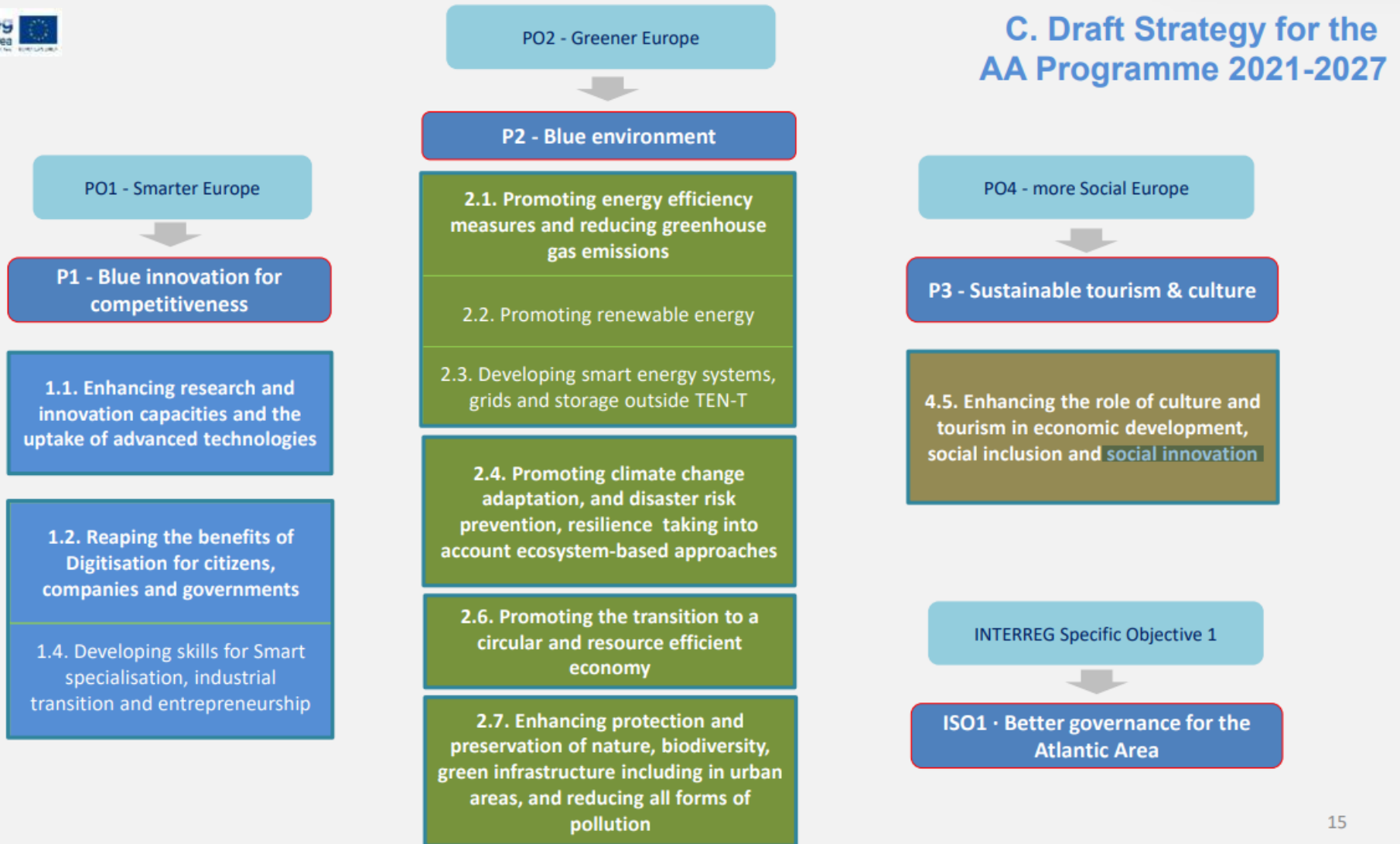

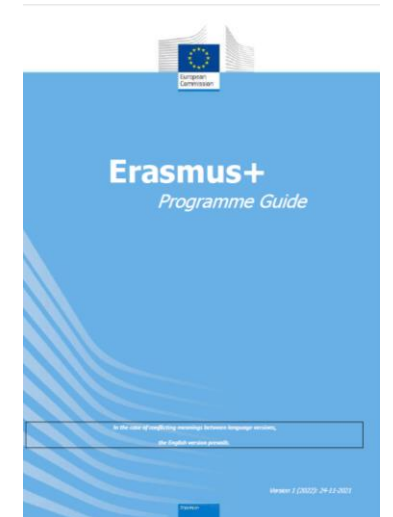

<p><b>Social enterprise</b></p>	<p>An undertaking, irrespective of its legal form, which is not listed on a regulated market within the meaning of point (14) of Article 4(1) of Directive 2004/39/EC, and which: 1) in accordance with its articles of association, statutes or any other statutory document establishing the business, has as its primary objective the achievement of measurable, positive social impacts rather than generating profit for its owners, members and stakeholders, where the undertaking: a) provides innovative services or goods which generate a social return and/or b) employs an innovative method of production of goods or services and that method of production embodies its social objective; 2) reinvests its profits first and foremost to achieve its primary objective and has in place predefined procedures and rules for any circumstances in which profits are distributed to shareholders and owners, in order to ensure that any distribution of profits does not undermine the primary objective; 3) is managed in an entrepreneurial, accountable and transparent way, in particular by involving workers, customers and/or stakeholders affected by its business activities.</p>

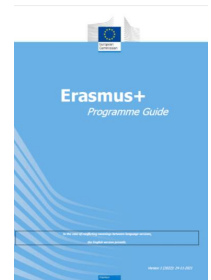

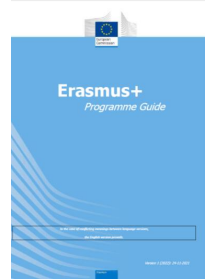

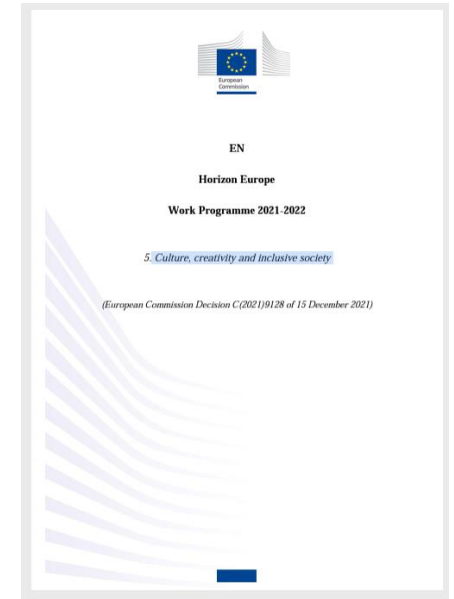

#### Priorities

**The Internal Market:** The SMP aims to ensure that citizens and businesses enjoy the benefits of the internal market and through a range of tools ensure they are aware and can exercise rights and take advantage of opportunities in full. Through the Internal Market strand, the SMP will implement and enforce rules and develop them further in order to ensure financial services meet the needs of consumers, civil society and end-users and enhance tools and expertise of the Commission to enforce effectively competition rules in the digital economy.

**Effective standards:** The SMP will provide financial support to organisations that develop European wide standards to ensure that products and services meet an agreed level of quality and safety.

**Competitiveness (particularly of SMEs):** The SME Strand of the SMP will provide various forms of support to businesses in particular SMEs in order to foster a favourable business environment and entrepreneurial culture, facilitate access to markets, reduce administrative burden, support uptake of innovation and address global and societal challenges.

**Protect consumers:** The SMP helps make sure products on the market are safe and consumers know the rules, and helps national authorities to work efficiently together and communicate swiftly.

**Food Safety:** Through the Food Strand, the SMP will prevent, control and eradicate animal diseases and plant pests, support sustainable food production and consumption, and the improvement of animal welfare, and improve the effectiveness, efficiency and reliability of official controls.

**European statistics:** The SMP will provide funding to national statistics institutes for the production and dissemination of high-quality statistics to monitor the economic, social, environmental and territorial situation, thereby providing for evidence-based decision making in the EU and measuring the impact of EU initiatives.

# Citizens, Equality, Rights & Values Programme (CERV)

- Brings together the Rights, Equality and Citizenship Programme and the Europe for Citizens Programme.

# Asylum, Migration & Integration Fund

Aims to boost national capacities and improve procedures for migration management, as well as to enhance solidarity and responsibility sharing between Member States.

Four objectives, including to support **legal migration**, including by contributing to the integration of third-country nationals.

Funded actions may include:

- providing **support and services** consistent with the status and the needs of the person concerned, in particular vulnerable groups
- **supporting integration measures** - including preparation to access the labour market - tailored to the needs of third-country nationals and early integration programmes focusing on education, language and other training (such as civic orientation courses and professional guidance) to prepare their active participation in and their acceptance by the receiving society
- supporting **infrastructures for the reception** of third country nationals.

Involvement of local and regional authorities as well as civil society organisations, including refugee organisations and migrant-led organisations, and social partners, is explicitly supported as per the “partnership principle” under the Member States’ national programmes, where most funding is available.

Transnational projects where a string focus is usually put on cooperation with local authorities, NGOs and migrant-led organisation can be financed under the thematic facility.

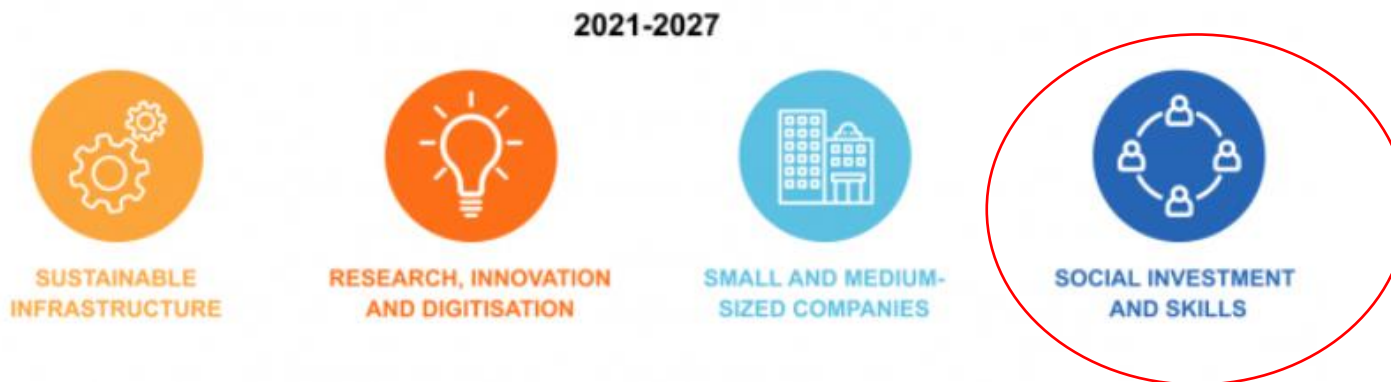
