#### 1. WALK AND PLAY AREAS IN THE UPPER MAYFIELD AREA

'That Cork City Council takes immediate action to create dedicated walk and play areas in the Upper Mayfield area, specifically in Silverheights, Ashmount, Dúnard, and Lotamore.

These neighbourhoods are densely populated and currently lack suitable outdoor spaces for residents, particularly children, to enjoy recreational activities and engage in physical exercise. Be it further resolved that the Council, upon receiving a positive assessment of the need for traffic lights, commits to actively engaging and coordinating with the responsible agencies, departments, and stakeholders to secure the necessary funding, permissions, and implementation of the traffic lights project;

Be it further resolved that the Council will prioritize and expedite the installation process to ensure the safety and well-being of the community members who regularly traverse these roads.

I kindly request all Council members to support this motion, recognizing the importance of addressing the increased traffic and potential dangers posed by the ongoing construction projects.
