### 3. **QUESTION TIME**

### 3.1 TRAFFIC LIGHTS OUTSIDE THE GLEN ROVERS FOOTBALL CLUB

In response to the following question submitted by Comhairleoir K. O'Flynn, a written reply was circulated as outlined below:-

Could the CEO please inform the Council of when the Traffic Lights outside the Glen Rovers Football Club were:

- a) Erected
- b) The Cost
- c) What year does the Manager envisage that they would be switched on?

Also could the CE please advise the Council of when the traffic lights were erected at Wellington Bridge?

Along with the cost to City Council and the plans of when they'll be switched on?

### REPLY

The controlled Pedestrian Crossing facility was installed on Ballincollie Road, outside the Glen Rovers Football Club in Blackpool in 2009. The approximate cost was €18,000. The controller operated satisfactorily for a number of years before becoming the subject of repeated vandalism leading to the removal of controller equipment. The installation will be re-examined by the repair crew and consideration given to how best to address the facility into the future.

Preliminary work was undertaken at the Thomas Davis Bridge (Wellington Bridge) - Sunday's Well Road junction some years ago. However, this was not progressed to completion due to concerns raised in relation to the adverse impact for parking on the approaches to the junction. A new proposed scheme for Thomas Davis Bridge-Sunday's Well Road junction has been drafted and submitted to the National Transport Authority (NTA) for consideration and possible grant- funding.

### REPLY

As per the current fabric upgrade plan circulated to Councillors at the last council meeting it is intended to commence fabric upgrade work in Desmond Square, Greenmount during

the last week of March 2015. This work involves the installation of attic and cavity wall insulation into each social house where appropriate. The work is carried out in accordance with *S.R.* 54:2014 Code of Practice: Methodology for the energy efficient retrofit of existing dwellings.

The Council was led to believe that the €1.6m the Council obtained by the County Board in lieu of the lands sold by the Council to the County Board for the redevelopment of Páirc Uí Chaoimh.

#### REPLY

The Part 8 Report for Area A Marina Park was scheduled for consideration by the Environment and Recreation Functional Committee on 29<sup>th</sup> September, 2014.

An Bord Pleanála advised the Council in the week prior to this Committee meeting that they had received a representation on the Part 8 process requesting them to review whether an Environmental Impact Statement was required for this development and, advised the Council to defer the report to Committee until this representation was determined by them. An Bord Pleanála advised on 22<sup>nd</sup> December, 2014 that they had reviewed the

representation and determined that an Environmental Impact Statement was not required for this development.

The Part 8 Report will now be submitted to the Environmental and Recreational Committee on Monday 16<sup>th</sup>, February for consideration.

On completion of the Part 8 process, initial works will be phased in order of priority in line with available resources. It is intended to undertake low cost elements of the plan as part of the Gateway Project Programme. The estimated cost of phase 1 (areaA) is of the order of 3.5 M Euro

Proposed works will form part of the overall capital budget of Council. Funding for the park development will be sourced in different ways including Development Contributions , sale of land including from Cork County |Board>, Government grants etc

### 3.6 MAINTENANCE OF BROKEN FOOTPATHS & ROADS

In response to the following question submitted by Comhairleoir T. Moloney, a written reply was circulated as outlined below:-

Leading on from the answer received that CCC have spent close to €3 million on personal injury claims in each of the last 3 years, and my supplementary question "How much is being spent on the maintenance of broken footpaths & roads"? Can the CE tell me?

- 1. What fund pays for this personal Injury Claims?
- 2. How many are settled out of court?
- 3. How much is being spent on the maintenance of broken footpaths & roads routine maintenance?
  - a. What is the breakdown of those costs?
  - b. How much of that comes out of CCC's own fund?
- 4. What would Dublin City Council spend per capita?
  - a. What does Cork City Council spend per capita?

I understand that we will never come to a place that all personal injury claims against CCC will be irradiated but does the CE not think it would be better to they and be proactive

rather reactive and try and put in place a fund to fix the pot holes & broken footpaths around the city rather than having to pay close to €3 million each year on claims?

### **REPLY**

1. Provision is made for Insurance and Liability costs for all compensations claims inclusive of personal injury claims in the revenue account budget each year.

The City Councils' self insured status and its employment of a dedicated and experienced in house investigation team allows for the Councils direct control and management over its own claims costs which saw a significant decrease in the levels of expenditure the Council was previously exposed to. Current claims budget has effectively been frozen for seven years at €3,536,700 and results in the equivalent of 2.3% of the City Councils revenue expenditure as against 6.2% in earlier years.

2. The Claims Unit endeavours to handle/manage public liability and employer liability claims in an effective and efficient manner and to protect the City Councils interests and to minimise the Councils exposure to risk and financial losses whilst obtaining value for money in the handling of claims.

The Unit in its investigation of any claim seeks an early determination on liability, information as to the validity of the claim, advices on quantum, early offset transfer or sharing of liability where appropriate, or early settlement where liability is not an issue. In all other cases the Council practices a policy of robust and vigorous defence of claims at Court. There were 106 cases listed for Court Hearing during 2014.

The Claims Unit further endeavours to minimise the City Councils exposure to risk and financial losses by monitoring trends, identification/reporting/preventing of risk.

3 (a) Expenditure in 2014 on the repair of footpaths and roads amounted to €3.5m. For 2014 this was broken down evenly between footpath and road repairs.

The above figure does <u>not</u> include other maintenance works such as gully cleaning, weed control, bridge maintenance, wall maintenance, winter maintenance, maintenance of bollards, permanent repairs to Irish Water road cuttings etc

- 3(b) This breakdown is not recorded as income is not allocated to expenditure at sub service levels. However central government grants to the Council for maintenance and improvement of regional and local roads account for approx 40% of the total spend on regional and local roads.
- Information on Dublin City Council's expenditure on road and footpath repairs per capita has been sought as requested.

### 4.5 ENERGY EFFICIENCY UPGRADE SCHEME - FLATS

An Chomhairle considered and approved the report of the Assistant Chief Executive, Housing & Community Services dated 31<sup>st</sup> December 2014 on the following motion referred to the Committee An Chomhairle:

'That Cork City Council seek funding from the Energy Efficiency Fabric Upgrade Scheme for the flats on Ballyphehane, Pouladuff and Noonan Road, Fort Street and St. Finbarr's Road.'

(Proposer: Cllr. S. Martin 14/318)

The report of the Assistant Chief Executive stated that the Sustainable Energy Agency Ireland Warmer Homes Scheme provides grant aid to house owners towards the cost of works to upgrade the energy efficiency of their houses. Cork City Council does not apply directly to SEAI but supports Community Based Organisations or Energy providers who are eligible to make applications in respect of social housing. Consideration will be given to including flats at these locations if the scheme is available in 2015.

### 4.6 <u>DATABASE OF MAINTENANCE WORKS</u>

An Chomhairle considered and approved the report of the Assistant Chief Executive, Housing & Community Services dated 31<sup>st</sup> December, 2014 on the following motion referred to the Committee by An Chomhairle:

'That Cork City Council would keep a database of the maintenance works required in all houses that become vacant in order to readily ascertain the costs associated with renovation of each house in City Council stock. This database should also include the costs associated with standing utility charges, security & any miscellaneous charges on each property to fully estimate the ongoing costs to City Council of vacant houses.'

(Proposer: Cllr. N. O'Keeffe 14/396)

The report of the Assistant Chief Executive stated that the cost estimates for the repair of vacant units are already compiled as a matter of course for the purposes of instigating necessary repairs by City Council staff or by Contract as appropriate. Consideration will be given to adding individual ongoing utility and security costs, currently monitored in bulk, to provide an individual property cost register as suggested.

### 4.7 GARAGES ON FARRANFERRIS AVENUE

An Chomhairle considered and approved the report of the Assistant Chief Executive, Housing & Community Services dated 31<sup>st</sup> December, 2014 on the following motion referred to the Committee by An Chomhairle:

'Can Cork City Council secure and carry out any necessary repairs to the 5 garages on Farranferris Ave and that Cork City Council facilitate the use of the garages to members of the community.'

(Proposer: Cllr. K. Collins 14/397)

The report of the Assistant Chief Executive stated that there are no resources available to secure and repair these garages. All Housing Maintenance resources are better directed towards necessary repairs to Housing stock. Without such repair, it is considered unlikely that any local expressions of interest for future use for the garages would be forthcoming. It may thus be preferable to demolish the garages, but leaving the rear walls standing to the normal garden wall height of 2m. It is suggested that local Ward Councillors should consider and agree this course of action before implementation.

### 4.8 FLATS/APARTMENTS ON TOGHER ROAD

An Chomharile considered and approved the report of the Assistant Chief Executive, Housing & Community Services dated 31<sup>st</sup> December, 2014 on the following motion referred to the Committee by An Chomhairle:

'That City Council would include the Council owned Flats / Apartments on Togher Road in the insulation / Warmer Home Scheme in the next programme if / when funding is allocated from the Dept. of Environment.'

(Proposer: Cllr. H. Cremin 14/398)

The report of the Assistant Chief Executive stated that the Sustainable Energy Agency Ireland Warmer Homes Scheme provides grant aid to house owners towards the cost of works to upgrade the energy efficiency of their houses. Cork City Council does not apply directly to SEAI but supports Community Based Organisations or Energy providers who are eligible to make applications in respect of social housing. Consideration will be given to including flats at these locations if the scheme is available in 2015.
