An tArdmhéara Comhairleoir C. O'Leary recited the opening prayer and observed one minutes reflection. He then welcomed Members, Officials, members of the public and members of the press, and outlined the proposed format for the meeting.

Comhairleoir J. Buttimer called on An Chomhairle to show solidarity with the citizens of Paris, France, following on from the events of Friday 13<sup>th</sup> November. This was agreed.

An tArdmhéara said that elected members could make an opening statement on the Budget. All contributions from members were to be limited to three minutes in duration. However, he first invited the Chief Executive to clarify the late change to the Budget due to the Global Utility Rate Revaluation.

Following the Chief Executives clarification, Comhairleoir T. Gould called for the suspension of Standing Orders. He proposed the following and was seconded by Comhairleoir T. Brosnan:

'That tonight's meeting be adjourned to allow the Leaders and Whips, Chief Executive and Head of Finance to meet and discuss the effect of the rates reduction on Cork City Council's Budget for 2016.'

## 1. **REPORT FROM CHIEF EXECUTIVE**

The Chief Executive presented her report on the 2016 Draft Budget for Cork City Council. A detailed consideration of Service Divisions A – H then followed with the Chief Executive and other officials responding to questions and issues raised by Members.

### 2. SUSPENSION OF STANDING ORDERS

On the proposal of Comhairleoir S. Martin, seconded by Comhairleoir T. Gould, it was agreed to suspend Standing Orders to extend the meeting beyond 8pm to complete the Budget Meeting.

## 3. **SERVICE DIVISION A**

3.1 The following amendment to the Draft Budget was proposed by Comhairleoir T. Moloney and seconded by Comhairleoir M. Finn.

'That Cork City Council apply to their lenders for a one year holiday on the payment of the interest paid on loans for the Affordable Housing and Land Bank loans and to put the savings made of approximately €1.5 million towards the following:

€500,000 to Housing Maintenance,

€500,000 for Estate Resurfacing, Footpaths, etc,

€500,000 for Housing Adaptations.'

The Head of Finance advised members that loan repayments are a mandatory charge and Cork City Council is obliged to pay them.

An tArdmhéara declared that the amendment was not in order and no vote was taken.

3.2 The following amendment to the Draft Budget was proposed by Comhairleoir T. Moloney and seconded by Comhairleoir M. Finn.

'That Cork City Council takes 100% of the cost of the Housing Voids from the 2015 − 2017 Capital Programme Budget. This would have a minimum saving of €1 million which should be ring fenced as follows:

€300,000 to Housing Maintenance,

€300,000 for Estate Resurfacing, Footpaths, etc,

€300,000 for Housing Adaptations,

€100,000 toward the playground in Bishopstown.'

The Head of Finance advised members that the Budget being discussed was a Revenue Budget and transfers from Capital to Revenue could not be facilitated.

An tArdmhéara declared that the amendment was not in order and no vote was taken.

'In accordance with Section 104 of the Local Government Act 2001 that the Council hereby approves the over-expenditure for 2015 as outlined.'

An Chomhairle agreed to adopt this motion without taking a vote.
