6.2 HOUSING IN CORK CITY COUNCIL

In response to the following question submitted by Comhairleoir T. Gould, a written reply was circulated as outlined below:-

REPLY

How many houses did Cork City Council complete building in 2018

A total of 242 social housing units were constructed in 2018 in Cork City.

Cork City Council's direct construction programme delivered 113 units in 2018 of which 82 units were delivered under the Council's Competitive Dialogue programme. A further 3 new build constructed units were delivered under Part V, resulting in a total of 116 homes.

The AHB sector supported by the Council provided a further 126 newly constructed homes in the City in 2018.

How many houses did Cork City Council purchase in 2018

A total of 86 units were purchased for social housing purposes in 2018.

The Council purchased 67 units under its single dwelling acquisition programme in 2018 of which 28 units were Buy and Renew properties.

The AHB Sector, supported by the Council also provided a further 19 housing unit acquisitions in 2018, 10 of which were Buy and Renew properties.

How many properties were returned to Cork City Council in 2018

153 properties were returned/became vacant in 2018.

How many properties were vacant / empty at the 31/12/2018

142 properties were vacant as at the 31/12/18.

How many properties did Cork City Council in total allocate in 2018

There were 247 property offers accepted and 46 offers refused.

How many new applicants went on to Cork City Council's housing list in 2018

A total of 863 new households after assessment were qualified for social housing support in 2018. It should be noted that the total number of eligible applicants for housing at December 2018 was 3,902, compared to 4,636 at December 2017.

Members will be aware that a number of public housing estates in the City are yet to be taken in charge. This estate has not been taken in charge but the works required to enable same have been costed and funding is in place to carry out the required works from the €1m loan approved by the Members of Cork City Council and the Department of Housing, Planning & Local Government. These works will be completed in early 2019.

6.4 **INDEPENDENT LEGAL ADVICE RELATING TO TANK FIELD**

In response to the following question submitted by Comhairleoir J. Kavanagh, a written reply was circulated as outlined below:-

On September 10th 2018, I had a motion approved by Council in relation to me seeking Independent Legal advice pertaining to the disposal of lands at the Tank Field in Montenotte. Despite my best efforts on an ongoing basis since September 10th 2018, this has not advanced or been allowed to advance in any shape or form.

Can the CE please provide me with one good reason why I have not been permitted to go and seek the Independent Legal Advice as per my request which was approved by Council?

REPLY

At a meeting of An Chomhairle held on 10th September 2018, An Chomhairle agreed the following; Cork City Council resolves to seek independent legal advice into the validity of the aforementioned Disposal Order and the associated Part 8. (motion 18/186 refers)

"That Cork City Council clarify that decisions in relation to the disposal of lands in the Tank Field, recently activated, were made on the basis of materially incorrect and incomplete information during both the disposal and associated Part 8 process. That Cork City Council further clarify that this disposal purported to dispose of lands that the City Council didn't actually own at the time of disposal.

It is noted that the disposal report and associated map, presented to the Council as a basis for their decision, stated that the lands in question were acquired by Order of the County Registrar by means of Conveyance dated 9th October 2001, when in fact, this was not strictly the case, as illustrated below.

- Councillors were not told that (i) a significant portion of the lands were not included in the County Registrar's order, and (ii) also importantly, they were not told that this land formed part of the statutory 10% green area of Mayfield Heights housing estate (located across the road from The Tank Field).
- Furthermore, it should be noted that members were informed that Council retrospectively claimed ownership of this 10% green area by means of Possessory Title (Squatters Rights), even though it subsequently was acknowledged that no such Possessory Title had been registered, as is required by law.
- It is also an issue of concern that the information contained in the subsequent Part 8 Certification which stated that the development does not contravene the Development Plan for the City of Cork, despite the fact that it was proposing to utilise a significant area in a manner not in accordance with its Public Amenity Zoning.

In view of the above, can I propose that Cork City Council resolves to seek independent legal advice into the validity of the aforementioned Disposal Order, and the associated Part 8."

A process has been put in place to carry out the wishes of Council and to this end, an official of Cork City Council is currently engaging with an appointed Solicitor in order to progress this matter with the engagement of a Barrister.

6.6 **<u>PUBLIC LIGHTS ON CURRAGH ROAD AND SOUTH DOUGLAS ROAD</u>**

In response to the following question submitted by Comhairleoir S. Martin, a written reply was circulated as outlined below:-

Is there a financial or contractual problem with upgrading public lights that have been out for the entire winter *e.g. Curragh Road*

South Douglas Road.

REPLY

The normal maintenance and patrols of public lighting continues under the AUS SSE Airtricity Contract. However, a number of faults and status reports have been listed on the Deadsure database in relation to individual public lights on the roadways referred to as follows:

a) South Douglas Road (near Tramore Lawn) – lantern and bracket remove from existing ESB Networks pole due to degraded asset – ESB Networks notified at the time of the pole condition.

Cork City Council cannot progress replacement lantern until such time as ESB Network replace the timber pole.

- b) South Douglas Road (near DOSCO Industrial Estate) light out of order due to loss of supply with removal of ESB 'Switchwire' – ESB Networks advised of status and replacement of 'Switchwire' requested in 2018.
- c) Curragh Road PL out of order due to degraded and defective lantern Installation of replacement LED lantern dependant on the extension to the AUS Maintenance and Associated Services Contract for 2019 which is under consideration at present.

It is expected that the Curragh Rd will be addressed in coming weeks and the Council will follow up further with ESB in relation to anticipated timeline for the two locations on South Douglas Road.

Can the CE please inform Council of the total Development Charges due to Council in respect of the recent development at Pairc Ui Chaoimh. Have Council officials been given a proposed payment schedule if charges are still outstanding. In view of the reported recent interest of Croke Park in the project do Council Management have any plans to raise the matter of outstanding charges , if still due , with Croke Park officers. The monies are needed by Council to upgrade public lighting and repair public infrastructure on the approaches to PuC Nua.

REPLY

The Elected Members granted the GAA a 100% waiver from the Cork City General Contribution Scheme and the Cork City Supplementary Development Contribution Scheme.

Planning permission was granted by An Bord Pleanála for the refurbishment of Pairc Uí Chaoimh under TP 13/35808. Condition 20 required a Special Contribution towards street lighting and Condition 21 required a Special Contribution towards work to Monahan Road in the area of the proposed revised access to the stadium. The respective amounts of these contributions are to be agreed between Cork City Council and the GAA. In default of agreement, the amounts shall be referred to An Bord Pleanála for determination.

The amounts of these Special Contributions have not been agreed between Cork City Council and the GAA. They are part of a wider process ongoing between the City Council and the GAA.

REPLY

The level of funding for road resurfacing in 2019 has not yet been announced by the Department of Transport, Tourism and Sport and therefore the list of roads has not yet been finalised. Once the funding levels have been confirmed, a list of roads will be drawn up based on the pavement surface condition index rating system. The works to be undertaken will the subject of the normal tendering process and will be executed over an estimated period of 8-9 months. The order in which works will be undertaken will be available following receipt and agreement to the selected contractors work programme with details to be confirmed as soon as available together with ongoing reports on progress.

An Chomhairle considered and approved the report of the Director of Services, Housing & Community Services on Housing for December 2018.

9.2 **DEVELOPMENT AT OLD WHITECHURCH ROAD**

On the proposal of Comhairleoir T. Gould, seconded by Comhairleoir C. O'Leary, An Chomhairle considered and approved the report of the Director of Services, Housing & Community Services dated 17th January, 2019 as required under Section 179 of the Planning and Development Act, 2000 as amended in relation to infrastructure development on lands at Old Whitechurch Road.

9.3 HORSE WELFARE/PROJECT

An Chomhairle considered and approved the report of the Director of Services, Housing & Community Services dated 17th January, 2019 on the following motion referred to the Committee by An Chomhairle:-

'That Cork City Council report on:

The numbers of horses 'put down' since 2014.

Numbers of horses returned to owners or re-homed and the fees charged by anybody acting on behalf of the City Council in this regard.

Educational courses taking place in horse ownership and care Council is aware of.

Progress in establishing a 'Horse Project' for the City.

Council will seek to establish a multi-agency horse forum and will also commit to ensuring in the first instance efforts are made to re-home any stray, loose horses with the assistance of groups like 'My Lovely Horse Rescue Cork'.'

(Proposer: Cllr. M. Nugent 18/394)

The report of the Director of Services stated that Cork City Council has responsibility for the Control of Horses under the Control of Horses Act, 1996. During the period 2014 to November, 2018 there were a total of 258 horses seized. Of this number 34 were reclaimed by the owner, 18 were re-homed and 206 were euthanized. The charge for reclaiming a horse is currently €35 plus VAT @ 23%.

Cork City Council is continuing to participate in and support the Horse Initiative Steering Group. The Inter-agency Steering Group has been successful in securing funding through the Department of Agriculture, Food and the Marine to deliver a number of equine courses for young travellers across the City and to undertake some research and development work with travellers to consider the needs of horse owners. The steering group is continuing to pursue the objective of a horse project and it is envisaged that Cork City Council will continue to participate in the project.

9.4 GARAGES IN FARRANCLEARY PLACE

An Chomhairle considered and approved the report of the Director of Services, Housing & Community Services dated 17th January, 2019 on the following motion referred to the Committee by An Chomhairle:

'The garages in Farrancleary Place be structurally looked at and new guttering and down pipes be replaced as a matter of urgency. Leaks from the guttering in these garages have caused damage to the property.'

The report of the director of Services stated that Housing is aware of the issues raised and will seek to resolve them at the earliest opportunity. Any works will set out to mitigate the issues and prevent them deteriorating further, mindful of the need to ensure resources are applied to areas of work most needed, i.e. occupied and vacant dwellings.

10.5 DOUBLE YELLOW LINES AT BOREENMANNA ROAD

An Chomhairle considered and approved the report of the Director of Services, Roads and Transportation dated the 17th January 2019 on the following motion referred to the Committee by An Chomhairle.

'That Cork City Council would extend the double yellow lines at the junctions of each of the parks on the Boreenmanna Rd. to give motorists greater and safer lines of sight when exiting onto the Boreenmanna Rd.'

The report of the Director of Services stated that the junctions of individual estates off Boreenmanna Road with Boreenmanna Road itself will be assessed in order to identify the extent of the problems that exist there and also to identify the most appropriate measures that can be provided.

Any identified measure will be included in the Roads Programme.

An Chomhairle considered and approved the report of the Director of Services, Roads and Transportation dated the 17th January 2019 on the following motion referred to the Committee by An Chomhairle.

'That Cork City Council implement a programme for 2019 of ensuring traffic-calming ramps are visible to motorists and the public in general.'

(Proposer: Cllr. M. Nugent 18/372)

The report of the Director of Services stated that the visibility of traffic calming ramps will be assessed in order to identify the extent of the problems that exist and also to identify the most appropriate measures that can be provided.

Any identified measure will be put forward for consideration by Ward Members as part of the annual discussion on the traffic calming works programme.

10.7 FOOTPATHS AT DONSCOURT, BISHOPSTOWN

An Chomhairle considered and approved the report of the Director of Services, Roads and Transportation dated the 17th January 2019 on the following motion referred to the Committee by An Chomhairle.

'That City Council would inspect the footpaths at Donscourt Bishopstown as they are in a terrible state now for years and residents are very unhappy that this has not been attended to long before now.'

(Proposer: Cllr. H. Cremin 18/377)

The report of the Director of Services stated that the footpaths in Donscourt have been inspected. Locations requiring urgent works have been identified and will be added to Roads Maintenance list of works, to be completed in the first quarter of 2019. Other areas requiring general upgrade will be assessed in comparison with the overall footpath network, with funds available being prioritised to the worst affected footpaths across the overall footpath network.

10.8 JUNCTION BOX AT THE ROUNDABOUT AT WILTON/SARSFIELD ROAD

An Chomhairle considered and approved the report of the Director of Services, Roads and Transportation dated the 17th January 2019 on the following motion referred to the Committee by An Chomhairle.

'That City Council would consider putting in a small junction box at the roundabout at Wilton / Sarsfield Road to facilitate traffic coming from the West i.e. outside lane approaching the roundabout from the west to continue to flow freely to either Glasheen Road or Sarsfield Road as this is constantly blocked at peak times when drivers will not give vehicles the opportunity to continue onto a route that is free flowing and not blocked.'

(Proposer: Cllr. H. Cremin 18/378)

The report of the Director of Services stated that the roundabout at Wilton/Sarsfield Road will be examined in conjunction with An Garda Síochána and if it is deemed necessary and appropriate, a yellow box will be installed at the location.

Yellow boxes can only be installed at locations where there is a well established need.

10.9 **<u>REDUCE THE CLOSURE OF PATRICK'S STREET</u>**

An Chomhairle considered the report of the Director of Services, Roads and Transportation dated the 17th January 2019 on the following motion referred to the Committee by An Chomhairle.

'In view of the on-going trading issues being experienced by our City Centre indigenous traders and other traders alike I ask that Cork City Council would reduce the closure of Patrick's Street to 5 days per week (Monday to Friday) and reinstate normal traffic flow on Patrick's Street on Saturday, Sunday and Bank Holiday Mondays. This would, I believe, be proactive and may help to alleviate the current difficulties that the current Movement Strategy is creating.'

(Proposer: Cllr. P. Dineen 18/379)

On the proposal of the Deputy Ard-Mhéara Comhairleoir T. Moloney, An Chomhairle agreed to refer the motion back to the Roads and Transportation Functional Committee for further consideration.

10.10 MULTI STOREY CAR PARKING INCENTIVES

An Chomhairle considered the report of the Director of Services, Roads and Transportation dated the 17th January 2019 on the following motion referred to the Committee by An Chomhairle.

'In view of the on-going trading issues being experienced by our City Centre indigenous traders and other traders alike I ask that Cork City Council would abandon all current multi story car parking incentives and introduce a long term parking incentive that will allow for the first 2 hours parking to be free parking from the time of entry up to 3pm on each day. An incentive of this nature would be proactive and would I believe be a huge benefit to all concerned.'

(Proposer: Cllr. P. Dineen 18/380)

On the proposal of the Deputy Ard-Mhéara Comhairleoir T. Moloney, An Chomhairle agreed to refer the motion back to the Roads and Transportation Functional Committee for further consideration.

10.11 <u>ROAD MARKINGS ON MIDDLE GLANMIRE ROAD AND WELLINGTON</u> <u>ROAD</u>

An Chomhairle considered and approved the report of the Director of Services, Roads and Transportation dated the 17th January 2019 on the following motion referred to the Committee by An Chomhairle.

'That Cork City Council re-instate road marking, specifically centre lines, on the Middle Glanmire Road from St Luke's Cross up to Cope and onwards to the Junction with Colmcille Avenue. I also request that Cork City Council re-instate road marking, specifically centre lines, on Wellington Road from St Luke's Cross all the way down to the junction of St Patricks Hill.'

(Proposer: Cllr. J. Kavanagh 18/387)

The report of the Director of Services stated that the reinstatement of road markings on the Middle Glanmire Road (from St Luke's Cross to the Junction with Colmcille Avenue) and on Wellington Road (from St Luke's Cross to the junction of St Patricks Hill) will be assessed to determine the extent of painting works required.

Any works deemed appropriate will be inputted into the road painting programme and undertaken as soon as is practical.

10.12 PARKING BAYS ON WELLINGTON ROAD

An Chomhairle considered and approved the report of the Director of Services, Roads and Transportation dated the 17th January 2019 on the following motion referred to the Committee by An Chomhairle.

'That Cork City Council would paint parking bays aligned at a 45 degree angle (as opposed to the current 90 degree parking) on Wellington Road between the junction of Sidney Hill and the junction with York Street. Also, in order to ensure the ease of traffic

flow and public safety, can the continuous double yellow lines on the opposite side of the road be re-instated.'

(Proposer: Cllr. J. Kavanagh 18/388)

The report of the Director of Services stated that there is a considerable body of research examining the safety impacts of angled and parallel parking, and the general consensus of these studies is that parallel parking is safer than angular parking. Angled parking can be hazardous and interferes with traffic flow. Angular parking also poses a danger to cyclists as it is difficult for drivers to see cyclists as they are reversing out of the angled parking spaces. Wellington Road (between the junction of Sidney Hill and the junction with York Street) will be assessed as requested.

Any proposed changes to parking provision particularly in relation to the removal of parking will need to be undertaken in consultation with the local community and business owners. If lining works are deemed appropriate, they will be put forward for consideration to be included in the Roads Programme and will be undertaken, subject to funding being available.

10.13 **TAKE IN CHARGE OF BEAUMONT LANE**

An Chomhairle considered and approved the report of the Director of Services, Roads and Transportation dated the 17th January 2019 on the following motion referred to the Committee by An Chomhairle.

'That Beaumont Lane be taken in charge. The lane at the junction of Beaumont Drive and the Blackrock Road.'

(Proposer: Cllr. D. Cahill 18/339)

The report of the Director of Services stated that an assessment will be undertaken with a view to taking in charge Beaumont Lane and a report will be prepared in due course for the Committee's consideration.
