"It is resolved that at the meeting of Cork City Council on 28th September 2022, the basic rate of the Local Property Tax should stand varied upwards by 9% for the years 2023 and 2024 in respect of the relevant residential properties situated in its administrative area."

An t-Ard-Mhéara declared the resolution hereby adopted.
