### 6.1 **PLANTING IN OPEN SPACES**

In response to the following question submitted by Comhairleoir J. Buttimer, a written reply was circulated as outlined below:-

To ask the Chief Executive in respect to planting in open public spaces and taken-in-charge estates; was is the official City Council policy with regard to the selection of trees, shrubs and other plants; what criteria are used to judge the appropriate height and spread of mature trees (branches and roots) in residential areas and their impact on adjoining properties; what processes and procedures are in place to assess trees in residential areas; has City Council looked to develop any strategic plan for the collection and composting of leaves from Council owned trees and shrubs either on its own or with other stakeholders; what protocols are in place with statutory bodies with regard to the pruning and cutting of trees on public lands?

#### **REPLY**

- 1. Tree planting in open public spaces and taken-in-charge estates; what is the official City Council policy with regard to the selection of trees, shrubs and other plants; what criteria are used to judge the appropriate height and spread of mature trees (branches and roots) in residential areas and their impact on adjoining properties?

  The height and crown spread of all tree and shrub species is established and well documented. The tree and shrub species selected for individual areas is determined by the specific location for planting, the space available to enable the selected species to reach its maximum size in terms of height, spread and root spread, distance from houses and other properties and, the presence of utilities.
- 2. What processes and procedures are in place to assess trees in residential areas? General observation of trees on public lands is undertaken by the relevant Parks Area Foreman and their staff. Where they identify a particular issue with an individual tree, a more detailed inspection is carried out by trained personnel in the Council's tree section and, where appropriate, by an external Arboriculture specialist.
- 3. Has the City Council looked to develop any strategic plan for the collection and composting of leaves from Council owned trees and shrubs either on its own or with other stakeholders?
  - The majority of fallen leaves during Autumn in parks and open space areas remain in situ and decompose naturally in shrubberies and hedgerows. Where necessary, leaves are swept, collected and deposited in these areas to decompose.
  - Leaves are collected in Fitzgerald's Park for compositing and used as mulch as appropriate.

The majority of leaves collected on streets are collected along with litter and other materials, segregating the leaves from these other materials would be extremely labour intensive, expensive and therefore not a viable option at present in the context of current scarce resources.

4. What protocols are in place with statutory bodies with regard to the pruning and cutting of trees on public lands?

Requests from Statutory bodies, to prune trees adjacent to utilities are made to the Council from time to time in the context of Health & Safety. Prior to the embargo on recruitment, the Council had a dedicated tree gang assigned to this service. The current arrangement is that the Statutory body engages a competent Arboricultural Contractor and undertakes the necessary pruning works agreed with the Council.

How many Executive Housing Officers does Cork City Council have?

How many houses has each Executive Housing Officer to manage and according to best practice, what should the ratio for Executive Housing Officers to council tenant housing be?

What additional resources / staff is Cork City Council investing in the housing department to prevent or reduce anti-social behaviour by Cork City Council tenants?

What safeguards are in place for Cork City Council staff when dealing with problem Tenants

The Tenancy Enforcement Officer is also responsible for Traveller Accommodation, why are these jobs combined. Is it a result of Government cuts or the staff embargo or lack of funding?

Does the CE acknowledge that Cork City Council Housing Department does not have enough staff or resources in place to deal with the amount of anti-social behaviour reports the council has received?

#### REPLY

Cork City Council's Housing Directorate currently employs nine Executive Housing Officers (EHOs).

Each EHO is responsible for on average 995 housing units.

A study carried out by UCC in 2000 recommends a maximum of 500 housing units per EHO.

Currently, it is not possible to recruit any additional resources to prevent, reduce and address anti-social behaviour issues within Council estates / properties. However, this will be kept under review and considered in the context of the annual budgeting process.

The present safeguards include the following:

- 1. Supervisors always informed as to the location of EHOs in particular properties.
- 2. EHOs require the assistance of Gardai when deemed necessary.
- 3. Dog distracter electronic devices

The role of Tenancy Enforcement Officer and Traveller Accommodation Officer has been combined for many years and this is not due to cutbacks.

I am satisfied that reports of anti social behaviour are addressed to the best of our ability, and as promptly as possible, within existing available resources. The staff involved are very dedicated and are to be commended for their work in combating this issue, which is by its nature, very challenging.

Could a schedule for grass cutting services which Cork City Council provides for each estate it services within its boundaries be provided to Members?

#### **REPLY**

#### Council Estates

Maintenance of grass areas within Council Estates is on a 14 - 16 day cycle and includes litter collection and general grounds maintenance duties.

#### Private Estates

Maintenance of grass areas within private estates consists of two mowings, one in March and the second in October. Mowings in between are either undertaken by the residents either by themselves or through the services of a contractor. The Council does assist with additional cuts, as resources permit, when individual estates appear to struggle with providing the required number of mowings to maintain their areas in a satisfactory condition. In addition to assisting with grass maintenance, the Council undertake clean-ups as and when required and, the maintenance of trees, shrubs and floral planting.

### Grass Verges

Maintenance of grass verges adjacent to roads and paths in both Council and private estates varies from a 14 - 16 day cycle to two mowings a year (in areas considered appropriate to set aside as nature/biodiversity areas).

### 6.5 **ART SCHEMES IN 2014, 2015 AND 2016**

In response to the following question submitted by Comhairleoir S. Martin, a written reply was circulated as outlined below:-

How much money was collected by the per cent for Art Schemes in 2014, 2015, 2016?

What works were carried out under this Scheme?

#### REPLY

The Per Cent for Art scheme is an initiative, whereby 1% of the cost of any publicly funded capital, infrastructural and building development can be allocated to the commissioning of a work of art. Since 1997 this scheme has been made available to all capital projects across all government departments.

Capital programmes where the Per Cent for Art applies include: - public housing projects, (social and affordable schemes); transport and roads; environmental schemes such as drainage schemes, pump stations and reservoirs; public buildings such as libraries, public offices, schools, hospitals, medical centres, prisons, cultural buildings - cinemas, theatres, art centres; conservation works carried out to public buildings and sites and, urban and village renewal schemes.

2014 - Cork City Council did not commission a % for Art Commission in 2014

**2015** - Cork City Council commissioned a % for Art project for Hollyhill library development. The Commission amount was €24,000. Three writers Billy O'Callaghan,

William Wall and Doireann Ní Ghríofa and photographer John Minihan created prose, poetry and photography published in a book called 'The Berries'.

**2016** – Cork City Council secured €80,000 from the Phase 1 A, Phase 1B and Phase 2A of the North West Quarter regeneration development. There was an international public commissioning process undertaken in 2016 and UK based artist Mark Storor was awarded the commission in 2017. The artists socially engaged commissioned will be completed by end of 2018.

A % for Art scheme of €33,000 was secured from the development of St Anthony's park, Hollyhill. Artist Leanne McDonagh was awarded the commission to develop a permanent sculpture informed by the traveller community to mark the year ethnicity status was recognised by Government. The project will be completed by November 2017.

The % for Art scheme budget included in Cork City Council works to date over the next few years are;

- **Deanrock** €51,000 estimated completion housing scheme by 2019 large housing estate and community centre: % For Art commissioning process will begin 2018
- Churchfield Place East €5,500\* estimated completion of housing works 2018 % For Art commissioning process will begin 2018
- Gerald Griffin Street €51,000 estimated works completion 2019/2020— large apartment complex with community facility % For Art commissioning process will begin 2019
- St. John's Well €9,752\* estimated works completion 2018 -% For Art commissioning process will begin 2018
- Shandon Street/ John Philpott Curren street €28k –estimated completion date 2017/2018- % For Art commissioning process will begin 2018
- **Boyces Street**-€ 51k estimated works completion date 2019/2020 % For Art commissioning process will begin 2020
- Bramble cottage— €10k estimated works completion 2019. % For Art commissioning process will begin 2019

### 6.7 <u>VACANT LOCAL AUTHORITY HOUSING UNITS IN CORK CITY</u>

That the CE would report on the number of vacant local authority housing units in Cork City currently and the level of funding available and approved by the Department for turning around these vacant units?

### **REPLY**

The total number of vacant houses as of 18<sup>th</sup> May is 290. This represents 3.2% of housing stock. The number of units within the 290 which for various reasons, as listed in the report to the Housing Functional Committee A2/8, are at present unavailable for repair is 96. The remaining 194 units include the following:

- ➤ units for which the Council is awaiting the return of keys
- ➤ Purchased units
- ➤ Units under repair/contract

Therefore, the number of units capable of repair is 110 or 1.2% of total stock.

The Department of Housing, Planning, Community & Local Government has approved an allocation of €871,000 towards the cost of refurbishing and retrofitting 43 vacant units subject to certain constraints.

#### REPLY

There are seven (7) loading bays located on Patrick Street.

The nearest loading bay to Merchant's Quay shopping centre is located on Merchant's Quay. On Patrick Street, the nearest loading bay to Merchant's Quay is outside the Savoy

- Merchants Quay;
- outside Savoy;
- outside Penneys;
- outside Le Chateau bar;
- outside Monsoon;
- outside Superdry (formerly The Moderne);
- outside HMV;
- outside Oasis/Burger King;

There are currently no plans to provide more loading bays in the area. The number of local bays is reviewed frequently in the context of demand and use. It is also reviewed as part of the Council's ongoing capital works programme.

### 11.5 <u>WALL CAPPING – GREEN AREA AT MARKET GARDENS</u>

An Chomhairle considered and approved the report of the Director of Services, Housing and Community Services dated 13<sup>th</sup> April 2017 on the following motion referred to the Committee by An Chomhairle:-

'That Cork City Council would complete the wall by placing Capping's on the cavity block walls dividing the private property and the green area at Market Gardens Togher. This wall is located between properties No. 56 and 57 and is a huge cause of concern for residents here as youths are climbing this wall and getting into residents back gardens. By putting these capping's in place it would drastically reduce this type of behaviour and give residents in this area some peace of mind.'

(Proposer: Cllr. H. Cremin 17/096)

The report of the Director of Services stated that the site was visited, inspected and residents were consulted. The subject wall is already complete with capping, albeit flat.

### 11.6 FARRANCLEARY FLATS AND GARAGES

An Chomhairle considered and approved the report of the Director of Services, Housing and Community Services dated 11<sup>th</sup> May, 2017 on the following motion referred to the Committee by An Chomhairle:

'That Cork City Council would include in its programme of works for 2017 the repainting of the Farran Cleary flats and repair the soffits and shoots of the Farran Cleary garage in Blackpool.'

(Proposer: Cllr. K. O'Flynn 17/085)

The report of the Director of Services stated that Cork City Council will arrange an inspection of the Farrancleary flats and garages with a view to carrying out any necessary painting and repairs to soffits during 2017. The ability and timeframe to carry out any identified work is dependent on the extent of the work required.

### 11.7 TRAVELLER ACCOMMODATION

An Chomhairle considered and approved the report of the Director of Services, Housing and Community Services dated 11<sup>th</sup> May, 2017 on the following motion referred to the Committee by An Chomhairle:

'In the context of Traveller Accommodation issues, City Council to report on: The midterm review of the Traveller Accommodation Plan 2014-2018, Funds available for Traveller accommodation this year and plans for same. The process and timeline for the next Traveller Accommodation Plan.'

(Proposer: Cllr. M. Nugent 17/125)

The report of the Director of Services stated that the mid-term review of the Traveller Accommodation Plan was sent to the Department of Housing, Planning, Community and Local Government (DHPCLG) in September 2016. The review was presented to the Local Traveller Accommodation Consultative Committee and was approved by the Director before being submitted to the DHPCLG.

Capital funds have been sought to build a retaining wall on the Spring Lane Halting site. Funds have also been requested to carry out upgrade works on the site.

The following has been provisionally approved pending a further review of the projects. This represents funding of 50% of the estimated costs involved. The Council needs full funding for these projects to proceed.

General Refurbishment: €365,415
Cliff Re-stabilisation Phase 2: €188,757

The process and timeline for the next Traveller Accommodation Plan 2019-2023 will be set by the DHPCLG.

As a point of information, the circular relating to the current Traveller Accommodation Plan 2014-2018 was circulated to local authorities in August 2013. It is expected the timeline for the new plan will be similar, i.e. initial Circular Letter due in 2018.

### 11.8 **APPLICATIONS FOR DOWNSIZING**

An Chomhairle considered and approved the report of the Director of Services, Housing and Community Services dated 11<sup>th</sup> May, 2017 on the following motion referred to the Committee by An Chomhairle:

'That City Council would forward a full report on our position and the status of our downsizing applications list and what progress if any is being made in reducing this list.'

(Proposer: Cllr. H. Cremin 17/130)

The report of the Director of Services stated that Cork City Council accepts applications for lettings under the downsizing scheme in the following circumstances and in order of priority as follows:

- Persons who are living in unfit or unsuitable accommodation for their needs;
- Elderly persons who wish to surrender their family home and move to smaller/more suitable accommodation; and
- Persons who are in need of housing on medical, compassionate or similar grounds.

There are currently 68 approved downsizing applications on hand, of which 53 are from applicants over 50 years of age. Cork City Council has, within its rented stock, certain designated dwellings which are more suitable for the needs of elderly persons (e.g. Barrett's Buildings) and such applicants may be considered for these properties as vacancies arise.

Applicants approved for downsizing may also access and bid on available properties on the Choice Based Letting (CBL) system.

### 11.9 TASK FORCE FOR ANTI-SOCIAL BEHAVIOUR

An Chomhairle considered and approved the report of the Director of Services, Housing and Community Services dated 11<sup>th</sup> May, 2017 on the following motion referred to the Committee by An Chomhairle:

'That Cork City Council would put a task force together to tackle the issue of unruly tenants and tenants that cause anti-social behaviour in their communities. That the task force would include officials from Cork City Council Housing Department, community guards and a senior member of Gardaí management also with a senior member of Cork City Council housing department and any other persons that would be of assistance in combating the increasing levels of tenants causing anti-social behaviour.'

(Proposer: Cllr. T. Gould 17/132)

The report of the Director of Services stated that City Council staff work closely with Gardaí in a number of fora already including Safety Forums and Joint Policing Committees.

Council staff have built up strong working relationships with Gardaí and work closely with Gardaí to combat anti-social behaviour.

Cork City Council's Tenancy Enforcement Officer recently met with our own Law Department and a Garda Superintendent to review legislation in relation to anti-social behaviour and a new process has been agreed for the reporting and follow up of anti-social behaviour, using the legislation to maximum effect.

25 tenants were removed from their homes during 2015/16 due to anti-social behaviour. 2 court orders were secured last month.

The Council will look to remove tenants where anti-social behaviour can be substantiated based on neighbours and/or Garda evidence. This is not achievable in all cases.

### 12. ROADS & TRANSPORTATION FUNCTIONAL COMMITTEE – 15<sup>th</sup> MAY 2017

An Chomhairle considered and noted the minutes of the Roads & Transportation Functional Committee from its meeting held 15<sup>th</sup> May 2017.

### 12.1 **ROADWORKS PROGRAMME**

An Chomhairle considered and approved the report of the Director of Services, dated the 11<sup>th</sup> May 2017 on the progress of the ongoing Roadwork's Programme for the month ending April 2017.

# 12.2 <u>DOUBLE YELLOW LINES AT THE JUNCTION LEADING TO SILVERHEIGHTS ROAD</u>

An Chomhairle considered and approved the report of the Director of Services, dated the 11<sup>th</sup> May 2017 on the following motion (as amended) referred to the Committee by An Chomhairle:

'That Cork City Council put in place double yellow lines at the upper side of this estate adjacent to the junction on Boherboy Road leading to Silverheights Road. While residents park outside their houses, a growing number of motorists are now leaving their cars in this area and taking the bus to town. This unwelcome car congestion is presenting a serious public safety hazard to both residents and children using the local school.'

(Proposer: Cllr. J. Kavanagh 17/063)

The report of the Director of Services stated that if the residents of Silverheights Road are experiencing problems due to unregulated parking, a written request in the form of a plebiscite from all residents affected to introduce parking controls in the form of double yellow lines or pay parking controls should be submitted to the Transportation Division.

### 12.3 **RE-PAINT ROAD SIGNS IN BALLYPHEHANE**

An Chomhairle considered and approved the report of the Director of Services, dated the 11<sup>th</sup> May 2017 on the following motion referred to the Committee by An Chomhairle:

'That all road signs in Ballyphehane be immediately re-painted.'

(Proposer: Cllr. S. Martin 17/103)

An Chomhairle further agreed that the issue of funding such works over a number of years would be examined.

The report of the Director of Services stated that this proposal was considered previously by the Commemoration Motions Committee of Cork City Council and it was deemed that resources were not available to undertake the work required.

### 12.4 **REPAINT ROAD SIGNS**

An Chomhairle considered and approved the report of the Director of Services, dated the 11<sup>th</sup> May 2017 on the following motion referred to the Committee by An Chomhairle:

14

'That the following road (street) signs which have been painted over be re-painted to their original status St. Endas Road, Templeacre Avenue, Rathmore Road, Springfield Estate (Mayfield), Kilnap Place, St. Brendan's Road, Kerry Road, North Mon Road, St. Joseph's Terrace, Killeens Place, Pophams Road.'

(Proposer: Cllr. S. Martin 17/104)

The report of the Director of Services stated that Cork City Council will assess the road (street) sign requests for St. Endas Road, Templeacre Avenue, Rathmore Road, Springfield Estate (Mayfield), Kilnap Place, St. Brendan's Road, Kerry Road, North Mon Road, St. Joseph's Terrace, Killeens Place, Pophams Road.

If deemed appropriate they will be inputted into the roads programme and will be undertaken subject to suitable weather conditions and funding being available.

### 12.5 NAMEPLATES ON FRIARS WALK

An Chomhairle considered and approved the report of the Director of Services, dated the 11<sup>th</sup> May 2017 on the following motion referred to the Committee by An Chomhairle:

'That mindful of the fact it is one of the longest streets in Cork, nameplates be erected along Friars Walk from its junction at Tower Street to its junction with Tramore Road a distance of some 1.7km, currently without any designation.'

(Proposer: Cllr. M. Finn 17/106)

The report of the Director of Services stated that Cork City Council has a small annual allocation to fund the erection of road and street nameplace signs within the city administrative area. This fund covers the costs for replacing old, damaged or stolen signs as well as the erection of new signs.

The appropriateness of the sign for, Friars Walk from its junction at Tower Street to its junction with Tramore Road will be assessed. If deemed suitable, it will be added to the list of requests for nameplates that will be put forward for execution, subject to funding being available.

### 12.6 TRAFFIC CALMING IN FRIARS WALK

An Chomhairle considered and approved the report of the Director of Services, dated the 11<sup>th</sup> May 2017 on the following motion referred to the Committee by An Chomhairle:

That in light of the re-routing of the 203 bus in Ballyphehane (that was often cited as an impediment to this proposal), traffic-calming or other necessary safety measures are undertaken on the stretch of Friars Walk from the Credit Union to the former Barbers Shop to facilitate residents' access to their home...the work perhaps to be undertaken in conjunction with mooted calming works at nearby Morning Star NS.'

(Proposer: Cllr. M. Finn 17/112)

The report of the Director of Services stated that Friars Walk from the Credit Union to the former Barbers Shop will be added to the list of areas where a request for traffic calming has been received. The area will be assessed to determine the extent of the problems that exist in order to identify any possible mitigation measures that can be provided there.

Any identified traffic calming solutions will be put forward for consideration by Ward Members to be included in the Roads Programme, subject to funding being available.

### 12.7 SIGN AT THE ENTRANCE TO MOUNT FARREN ESTATE

An Chomhairle considered and approved the report of the Director of Services, dated the 11<sup>th</sup> May 2017 on the following motion referred to the Committee by An Chomhairle:

'That Cork City Council would erect a sign at the entrance to Mount Farren Estate.'

(Proposer: Cllr. J. Sheehan 17/118)

The report of the Director of Services stated that Cork City Council has a small annual allocation to fund the erection of road and street nameplace signs within the city administrative area. This fund covers the costs for replacing old, damaged or stolen signs as well as the erection of new signs.

The appropriateness of the sign at the entrance to Mount Farren Estate will be assessed. If deemed suitable, it will be added to the list of requests for nameplates that will be put forward for execution, subject to funding being available.

# 12.8 PUBLIC RIGHT OF WAY FROM OLD YOUGHAL ROAD TO BALLYHOOLEY ROAD, THE QUARRY STEPS

An Chomhairle considered and approved the report of the Director of Services, dated the 11<sup>th</sup> May 2017 on the following motion referred to the Committee by An Chomhairle:

'That Cork City Council would now permanently extinguish the public right of way from Old Youghal Road to Ballyhooley Road, known locally as the Quarry steps. This matter has been delayed for many years by officials and now it must be closed permanently in the public interest and the common good.'

(Proposer: Cllr. T. Brosnan 17/123)

The report of the Director of Services stated that a detailed scheme for the future use of the quarry steps area is currently being prepared by a number of City Council Directorates being led by the Strategic Planning and Development Directorate. When agreement is reached on the exact nature of the area, consideration can then be given to extinguishing the public right of way as part of a holistic solution to current issues.

### 12.9 PARKING AT THE BALLINLOUGH SHOPPING PARADE

An Chomhairle considered and approved the report of the Director of Services, dated the 11<sup>th</sup> May 2017 on the following motion referred to the Committee by An Chomhairle:

'That Cork City Council reviews and assesses the feasibility of increasing parking provision within the Ballinlough shopping parade, near the Silver Key Bar. There are five businesses trading within the area and parking is not adequate. This is causing problems for customers of the businesses and illegal parking is an issue for nearby residents.'

(Proposer: Cllr. N. O'Keeffe 17/127)

The report of the Director of Services stated that parking near the Ballinlough shopping parade adjacent to the Silver Key Bar can be assessed to determine the issues that exist in order to identify any improvements that can be provided there.

It may also be useful for the five businesses to engage with their customers in relation to appropriate parking and also in relation to logistics associated with deliveries to their premises.

# 12.10 <u>REVIEW OF SPEEDING ON GLASHEEN RD, MAGAZINE RD AND O'DONOVAN'S RD</u>

An Chomhairle considered and approved the report of the Director of Services, dated the 11<sup>th</sup> May 2017 on the following motion referred to the Committee by An Chomhairle:

'That Cork City Council would undertake a review of speeding on the Glasheen Road, Magazine Road and O'Donovan's Road and would develop a plan for speed reduction and noise mitigation measures to ensure increased safety for all road users especially pedestrians, that this report would also consider the need for traffic calming measures in estates off these roads and that improved access and egress for local estates on these roads would also be augmented and enhanced.'

(Proposer: Cllr. J. Buttimer 17/128)

An Chomhairle further agreed that locations in the area be included for consideration in the roll out/relocation of speed warning signs.

The report of the Director of Services stated that Glasheen Road, Magazine Road and O'Donovan's Road are all situated within the 50kph speed limit zone which is the maximum speed at which vehicles may legally travel. It is the responsibility of the driver to obey a speed limit at all times such that the speed at which their vehicle is been driven is appropriate for the conditions even if that speed is lower than the speed limit. Enforcement is a matter for An Garda Síochána.

A reduced speed limit can help as a noise mitigation measure. However, due to their strategic nature, Glasheen Road, Magazine Road and O'Donovan's Road are not suitable to be considered for a reduced speed limit of 30kph.

Noise mitigation measures to counter traffic noise, which are being encouraged on a city wide basis include:

- the encouragement of more environmentally friendly forms of transport such was walking and cycling;
- the encouragement of the use of public transport;
- the installation of traffic calming, where appropriate;
- the use of low noise road resurfacing, where appropriate.

Specific estates requesting traffic calming measures can register this request with Cork City Council so that they can be added to the list of areas where a request for traffic calming has been received. The area will be assessed to determine the extent of the problems that exist in order to identify any possible mitigation measures that can be provided there.

Any identified traffic calming solutions will be put forward for consideration by Ward Members to be included in the Roads Programme, subject to funding being available.

Improvements to access and egress to local estates will be improved as part of the improvement schemes proposed in the Corridor Study.

### 12.11 **REVIEW OF THE PUBLIC REALM AT UAM VAR, BISHOPSTOWN**

An Chomhairle considered and approved the report of Director of Services dated the 11<sup>th</sup> May 2017 on the following motion referred to the Committee by An Chomhairle:

'That Cork City Council would undertake a major review of the public realm, road network and footpath network in Uam Var, Bishopstown, and would liaise with the Residents Association to develop a plan to remediate identified deficits and that anti-dog fouling litter signs would be erected as well as the provision of bins for the deposit of such waste.'

(Proposer: Cllr. J. Buttimer 17/129)

The report of the Director of Services stated that the request for anti-dog fouling litter signs and the provision of bins for the deposit of such waste is a matter for the Environment Directorate and will passed onto them for their attention.

The roads and footways in the Uam Var area will be assessed with a view to creating a rolling programme for any necessary repairs in the general area.

### 12.12 INSTALL PEDESTRIAN CROSSINGS IN TOGHER

An Chomhairle considered and approved the report of the Director of Services, dated the 11<sup>th</sup> May 2017 on the following motion referred to the Committee by An Chomhairle:

'That City Council would install pedestrian crossings in the following areas in Togher:-

 On Togher Road between Deanvale and Market Gardens to accommodation the residents of Deanrock Estate and particularly with the new development under construction. These residents have nowhere to cross Togher Road safely between Tramore Rd. and Vicars Rd. 2. Tramore Road residents have being lobbying Cllrs. for a predestrian crossing on this road for some years now since the removal of the traffic lights at this junction with Togher Rd. Ideally they would like this to be installed between that junction and their local Shop / Post Office.'

(Proposer: Cllr. H. Cremin 17/131)

The report of the Director of Services stated that in the context of the new Deanrock Housing Project, it is proposed to undertake an upgrade of the existing traffic signal control junction to include a revised geometric layout. This proposal incorporates an improved level of service for pedestrians using the crossing facilities at the junction Clashduv/Togher Road junction. A funding allocation has been secured in relation to this work and the scheme is currently at design stage.

Significant improvements have been incorporated into the revised layout at the Togehr Road – Tramore Road Roundabout with the provision of Zebra Pedestrian Crossings and much reduced lane widths on approaches. Further proposals to upgrade the network have been considered in the context of the South West Strategic Corridor Study and measures, including the provision of pedestrian facilities, are assessed with regard to needs that would support more sustainable travel for which NTA funding may be allocated on future Roads Programmes.

# 12.13 ROAD RESURFACING ON CATHEDRAL ROAD, CATHEDRAL STREET, ROMAN STREET, UPPER JOHN STREET AND GERALD GRIFFIN STREET

An Chomhairle considered and approved the report of the Director of Services, dated the 11<sup>th</sup> May 2017 on the following motion referred to the Committee by An Chomhairle:

'That Cork City Council would carry out urgent road resurfacing on Cathedral Road, Cathedral Street, Roman Street, Upper John Street, Gerald Griffin Street and surrounding roads because of the shocking state of the roads following the works Irish Water carried out and because of the lack of investment by the Government.'

(Proposer: Cllr. T. Gould 17/133)

The report of the Director of Services stated that sections of Cathedral Road, Cathedral St and Roman St are included in the 2017 Road Resurfacing Programme. The extent of works carried out will be dependent on tender prices received and available funding. Upper John St and Gerald Griffin St will be assessed for possible inclusion in a future resurfacing programme.

### 12.14 ESTATE RESURFACING PROGRAMME

An Chomhairle considered and approved the report of the Director of Services, dated the 11<sup>th</sup> May 2017 on the following motion referred to the Committee by An Chomhairle:

'That Connolly Park be included in the 2017 Estate Resurfacing Programme.'

(Proposer: Cllr. S. Martin 17/109)

The report of the Director of Services stated that the road surface at Connolly Park will be assessed and considered for inclusion in a future resurfacing programme.

### 12.15 **UP TO DATE FOBS**

An Chomhairle considered and approved the report of the Director of Services, dated the 11<sup>th</sup> May 2017 on the following motion referred to the Committee by An Chomhairle:

'To ensure the residents of Shandon Way are issued with up to date fobs to ensure access for cars/those with mobility assistance etc. For residents.'

(Proposer: Cllr. K. O'Flynn 17/113)

The report of the Director of Services stated that this motion is to be forwarded to the Housing & Community Directorate.

# 12.16 <u>REPLACE THE MISSING NAMEPLATES FROM PARKLANDS, COMMONS ROAD</u>

An Chomhairle considered and approved the report of the Director of Services, dated the 11<sup>th</sup> May 2017 on the following motion referred to the Committee by An Chomhairle:

'That Cork City Council would replace the name plates that is missing from each of the estates in Parklands Commons Road,'

(Proposer: Cllr. K. Collins 17/135)

The report of the Director of Services stated that Cork City Council has a small annual allocation to fund the erection of road and street nameplace signs within the city administrative area. This fund covers the costs for replacing old, damaged or stolen signs as well as the erection of new signs.

The replacement of missing name plates from the estates in Parklands Commons Road will be assessed. If deemed appropriate, they will be added to the list of requests for nameplates that will be put forward for execution, subject to funding being available.

### 12.17 RESURFACE FOOTPATHS ON EDWARD WALSH ROAD

An Chomhairle considered and approved the report of the Director of Services, dated the 11<sup>th</sup> May 2017 on the following motion referred to the Committee by An Chomhairle:

'That City Council would examine all the footpaths on Edward Walsh Road with the intentions of a total new resurfacing programme for this area. These footpaths are in a terrible condition and dangerous for pedestrians.'

(Proposer: Cllr. H. Cremin 17/139)

The report of the Director of Services stated that the footpaths on Edward Walsh Road will be assessed and considered for inclusion in any future footpath replacement programme, subject to resources being available.

### 12.18 FULL INSPECTION AT HAZEL ROAD, TOGHER

An Chomhairle considered and approved the report of the Director of Services, dated the 11<sup>th</sup> May 2017 on the following motion referred to the Committee by An Chomhairle:

'That City Council roads section would carry out a full inspection on the condition of the road surface at Hazel Road Togher. In particular I would ask the two cul de sacs on this road be given serious consideration for resurfacing as some of the residents have had serious falls in these areas.'

(Proposer: Cllr. H. Cremin 17/140)

The report of the Director of Services stated that the road surface including the cul de sacs at Hazel Road will be assessed and considered for inclusion in a future resurfacing programme.

### 12.19 CITY CENTRE MOEVEMENT STRATEGY PARKING TIMES

An Chomhairle considered and approved the report of the Director of Services, dated the 11<sup>th</sup> May 2017 on the following motion referred to the Committee by An Chomhairle:

'That Cork City Council would amend the City Centre Movement Strategy parking times and revert back to its original times covering the areas around the Mercy University Hospital from Little Hanover St to Grenville Place and including Sheares St, Henry St, Moore St and Coach St. There is a lot of very sick patients using these Roads to park while receiving treatment along with the medical staff that work in the hospital.'

(Proposer: Cllr. K. Collins 17/141)

An Chomhairle noted that it was also advised that the scheme provides for review post completion.

The report of the Director of Services stated that the changes to the parking within the Middle Parish area were put forward following consideration of issues raised by the Middle Parish Residents Association during the consultation for the City Centre Movement Strategy Phase 1&2 scheme and were agreed by Council as part of the Planning process.

The changes are designed to better balance the needs of residents in the area. They also ensure that those who visit the area with short term needs for parking can be accommodated by ensuring turnover of on street spaces during the day and early evening whilst those working or with longer term requirements can use off street parking. The hours of the North Main Street car park have been extended to facilitate this.

#### 12.20 REVIEW PARKING IN THE FOYLE AVENUE AREA

An Chomhairle considered and approved the report of the Director of Services, dated the 11<sup>th</sup> May 2017 on the following motion referred to the Committee by An Chomhairle:

'Given the increase in services at the community buildings and senior citizens centre at Foyle Avenue Knocknaheeny that council review the parking allocation in the Foyle Avenue area keeping in mind local residents, people with medical needs and older people attending the services.'

(Proposer: Cllr. T. Fitzgerald 17/142)

The report of the Director of Services stated that parking allocation in the Foyle Avenue Knocknaheeny can be assessed to determine the issues that exist as well as identify any improvements that can be provided there.

Any identified measures will be put forward for consideration to be included in the Roads Programme, subject to funding being available.

# 12.21 <u>REVIEW OF PARKING AND ROAD LAYOUT OUTSIDE THE SHOPPING PARADE</u>

An Chomhairle considered and approved the report of the Director of Services, dated the 11<sup>th</sup> May 2017 on the following motion referred to the Committee by An Chomhairle:

'That the Council review the parking situation and road layout outside the shopping parade near the Silver Key bar. At present there is very little parking for the five businesses trading here. There can be a lot of congestion and illegal parking around busy times and this affects business and causes problems for local residents who are left with no option but to call the Gardaí. A strip of cycle lane on the main road was formerly much used and greatly appreciated parking.'

(Proposer: Cllr. K. McCarthy 17/143)

The report of the Director of Services stated that parking near the Ballinlough Shopping Parade adjacent to the Silver Key Bar can be assessed to determine the issues that exist in order to identify any improvements that can be provided there.

It may also be useful for the five businesses to engage with their customers in relation to appropriate parking and also in relation to logistics associated with deliveries to their premises.

### 12.22 RESURFACE ROAD OUTSIDE GALVIN'S OFF-LICENCE ON DOUGLAS ROAD

An Chomhairle considered and approved the report of the Director of Services, dated the 11<sup>th</sup> May 2017 on the following motion referred to the Committee by An Chomhairle:

'That the Council resurface the stretch of road outside Galvin's Off-Licence on Douglas Road. It has been in a deteriorating state for many years now.'

(Proposer: Cllr. K. McCarthy 17/144)

The report of the Director of Services stated that the road surface at the Douglas Road between Endsleigh and Woodview will be renewed as part of the 2017 resurfacing programme.

### 12.23 TWO STOP STRATEGY FOR BLACK ASH PARK AND RIDE

An Chomhairle considered and approved the report of the Director of Services, dated the 11<sup>th</sup> May 2017 on the following motion referred to the Committee by An Chomhairle:

'Taking into consideration that the Black Ash Park and Ride is under performing I propose that the Roads and Transportation Directorate of Cork City Council review and replace its current one stop fits all strategy on Lapps Quay and replace it with a new two stop strategy. One stop being on the Grand Parade and the second stop being on Patrick Street. It is my belief that this would enable the Black Ash Park and Ride to reach its full potential while also increasing foot fall into the City Centre.'

(Proposer: Cllr. P. Dineen 17/145)

The report of the Director of Services stated that we are currently reviewing operations to identify optimum arrangements and will have regard to the motion. It should be noted however that Lapps Quay is approximately 640m from the Fountain in Grand Parade and 340 m from Patrick Street. If the Black Ash Park & Ride bus was to access the proposed stops on Grand Parade and St. Patrick Street, the longer route and the subsequent increased bus journey time will reduce the attractiveness and efficiency of the service. This could outweigh any benefit of walking time to/from Lapps Quay.

### 12.24 <u>FULL ESTATE RESURFACING AT MERRION COURT HOUSING ESTATE</u>

An Chomhairle considered and approved the report of the Director of Services, dated the 11<sup>th</sup> May 2017 on the following motion referred to the Committee by An Chomhairle:

'That Merrion Court Housing Estate be considered for full estate resurfacing as the roads in this estate have deteriorated considerably.'

(Proposer: Cllr. J. Kavanagh 17/146)

The report of the Director of Services stated that the road surface at Merrion Court will be assessed and considered for inclusion in a future resurfacing programme.

### 12.25 SIGNS ON THE N40 – BOTHAR CUMANN NA MBAN

An Chomhairle considered the report of the Director of Services, dated the 11<sup>th</sup> May 2017 on the following motion referred to the Committee by An Chomhairle:

'I am calling on Cork City Council to erect signs informing road users entering the N40 South Ring Road that the name of this road has been changed to N40- Bothar Cumann Na mBan, as agreed by this Council at a Council meeting in early 2015, to commemorate the vital role of women in the struggle for independence. This omission is another example of women being treated as 2nd class citizens. The Council has shown further disrespect by making no effort to correct the media such as Cork 96 FM, Cork Red FM etc when they refer to the road by its former name.'

(Proposer: Cllr. M. Shields 16/313)

The report of the Director of Services stated that the South Ring Road is located within the functional areas of both Cork County Council and Cork City Council and as a National Road falls within the responsibility of Transport Infrastructure Ireland (previously the National Roads Authority).

While the purpose of the motion is understood in terms of commemorating Cumann na mBan, it would not be possible for the Council to erect signage or contact media outlets in relation to the use of N40- *Bóthar Cumann na mBan*. A change of name in the case of a National Road traversing two authorities requires the approval of the two Councils and should have the agreement of TII. The relevant statutory procedures (Local Government Act 1946 as amended) also require the local authorities to have the consent of not less than the majority of the qualified electors. For the purposes of this provision qualified electors means every person who in relation to the road is a registered local government elector or rated occupier (excluding full abatements).

The matter has been the subject of previous discussion by Cork City Council and Cork County Council. This includes this Councils previous support for renaming the road as *Bóthar Cumann na mBan*. In its communications with the National Roads Authority it is understood that Cork County Council was advised that the renaming of the road would be contrary to safety of use, strategic future proofing of signage, ease of wayfinding and National Policy. It is also understood that Cork County Council recently discussed a further motion on the matter and it decided to refer the issue to its Commemoration Committee for further consideration as to how Cumann na mBan might be best commemorated.

As agreed by the committee, the TII were written to in relation to the matter and enqueries were made to Cork County Council. The TII responded as follows:

Thank you for your letter of  $28^{th}$  March 2017 regarding the above. The position in relation to your enquiry is as follows.

At the outset, I wish to advise that TII has no statutory function in relation to the naming of roads. Notwithstanding this, TII does have an obligation to provide a safe and efficient network of national roads and it is considered that the renaming of the N40, as proposed, would not be compatible with this.

As mentioned in our previous correspondence of 16 March 2015, the N40 is a major significant and strategically important road in the Cork Area. You may be aware that when the route was reclassified from N25 to N40, an extensive re-signing project was undertaken and the route was designated as "N40 Cork Ring Road". This was to future-proof the signing strategy for when the full ring eventually is completed. The idea is that the sings will indicate, either N40 Cork Ring East/N40 Cork Ring West (as they currently do), or N40 Cork Ring North/N40 Cork Ring South, depending on the section of the ring road the motorist is on and the direction of travel. Renaming the road would potentially require a costly resigning exercise and would undermine our signage strategy for the whole ring road.

Policy for naming of roundabouts, as set out in the Department of Transport, Tourism and Sport's Traffic Signs Manual, states that "The naming of roundabouts is used in principle to assist in guiding and directing traffic. However the names used should bear some geographical significance such as Kinsale Road Roundabout or the Kilheffernan

roundabout outside Clonmel. The name should be of assistance in directing traffic to a destination with reference to a map or satellite navigation system. Putting random names which have no geographical significance or that don't relate to destinations on a map will be of little or no assistance in way-finding and would be counter-productive in that it spoils an opportunity to show more useful information." It is considered that the same principles would apply to the naming of strategic routes such as the N40.

In summary, TII would not be in favour of the renaming of the N40 Cork South Ring Road as proposed as it would interfere with out carefully planned signage strategy, would cause confusion to the motoring public and would not be compatible with national policy.

I hope that the above information clarifies the position for you.
