### 6.6 TRANSFER TO A VOLUNTARY HOUSING AGENCY PROPERTY

Is it possible for Council tenants who are overcrowded to apply for a transfer to a property managed by a Voluntary Housing Agency?

#### REPLY

Cork City Council has recently extended the Choice Based Letting (CBL) System to include suitable properties available for letting from Approved Housing Bodies (AHBs). The new facility on the website **cbl.corkcity.ie** will display the name of the Property Manager (either Cork City Council or the AHB). The AHB property listings will be in the same format as for Council properties, including a detailed description, photographs, and an interactive map showing the property location. It will also provide a link to the relevant Approved Housing Bodies' website so applicants can get further information if desired. The first property under the pilot of the new initiative was advertised in late October.

Any City Council tenant who has submitted a transfer request which has been approved is granted access to the CBL system, to allow them to submit bids on any advertised properties in the same manner as applicants on the housing waiting list.

## 6.7 OCCUPATIONAL THERAPISTS

Why are Occupational Therapists being sent to re-assess people with Autism and various other conditions of a similar nature which are lifelong medical conditions which we are aware from medical evidence, these conditions do not change over time?

Please explain why this practice is being done and the cost incurred with such?

#### REPLY

Cork City Council uses a panel of independent Occupational Therapists established by e-procurement procedures in 2016. The Occupational Therapists assess the applicant's medical needs and apply them to their current accommodation.

Applicants <u>occasionally</u> include (within their application) a report from a HSE Occupational Therapist or an Enable Ireland Occupational Therapist. The reports of Cork City Council's Occupational Therapists are used in these instances to complement the reports submitted with the application. The Cork City Council Occupational Therapist reports provide a more detailed picture of the property layout and potential for adaptation.

The cost of an Occupational Therapist report is €280 per visit.

## 6.8 **PROVISION OF SPEED RAMPS IN COOLGARTEN PARK**

In response to the following question submitted by Comhairleoir M. Shields, a written reply was circulated as outlined below:-

Provision of speed ramps in Coolgarten Park

- 1. Would it be possible to assess Coolgarten Park for the insertion of a suitable number of speed ramps to prevent motorists from speeding from Magazine Road to Glasheen Road and vice versa through Coolgarten Park particularly at morning and evening rush hours? Residents of the cul de sac off Coolgarten Park find it impossible to exit their area at peak times because of speeding motorists.
- 2. Could yellow lines be inserted at the junction (west side) of Magazine Road and Coolgarten Park? Motorists are parking right up to the corner and it is then difficult to exit on to Magazine Road if turning left.

#### REPLY

- 1. Coolgarten Park will be assessed to determine the extent of the problems that exist and in order to identify any possible mitigation measures that could be provided. Any traffic calming solutions that are identified will be put forward for the consideration of Elected Members in the context of the next traffic calming works programme.
- 2. Cork City Council will assess the road painting request for Coolgarten Park. If deemed appropriate it will be added to the ongoing painting programme and will be undertaken subject to suitable weather conditions in accordance with the available budget.

#### 6.9 TREE RE-PLANTING PROGRAMME

To ask about the number of trees removed as part of the ongoing City Centre Traffic Strategy and the reasons why?

#### REPLY

An annual provision of €100,000 was included in Parks Revenue Budgets for tree planting in the City up to 2011, this unfortunately was one of the many budgets removed at that time to assist with addressing the Council's difficult financial position due to the economic collapse. The Council has not been in a position to replace this budget to date.

An assessment of tree planting requirements will be carried out during 2018 to address the loss of trees caused by Storm Ophelia and, provision included in the 2019 Draft Estimates for consideration.

There are 7 trees to be removed as part of the City Centre Public Transport Improvement Scheme. It is necessary to remove the trees to facilitate the upgrading of public lighting and to enable the realignment of roadways and junctions

It is proposed to install 13 new trees in suitable locations across the Middle Parish as part of the scheme.

## 6.10 PUBLIC LIGHTING ON ST. PATRICK'S STREET AND ST. PATRICK'S BRIDGE

Can the City Manager please confirm the up to date position in relation to the refurbishment of Public Lighting on St Patrick's Street and St Patrick's Bridge. When are works on St Patrick's Bridge due to commemce, finish and can Councilors please be furnished with a copy of the Tender brief issued in relation to the renewal of Public Lighting on St Patrick's Bridge.

## **REPLY**

The improvements to lighting on St. Patrick's Street are being undertaken on foot of the Council's normal maintenance contract with SSE Airtricity. In the first instance the electrical supply circuits are being upgraded to cater for better protection and to provide separate dedicated circuits to cater for festive lighting. The access to the customer service pillars has been improved and will be controlled to comply with electrical safety management. The lanterns on both the Pitman & Sarah type columns are being up graded over the period of the maintenance contract to incorporate LED lamps and electronic control gear delivering energy reductions in line with City Council policy.

The rehabilitation of St. Patrick's Bridge has been divided into two phases; the advance works contract, which is currently at tender evaluation phase, includes for the removal of the existing heritage lighting columns on the bridge parapets, transporting them for repair and replication and returning them complete and ready to be installed in the next phase of works. There are currently four lighting columns on the bridge with a further four in storage. The proposed contract includes for the restoration of these existing heritage lighting columns and their replication to provide 14 columns and lanterns. 12 as per the original layout with the remaining 2 to remain in storage for use in the event of loss or damage. It is expected that this element of the works will commence in early to mid December and be completed by June 2018.

The second phase of works, currently at detailed design phase, will consist of the remaining remedial works to the bridge and is expected to commence on site in April/May 2018, subject to funding allocation.

The successful tenderer will be required to carefully remove the existing 4 columns on the bridge and send these plus the additional 4 in storage to be repaired/restored in accordance with the specification. Upon completion, the 14 repaired/replicated standards will sent to a designated storage facility where they will be installed by a third party at a later date. The successful tenderer will be required to deliver the standards fully assembled, complete with new lanterns and lighting heads.

Overhangs (including balconies)

Any structure (including balconies) having an overhang in excess of 600mm will have the entire area under the overhang included in the area used to calculate the contribution
