Cork City Council has received bids to carry out Deep Energy Retrofit works including upgrading the building fabric at the following apartment addresses:

261-279 Connolly Road – 12 units 62-78 Killeenreendowney – 9 units 14-24 Edward Walsh Road – 6 Units 25-41 Edward Walsh Road – 9 units 64-84 Edward Walsh Road – 12 units 241-246 Pouladuff Road – 6 units 15-29 Connolly Green – 9 units
48-74 Fr. Dominic Road – 9 units
11-19 Pearse Road – 9 units
48-53 Fr. O'Flynn Place – 12 units
1-6 Bro. Rice Avenue – 6 units

The works to be carried out includes:

a. External Wall insulation – 100mm depthb. Window upgrades to triple glazing where required.c. Installation of heat pump

The total cost of the works listed above is €.2m.

The Council has applied to the DHPLG for funding and is awaiting an allocation prior to commencing the works.

This work will be 50% funded by the National Governments Department of Finance and 50% funded by the EU through the Southern Assemblies Regional Operational Program 2014-2020.

It is hoped that additional funding will be made available from the DHPLG through the Regional Operational Program to enable works to be carried out to additional apartment blocks in the city.

That in view for the proposed referendum in May/June and the proliferation of posters re: same can the CE outline what measures the Council will take to 1. highlight the rules governing the erection of posters in the city and 2. mechanisms of dealing with unauthorized posters that have been erected.

## REPLY

Cork City Council at its meeting held on the 22<sup>nd</sup> June 2015 approved a protocol for the erection of temporary meeting, event posters on its property under Section 19 of the Litter Pollution Acts 1997 to 2002. The protocol came into force with effect from1st August 2015.

The protocol is designed to control the number of poster erected across the city and sets out the do's and don'ts and safety guidelines to be followed while erecting posters.

Postering is monitored by the Litter Management Section and in general there is a high degree of compliance with the postering protocol. Unauthorised posters are removed by the Litter Wardens as soon as is practicable as resources allow and Litter fines are issued where appropriate.

I will arrange for the protocol to be published and retained on the home page of the of the City Council's website for a period of time to highlight the proper procedures in relation to the erection of temporary posters.

### 6.8 **RAW SEWAGE OVERFLOWS**

In response to the following question submitted by Comhairleoir T. Brosnan, a written reply was circulated as outlined below:-

Apart from the overflow at Crosses Green, can the CE please advise where there are other raw sewage overflows into (a) North Channel and (b) South Channel of the River Lee, what records are kept of incidences of sewage overflows into the River Lee and what plans do Cork City Council have to eliminate sewage outflows?

## REPLY

The only known sewage overflow to either the North or South Channels of the River Lee, within the Cork City agglomeration boundary, is from the St Patrick's Culvert, at St Patrick's Bridge, on account of a limited number of historic mis-connections, which were not resolved as part of the Cork Main Drainage project. To resolve this issue, Irish Water and Cork City Council has undertaken a study and survey works to identify these remaining mis-connections. The findings are now being incorporated into the broader Drainage Area Plan (DAP) study, currently underway by Irish Water, for the Cork City Agglomeration.

There are numerous Combined Sewer Overflows (CSOs), which overflow to the various rivers within the Cork City agglomeration during times of rainfall. However, these CSOs are registered on the Cork City Discharge License and overflow during rainfall is part of their intended operation.

In terms of recording sewage overflows (e.g. a pump station overflow or CSO overflow during dry weather), when such an event occurs, it is reported to the EPA via their EDEN

portal. The incident is then investigated by Cork City Council, and the findings reported to the EPA. The incident is then closed when it has been addressed and resolved to the satisfaction of the EPA.

In general sewage flows are avoided by a programme of routine inspection and maintenance to both pump stations and CSOs. Cork City Council has a dedicated outdoor operations crew solely responsible for the routine inspection and maintenance of CSOs. For the purposes of maintenance to pump stations, Cork City Council / IW employ the services of specialist contractors to carry out these works.

### 6.9 PLANNING APPLICATIONS OF OLD ODLUMS BUILDING

To ask the CE for an update on planning applications for the old Odlums Building in Docklands, and have any approaches been made to the owner regarding considering the future use of this historic building?

#### REPLY

The last planning application was TP 13/35859: Demolish and remove disused warehouses/stores, mill/silos, weightbridge and ancillary buildings on a site bounded by Kennedy's Quay, Mill Road, Marina Road & Furlong Street, South Docklands, Cork City. The buildings to be demolished are within the cartilage of the Odlums Building (protected structure ref. PS856), which along with an adjoining store to the west, will not be demolished and will be retained as part of this. This was granted permission and implemented.

Since then there has been no discussions with the owners, Origin Enterprises, regarding the property.

## 6.10 **PÁIRC UÍ CHAOIMH**

In response to the following question submitted by Comhairleoir T. Shannon, a written reply was circulated as outlined below:-

To ask the CE for an up- to- date report to Council on any discussions that are taking place between the management of Páirc Uí Chaoimh and officials of Cork City Council regarding the outstanding conditions of planning for the redevelopment of the Stadium, which to date have not been implemented, in particular the public lighting on the roads and walkways surrounding the Stadium. Have these discussions included the forthcoming Ed Sheeran Concert due to take place in May and any concerns expressed by City Council officials to the management of the Stadium and the concert promoter regarding any public safety/health concerns about the surrounding public realm.

## REPLY

Discussions are underway with the Cork GAA in relation to some outstanding conditions in relation to the planning permission granted for the redevelopment of Páirc Uí Chaoimh. The major unresolved issue relates to the contribution expected from the GAA to the public lighting of approaches to the stadium. However, at present, the degree of noncompliance does not necessitate issuing enforcement proceedings and both sides are endeavouring to resolve the issues still outstanding.

The Ed Sheeran Concerts will be dealt with by a separate process, the granting of an Event Licence. This is a separate process to the planning permission. Cork City Council stated at the Oral Hearing into the redevelopment of Páirc Uí Chaoimh that events such as concerts would be deal with under the Event Licence process. The application for an Event Licence is being considered at present. The applicant is Aiken Promotions. If the Event Licence is granted, Aiken Promotions will be responsible for staging the concerts. The Event Licence, if granted, will contain conditions that address any public safety concerns in relation to the concerts.

On the proposal of Comhairleoir M. Finn, seconded by Comhairleoir T. Moloney, An Chomhairle considered and approved the report of the Director of Services, Corporate and External Affairs dated 1<sup>st</sup> March 2018 on Funding Agreement between Fáilte Ireland and Local Authorities for Regional Festivals and Participative Events 2018.

### 8.4 MOTIONS

### 8.4.1 **FUTURE ARTS PLANS**

An Chomhairle considered and approved the report of the Director of Services dated 28<sup>th</sup> February 2018 on the following Motion referred to the Committee by An Chomhairle:-

'That Cork City Council's future Arts Plan be compiled and published.'

#### (Proposer: Cllr. K. McCarthy 18/019)

The report of the Director of Services stated that the current plan from 2011-2015 has been extended to 2017. The Council should be aware that the Arts Office prepares annual Operational Plans in line with the Corporate Plan and the Arts Plan and updates the Arts Committee and Functional Committee of same regularly throughout the year.

In my consideration the main aims and objectives of the plan continue to be relevant. With a broadening city council area, and the redevelopment of the Corporate Plan from 2019 onwards I recommend extending the current plan until 2019 so that all planning processes can move forward together. I further recommend that the Arts Committee undertake a status report on the existing plan to be brought to this committee in Quarter 4, with a view towards informing the development of the next plan in 2019.

#### 8.4.2 LIBRARY SERVICE IN MAHON/BLACKROCK AREA

An Chomhairle considered and approved the report of the Director of Services dated 28<sup>th</sup> February 2018 on the following Motion referred to the Committee by An Chomhairle:-

'That Cork City Council commits to the delivery and time scale for the development of a local library service in Mahon/Blackrock area (South East Ward) at the site of the old HSE Medical Centre at Lakelands.'

## (Proposer: Cllr. C. O'Leary 18/053)

The report of the Director of Services stated that the former Health Centre at Lakeland's Crescent, Mahon is not in the ownership of Cork City Council. Discussions in relation to this property have been ongoing with the Health Services Executive, but have not been

finally concluded. Until such time as the transfer of the property is concluded, the City Council cannot proceed to develop detailed proposals in relation to potential future uses. In relation to the use of the building and site for the local library service in the Mahon/Blackrock Area all available sites and building options will be explored but the development of a branch library will be dependent on the necessary capital funding programme being available.

## 8.4.3 **FUNDING FOR A NATIONAL MARITIME CENTRE IN THE DOCKLANDS**

An Chomhairle considered and approved the report of the Director of Services dated 5<sup>th</sup> March 2018 on the following Motion referred to the Committee by An Chomhairle:-

'Mindful of the fact that Fáilte Ireland has highlighted the lack of a major 'must-see' attraction in Cork City, that the City Council immediately puts in motion a plan to develop and secure funding for a National Maritime Centre in the Docklands that will relate and enliven Ireland's rich maritime story with active linkages (to include sailings, rail or road) to centres in Cobh and Spike Island and other sites associated with that history and to include the history of transportation to Britain, the US, Australia and the world during the Famine Years as well as the unique ties with the Titanic and Lusitania.'

(Proposer: Cllr. M. Finn 18/056)

The report of the Director of Services stated that Members of the City Council and Senior Management Team attended at workshops recently with representatives from Fáilte Ireland. The workshops highlighted the potential for the creation in Cork City of an iconic tourist attraction of scale.

It is certainly appreciated that the maritime credentials and assets of Cork represent an opportunity for the creation of a new visitor attraction of scale. The City Council has committed to continue to work with Fáilte Ireland to develop a plan for the creation of a new attraction with the ability to create a high number of visitors. Further reports will issue to Members as this process progresses.

On the proposal Comhairleoir D. Cahill, seconded by Comhairleoir M. Finn it was further agreed that the development of a "must see" attraction be a constant item to the Tourism, Arts & Culture Functional Committee meeting agendas.

## 8.4.4 FLEADH CEOL NA hÉIREANN

An Chomhairle considered and approved the report of the Director of Services dated 28<sup>th</sup> February 2018 on the following Motion referred to the Committee by An Chomhairle:-
