A study is presently underway to review finished ground levels for the South Docks, details design for Kennedy Park will commence on the completion of this review and will include full consultation with residents and all stake holders.

Both of these properties have been on the Derelict Sites Register since 2017. Issues of health and safety are matters for the property owners. In relation to St. Kevin's, Cork City Council is actively facilitating the development of the site. There are no plans to prepare a local area plan. The absence of a local area plan is not inhibiting the redevelopment of these properties.

- g. Is CE aware of any dangers to fire services in dealing with such chemicals?
- h. Has there been a chemical and environmental inspection of the site?

#### REPLY

While it is obvious that the passengers from visiting cruise liners are visible in their numbers in the city centre it is impossible to quantify their top five chosen destinations.

A percentage of passengers book on shore tours in advance via their travel agents or contractors recommended by Port of Cork. Cruise passengers are provided with a Top Attractions brochure by the Cruise Ambassadors which highlights the 16 attractions in the City.

Eighty Six cruise shops will have been boarded by Cruise Ambassadors in Cork in 2018 averaging 2,000 passengers each.

Feedback from the attractions and the traders to date has indicated an increase in footfall in visitors for 2018.

94 Rebuilding Ireland Home Loan Applications have been received by Cork City Council for the period 01/02/2018 to 29/08/2018.

7 Approvals from Cork City Council have issued to Applicants.

56 refusals have been notified to Applicants.

Notification of Decisions will issue to 28 applicants in September.

3 Files were returned to applicants because of missing documentation or non qualification.

There is an approximate waiting time of 10 weeks from the time of application to a provisional approval or refusal.

## 7.7 <u>COUNCIL HOUSING DEVELOPMENT IN GERALD GRIFFIN ST.</u>

In response to the following question submitted by Comhairleoir J. Sheehan, a written reply was circulated as outlined below:-

Can the CE update the Council on the progress in relation to the Council housing development in Gerald Griffin St. Ground works appear to have being completed but further construction on the development appears to have stopped.

## REPLY

The Council completed substantial deep underground civic engineering enabling works to facilitate the housing development at Gerald Griffin Street. These works were extensive and complex and comprised mainly of a major diversion of the main trunk sewer serving the Northside of the City which involves structural piling and permanent diversion of utility services. The enabling works were a necessary and complex major stage in the building project and diversions/substructures were essential to facilitate the final main building contract and de-risk it commercially. As a result of progress made in this Phase 1 and the modified underground formation, the main contract drawings and documentation

needed to be designed and updated accordingly by the City Architects Department. The Council expects to be inviting tenders for the main building contract in October with a view to commencing construction in late 2018 and provisional funding has already been approved by the Department of Housing, Planning & Local Government. Substantial progress has actually been made and infrastructure installed which will now save time and potential delays downstream on the project.

#### 7.8 COMPULSORY PURCHASE OF THE FORMER OFFICERS HOUSES

In response to the following question submitted by Comhairleoir T. Brosnan, a written reply was circulated as outlined below:-

Can the CE please proceed to the Compulsory purchase of the former Officers Houses (9 in all) to help meet the demand for housing citizens. Senior Officials in the Dept of Defence have wastefully allowed these houses decline to a disgraceful condition. Alternatively, can City Council acquire the houses under the Derelict Sites legislation?

#### REPLY

Cork City Council's Housing Directorate has engaged with the Military Authorities in Collins Barracks and the Department of Defence with regard to the nine vacant houses and surrounding lands at the Camp Field, Old Youghal Road. The Council has been advised that following an examination of their future requirements/proposed use of the Camp Field going forward, the Military Authorities have identified a need for the retention of that portion of the camp field for use by the Defence Forces. This includes the location of eight vacant semi-detached houses.

They have however, identified an alternative site in the Camp Field, the former General Officer Commanding (GOC's) house and garden, which has development potential. It was agreed that Cork City Council would prepare a feasibility study for the location of housing at this location in order to inform further discussions with the Department of Defence and the Military Authorities at Collins Barracks.

## REPLY

There are no planning guidelines or regulations regarding the leasing or renting of private parking spaces attached to private residential properties. The lease or renting of such spaces, depending on the particular circumstances, may constitute a material change of use and may require planning permission.

The controls, powers and responsibilities that Cork City Council has to regulate these matters, if planning permission is required, is set out under Part VIII of the Planning and Development Act, 2000 as amended which relates to enforcement.

The Strategic Planning and Economic Directorate has no information regarding the extent of this practice in Cork. Matters relating to Revenue and tax are beyond the scope of the planning code.

## Note 3: SUSPENSION OF STANDING ORDERS (Ref:- Note 2 on Page 3)

## 10.8.1 **TANK FIELD**

Comhairleoir J. Kavanagh informed An Chomhairle that he wished to withdraw the following Motion, and leave was given for him to do so.

'In view of the fact that the officials did not forward my Motion 16.12 (as listed on Agenda of May 28<sup>th</sup>) in relation to the Tank Field to the Planning Functional Committee, as they were directed to do by the Council at its meeting of 28<sup>th</sup> May 2018, and in view of the consequences of this action, that has not enabled the Planning Functional Committee to consider the issue, the Council hereby directs the Chief Executive Officer, under Section 47 of the Local Government Reform Act 2014, to formally notify, if possible, by an appropriate legal notice, the Department of Education and Skills and instruct them to desist from taking any actions that may restrict in any way the options open to Cork City Council in relation to the future of the Tank Field, until the Cork City Council has considered the issue fully in the Planning Functional Committee and, furthermore, in particular, it directs the Chief Executive to cease all proposed developments on the Tank Field until a final decision on Motion 16.12 is agreed.'

## 10.8.2 DISPOSAL OF LANDS IN THE TANK FIELD

An Chomhairle considered the report of the Director of Services, Strategic Planning, Economic Development and Enterprise dated 3<sup>rd</sup> September 2018 on the following Motion referred to the Committee by An Chomhairle:-

'That Cork City Council clarify that decisions in relation to the disposal of lands in the Tank Field, recently activated, were made on the basis of materially incorrect and incomplete information during both the disposal and associated Part 8 process. That Cork City Council further clarify that this disposal purported to dispose of lands that the City Council didn't actually own at the time of disposal.

It is noted that the disposal report and associated map, presented to the Council as a basis for their decision, stated that the lands in question were acquired by Order of the County Registrar by means of Conveyance dated 9<sup>th</sup> October 2001, when in fact, this was not strictly the case, as illustrated below.

- Councillors were not told that (i) a significant portion of the lands were not included in the County Registrar's order, and (ii) also importantly, they were not told that this land formed part of the statutory 10% green area of Mayfield Heights housing estate (located across the road from The Tank Field).
- Furthermore, it should be noted that members were informed that Council retrospectively claimed ownership of this 10% green area by means of Possessory Title (Squatters Rights), even though it subsequently was acknowledged that no such Possessory Title had been registered, as is required by law.
- It is also an issue of concern that the information contained in the subsequent Part 8 Certification which stated that the development does not contravene the Development Plan for the City of Cork, despite the fact that it was proposing to utilise a significant area in a manner not in accordance with its Public Amenity Zoning.

In view of the above, can I propose that Cork City Council resolves to seek independent legal advice into the validity of the aforementioned Disposal Order, and the associated Part 8, and that in the meantime, no further development be undertaken on the Tank Field until such time as this issue is clarified and resolved.'

#### (Proposer: Cllr. J. Kavanagh 18/186)

"The report of the Director of Services stated that at the time of approval of the relevant disposal notices by Council to the Department of Education and Brian Dillons Hurling and Football Club in March and October of 2005 respectively and at the time of the Part VIII Planning in February 2006 Cork City Council was the owner of the lands at the Tank Field. The greater part of the Tank Field was then and is held by Cork City Council in fee simple under and by virtue of a Deed of Conveyance dated the 9<sup>th</sup> of October 2001, made between The Unknown and The Unascertained Owner of the Fee Simple and other Intermediate Interest(s) (if any), the Chief Clerk of the Circuit Court of the one part and The Lord Mayor Aldermen and Burgesses of Cork of the other part.

As advised by the Law Agent the area of land alleged to have been in the ownership of the property company that developed the Mayfield Heights housing estate was at the time of the Disposal Notices held in possessory title by Cork City Council for over 40 years. Cork City Council had been in possession and occupation of the lands since the mid to late

1960's. This land was subsequently the subject of the Iona Road – Murmont Road Compulsory Acquisition Order No. 1 of 2013 ("Order No. 1") measuring an area approx. 3456sqm or 0.85 acres. The purpose of Order No. 1 was to improve Cork City Council's existing title by acquiring a freehold interest in the subject lands.

While the CPO was objected to and the matter duly referred to An Bord Pleanala for determination the Council was informed by the Board on the 18<sup>th</sup> July 2013 that "... The Board hereby informs you that it has received no valid objections to this compulsory purchase order within the period provided for making objections and it is now open to you to confirm/refuse to confirm the order..." The Board upheld the Council's view that no valid objections were made as the objections were not made by owners, lessees or occupiers of the Compulsory Purchase Order lands, i.e. entitles that constitute a category of person upon whom such a notice is to be served. Cork City Council therefore pursuant to its powers in that behalf duly confirmed the CPO.

At the time of approval of the Part VIII Planning in February 2006 Cork City Council was the owner of the lands at the Tank Field. As such the consent or otherwise of other parties was not required to advance the Part VIII process and seek Council approval for same. In preparing the original Part VIII Planning the City Council relied on drawings submitted by qualified and experienced consultants acting for Brian Dillon's Hurling and Football Club who were and continue to use the Tankfield as a local sports and community facility. It is not uncommon for lands zoned Public Open Space in the City to incorporate public sports facilities and grounds across the city and as such no material contravention of the existing City Development Plan occurred.

I am satisfied that the lands in question were within City Council ownership and control allowing the relevant disposal notices and Part VIII to be prepared and brought before Council for approval. As such the necessary legislative procedures were carried out validly and appropriately and so no further legal advice is required. The relevant lands have been disposed of to both the Club and the Department of Education as provided for in the referenced Disposal Notices."

Following a debate and on the proposal of Comhairleoir J. Kavanagh, seconded by Comhairleoir J. Buttimer, An Chomhairle agreed to delete all words after "Part 8" in the final paragraph of the Motion.

An Chomhairle approved the amended Motion to read as follows:-

'That Cork City Council clarify that decisions in relation to the disposal of lands in the Tank Field, recently activated, were made on the basis of materially incorrect and incomplete information during both the disposal and associated Part 8 process. That Cork City Council further clarify that this disposal purported to dispose of lands that the City Council didn't actually own at the time of disposal.

It is noted that the disposal report and associated map, presented to the Council as a basis for their decision, stated that the lands in question were acquired by Order of the County Registrar by means of Conveyance dated 9<sup>th</sup> October 2001, when in fact, this was not strictly the case, as illustrated below.

• Councillors were not told that (i) a significant portion of the lands were not included in the County Registrar's order, and (ii) also importantly, they were not told that this land

formed part of the statutory 10% green area of Mayfield Heights housing estate (located across the road from The Tank Field).

- Furthermore, it should be noted that members were informed that Council retrospectively claimed ownership of this 10% green area by means of Possessory Title (Squatters Rights), even though it subsequently was acknowledged that no such Possessory Title had been registered, as is required by law.
- It is also an issue of concern that the information contained in the subsequent Part 8 Certification which stated that the development does not contravene the Development Plan for the City of Cork, despite the fact that it was proposing to utilise a significant area in a manner not in accordance with its Public Amenity Zoning.

In view of the above, can I propose that Cork City Council resolves to seek independent legal advice into the validity of the aforementioned Disposal Order, and the associated Part 8.'

(Proposer: Cllr. J. Kavanagh 18/186)

An Chomhairle considered and approved the report of the Director of Services, Environment & Recreation dated 30<sup>th</sup> August 2018 on Bonfire Night.

## 9.2 BALLYPHEHANE GAA CLUB

An Chomhairle considered and approved the report of the Director of Services, Environment & Recreation dated 30<sup>th</sup> August 2018 on the Ballyphehane GAA Club.

#### 9.3 COMMUNITY MAINTENANCE GRANTS SCHEME 2018

On the proposal of Comhairleoir J. Buttimer, seconded by Comhairleoir K. O'Flynn, An Chomhairle considered and approved the report of the Director of Services, Environment & Recreation dated 30<sup>th</sup> August 2018 on the Community Maintenance Grants Scheme 2018.

#### 9.4 **<u>REMOVE SHARP NEEDLE BIN FROM THE STEPS OFFWELLINGTON ROAD</u>**

An Chomhairle considered the report of the Director of Services, Environment & Recreation dated 30<sup>th</sup> August 2018 on the following Motion referred to the Committee by An Chomhairle:-

'That Cork City Council in conjunction with the HSE immediately remove the sharps needles bin which has been located on the steps off Wellington Road for the past year. Local Residents are becoming increasingly concerned at the location of this bin and are adamant that it be moved immediately.'

#### (Proposer: Cllr. J. Kavanagh 17/308)

The Report of the Director of Services stated that the City-wide initiative to provide sharps-specific bins is delivered in partnership with the HSE. As such, we have a significant interest in addressing public concern with regard to litter and hazardous waste arising from drug use. This initiative revolves around an evidence-based dataset generated between Cork City Council and the HSE, and a network of sharps-specific bins has been deployed in locations identified from the above information where chronic litter of this nature in established. Upon role out of the bin infrastructure for sharps, a significant drop in litter associated with drug misuse has been noted at these locations; and bins are being used. The HSE services these bins and maintain a record of use of bins with a view to optimising deployment of bin resource. Recent correspondence with the HSE indicates that this bin in the Wellington Road area should remain in situ.

An Chomhairle agreed to refer this Report back for further consideration to the Environment and Recreation Functional Committee.

## 9.5 AIR QUALITY MONITORING ACROSS THE CITY

An Chomhairle considered and approved the report of the Director of Services, Environment & Recreation on the following Motion referred to the Committee by An Chomhairle:- 'Following the recent air quality monitoring undertaken by the Centre for Research into Atmospheric Chemistry (CRAC) in St. Patrick's Street and surrounding streets in conjunction with 96FM and the disturbing figures revealed therein, that Cork City Council would institute regular air quality monitoring across the city. These should include measurement of particulates as well as Nitrogen Dioxide (NO<sub>2</sub>) and Ozone. This should be done using a combination of fixed permanent monitoring stations at key locations and regular spot checks using portable air monitoring equipment at points around the city as required.'

(Proposer: Cllr. T. Tynan 18/158)

The report of the Director of Services dated 30<sup>th</sup> August 2018 stated that Cork City Council currently has two air monitoring stations, one at the Kinsale Road Civic Amenity Site and the second located in Bishopstown. As part of the 'SMART Cities' initiative, Cork City Council recently started a pilot project to trial additional air monitoring devices in the City Centre. The results from this trial are now being reviewed. Following this analysis, recommendations on how best to proceed with the possible development of an air quality monitoring programme will be made.

## 9.6 AIR QUALITY SURVEY IN MAYFIELD AREA

An Chomhairle considered and approved the report of the Director of Services, Environment & Recreation on the following Motion referred to the Committee by An Chomhairle:-

'In light of heavy diesel powered goods vehicles travelling from Silver spring's Hotel through to Ballyvolane Service Station, including in particular the Tinker's Cross Mayfield Shopping Centre area, that Cork City Council would employ the services of the Centre for Research into Atmospheric Chemistry (CRAC) to carry out an air quality survey in the area. Surveys to be carried out at peak traffic times on a similar basis to the survey recently carried out in St. Patrick's Street and surrounding streets by CRAC under the auspices of 96FM.'

(Proposer: Cllr. T. Tynan 18/157)

The report of the Director of Services dated 30<sup>th</sup> August 2018 stated that as part of the 'SMART Cities' initiative, Cork City Council recently started a pilot project to trial additional air monitoring devices in the City Centre. The results from this trial are now being reviewed. Following this analysis, recommendations on how best to proceed with the possible development of an air quality monitoring programme will be made. Cork City Council may consider moving one or both of these additional air monitoring devices from the City Centre to alternative locations, such as the Mayfield area. Employing the services of an organisation such as CRAC have budgetary and management implications which have not been factored into 2018.

## 9.7 AIR QUALITY MONITORS IN THE CITY CENTRE

An Chomhairle considered and approved the report of the Director of Services, Environment & Recreation on the following Motion referred to the Committee by An Chomhairle:- 'That the Council install air quality monitors in the City Centre.'

(Proposer: Cllr. K. McCarthy 18/172)

The report of the Director of Services dated 30<sup>th</sup> August 2018 stated that Cork City Council currently has two air monitoring stations, one at the Kinsale Road Civic Amenity Site and the second located in Bishopstown. As part of the 'SMART Cities' initiative, Cork City Council recently started a pilot project to trial additional air monitoring devices in the City Centre (McCurtain Street). The results from the trial are now being reviewed. Following this analysis, recommendations on how best to proceed with the possible development of an air quality monitoring programme will be made.

9.8 An Chomhairle considered and approved the report of the Director of Services, Environment & Recreation on the following Motions referred to the Committee by An Chomhairle:-

#### 9.8.1 **<u>REPORT ON THE FISH KILL AT THE LOUGH</u>**

'That Cork City Council would as soon as is practicable publish a full and comprehensive report on the recent fish kill at the Lough and going forward would make quarterly reports to the Environment Functional Committee on monitoring of the Lough.'

(Proposer: Cllr. J. Buttimer 18/179)

## 9.8.2 **<u>RESTORE WATER QUALITY IN THE LOUGH</u>**

'That Cork City Council seek funding to take necessary measures to clean out the Lough and restore water quality at a time when fish stocks have been seriously depleted and again consider the location of proper fountains throughout the lake as aerating measures.'

(Proposer: Cllr. M. Finn 18/182)

The report of the Director of Services dated  $30^{\text{th}}$  August 2018 stated that a full report on the outbreak of Carp Edema Virus at the Lough was presented to the last Functional Meeting of  $5^{\text{th}}$  June, together with a copy of the specialist fish veterinary report – copy attached. The most likely cause of the disease outbreak at the Lough was the use of infected fishing equipment.

Since early May, no further fish kills have been reported at the lake. On the recommendations of Inland Fisheries Ireland, no fishing has been allowed, with signage erected around the path perimeter. IFI are anxious that the ban on fishing continue to minimise the risk of the disease being carried to other waters. Similarly, IFI are not in favour of any short term re-stocking due to risks to other local waters and the Fish Vet report also indicated this would be high risk measure.

Further testing on the remaining fish stock will be carried out by the Marine Institute. Contact has been made with the UCC Zoology Department regarding a complete ecological assessment of the lake.

The Parks Department carries out texting of the water from six different points twice a week and the water quality is good. A further two water jets were installed in June near the

Slipway to further aerate the water during hot weather. Barley straw has been placed around the perimeter of the island in recent years each April, the decaying straw releasing toxins which help prevent algae bloom. The straw is removed each September.

A quarterly Report on the Lough would be provided to the Committee as requested.

## 9.9 <u>OVERGROWN EMBANKMENTS AT MOUNT ST. JOSEPH'S AVENUE AND</u> DRIVE

An Chomhairle considered and approved the report of the Director of Services, Environment & Recreation on the following Motion referred to the Committee by An Chomhairle:-

'That Cork City Council will tend to overgrown embankments at Mount St. Joseph's Avenue & Drive, Bakers Hill.'

(Proposer: Cllr. M. Nugent 18/193)

The report of the Director of Services dated 30<sup>th</sup> August 2018 stated that the overgrowth onto Mount St. Joseph's Avenue & Drive was cut back during the past week.

## 9.10 PUBLIC LIGHTING SCHEME IN KENNEDY PARK, VICTORIA ROAD

An Chomhairle considered and approved the report of the Director of Services, Environment & Recreation on the following Motion referred to the Committee by An Chomhairle:-

'That Cork City Council would allocate sufficient funds in the 2019 Budget to install a Public Lighting Scheme in Kennedy Park on Victoria Road.'

(Proposer: Cllr. T. Shannon 18/099)

The report of the Director of Services dated 30<sup>th</sup> August 2018 stated that City Council has approved funding under the Housing Local Infrastructure Activation Fund for a landscape enhancement scheme for Kennedy Park and Monahan Road which will include the installation of public lighting. A study is presently underway to review finished ground levels for the South Docks, detail design for Kennedy Park will commence on the completion of this review.

## 9.11 **<u>REMOVAL OF TREES OUTSIDE 30 AVENUE DE RENNES</u>**

An Chomhairle considered and approved the report of the Director of Services, Environment & Recreation on the following Motion referred to the Committee by An Chomhairle:-

'That Cork City Council commits to the removal of two trees outside number 30 Avenue De Rennes which are of concern to the resident on a number of fronts including the over grown, blocking out of day light in the front of the property, damage to property from the encroaching roots, recent storms has given rise to health and safety issues.'

(Proposer: Cllr. C. O'Leary 18/163)

The report of the Director of Services dated 30<sup>th</sup> August 2018 stated that the Hornbeam trees at Avenue De Renne were planted at the request of residents approximately fifteen years ago and add to the visual appeal and attractiveness of the avenue. In the context removal is not appropriate, however, remedial pruning will be carried out to address the above concerns.

An Chomhairle further agreed that V. O'Sullivan, Director of Services and Comhairleoir C. O'Leary would arrange to meet on site, at a mutually agreeable date and time.

## 9.12 INSTALL FLOWER BEDS AT AUDLEY PLACE, OUR LADY'S WELL

An Chomhairle considered and approved the report of the Director of Services, Environment & Recreation on the following Motion referred to the Committee by An Chomhairle:-

'That the Council install flower beds at Audley Place, Our Lady's Well and clean up the dumped rubbish on the Fever Hospital Steps ultimately making the space more of a tourist and community quarter.'

(Proposer: Cllr. K. McCarthy 18/171)

The report of the Director of Services dated 30<sup>th</sup> August 2018 stated that litter and dumped rubbish is collected at Audley Place, Fever Hospital Steps and Lady's Well as part of the scheduled collection in that area and, on other occasions as required. Seasonal floral planting will be considered in line with available resources.

#### 9.13 ENVIRONMENT GROUP IN KNOCKNAHEENY/HOLLYHILL

An Chomhairle considered and approved the report of the Director of Services, Environment & Recreation on the following Motion referred to the Committee by An Chomhairle:-

'That Cork City Council assist in the setting up of an Environmental group in Knocknaheeny/Hollyhill similar to the group in Farranree.'

(Proposer: Cllr. M. Nugent 18/175)

The report of the Director of Services dated 30<sup>th</sup> August 2018 stated that the Environment & Recreation Directorate will provide any necessary assistance and advice to the community to help enable them to establish an Environmental Group.

#### 9.14 CLOSURE OF LANE BETWEEN PARK COURT AND MEELICK PARK

An Chomhairle considered and approved the report of the Director of Services, Environment & Recreation on the following Motion referred to the Committee by An Chomhairle:-

'That Cork City Council would arrange for the Closure of the Laneway between Park Court & Meelick Park as this has led to anti-social behaviour in the area. This motion is brought on foot of a petition and consultation with Local residents in the area and with the Gardaí.'

(Proposer: Cllr. K. O'Flynn 18/166)

The report of the Director of Services dated 30<sup>th</sup> August 2018 stated that it was agreed by Ward Members that consideration of requests for lane closures in the Meelick Park area would be considered by Ward Members in the first instance.

A Ward Meeting will be arranged shortly at which the matter will be raised.

## 9.15 STREET CLEANSING SCHEDULE

An Chomhairle considered and approved the report of the Director of Services, Environment & Recreation on the following Motion referred to the Committee by An Chomhairle:-

'That Cork City Council draw up an immediate street cleansing schedule apart from standard sweeping in order to ensure the City streets do not continue in their current manky condition and that mechanised cleansing machines be used.'

(Proposer: Cllr. T. Brosnan 18/229)

The report of the Director of Services dated 30<sup>th</sup> August 2018 stated that Cork City Council have had to 'stand down' all the mechanised sweepers due to the current hosepipe ban (extended until end Oct 2018), and have re-assigned staff to other duties, including the City Centre rosters.

## 9.16 PLAYGROUND ON URSULINE CONVENT GROUNDS

An Chomhairle considered and approved the report of the Director of Services, Environment & Recreation on the following Motion referred to the Committee by An Chomhairle:-

'That the City Council re-commits to the concept of having a playground on the Ursuline Convent grounds, as proposed in the original plans for the Blackrock Pier Regeneration project.'

(Proposer: Cllr. K. McCarthy 18/121)

The report of the Director of Services dated 30<sup>th</sup> August 2018 stated the most suitable location for a state of the art playground to serve Blackrock, Ballintemple and the South Docklands is Marina Park. A site has been identified within the park, development of the playground is identified for Marina Park Phase 2. Phase 1 works are scheduled to commence in October. Detail design for phase 2 including the playground will commence when the necessary resources are available. City Council is committed to the enhancement of the Ursuline Convent Ground and will explore options to finance same under the Urban Regeneration Development Fund. City Council is still awaiting final transfer of the lands from the receiver of this development.

## 9.17 WORK TO BE CARRIED OUT ON CLASHDUV PARKS WALK WAY

An Chomhairle considered and approved the report of the Director of Services, Environment & Recreation on the following Motion referred to the Committee by An Chomhairle:-

'Considering the number of years Clashduv Park walk way has been left in such poor repair and the fact that funding has been secured out of the 2018 Capital Budget for works to be done in Autumn 2018. I request that these works be fast tracked and carried out within the next couple of weeks so as the community will be able to enjoy this facility fully in the summer months.'

(Proposer: Cllr. T. Moloney 18/181)

The report of the Director of Services dated 30<sup>th</sup> August 2018 stated that works have commenced on upgrading the paths at Clashduv Park and are scheduled for completion in January/February 2019.

#### 9.18 **PRUNE TREES ON WELLINGTON ROAD**

An Chomhairle considered and approved the report of the Director of Services, Environment & Recreation on the following Motion referred to the Committee by An Chomhairle:-

'That Cork City Council in the interest of Public Safety undertake immediate action to prune trees on Wellington Road as they are dangerously overgrown and seriously impede street lighting such as to endanger the safety of pedestrians and cyclists. The trees need to be trimmed back like those on Clashduv Estate.'

(Proposer: Cllr. T. Brosnan 18/198)

The report of the Director of Services dated 30<sup>th</sup> August 2018 stated that the above trees will be added to the schedule of tree works for remedial pruning. Any trees endangering the public will be attended to immediately.

## 9.19 FENCING AT ARDCULLEN ESTATE, HOLLYHILL

An Chomhairle considered and approved the report of the Director of Services, Environment & Recreation on the following Motion referred to the Committee by An Chomhairle:-

'That Cork City Council would replace fencing at the left side entrance to Ardcullen Estate, Hollyhill with well appointed bollards which could protect the green area. The green area could then be developed as an amenity linked to the area around the nearby reservoir, earmarked for development as amenity under the Regeneration Masterplan, by a pedestrian crossing.'

(Proposer: Cllr. M. Nugent 18/201)

The report of the Director of Services dated 30<sup>th</sup> August 2018 stated that an estimate for landscape enhancement works at Ardcullen Estate is included in the 2019 Draft Parks Capital Programme for consideration, the replacement of te fence with bollards will be considered should funding be secured.

'In view of the fact the San Francisco had recently erected a signpost listing their twinned cities and their distances, that Cork City Council would erect a similar signpost, in a prominent city location, giving the direction and distance to our twinned cities.'

#### (Proposer: Cllr. J. Sheehan 18/225)

The report of the Director of Services stated that the Corporate and External Affairs Directorate will be reviewing all existing twinning signage in conjunction with the revised boundary. This motion will be considered as part of this review.
