The widening and renewal of Skehard Road Phase 2 (Parkhill Estate to Church Rd Junction including the CSO Junction) will be substantially complete by the end of November. Twenty three semi mature trees will be planted in the coming planting season (November to March).

Construction of Skehard Road Phase 3 (the area between Church Rd Junction and the CSO Junction) is scheduled to commence in mid 2019. Land acquisition and detailed design for this phase is underway.

## 7.1 PEDESTRIAN BRIDGE FROM MERCHANTS QUAY TO HARLEY STREET

An Chomhairle considered and approved the report of G. O'Beirne, Director of Services, Roads and Transportation dated 1<sup>st</sup> October 2018 on the following Motion referred to the Group by An Chomhairle:-

'That in order to celebrate and claim Cork's prominent place in the international literary world that Cork City Councillors would name the new pedestrian bridge from Merchants Quay to Harley Street as Frank O'Connor Bridge and also that City Councillors would change the name of Shandon Bridge to Sean O'Faolain Bridge as both writers are internationally renowned Cork City natives.'

The report of the Director of Services stated that as Members will be aware the Council is constructing a new bridge for pedestrians and cyclists at Harleys Street. The bridge is being funded with support from the South East Regional Authority and the National Transport Authority. Construction work commenced in July 2018 it is expected to be completed in April 2019.

The new bridge is an important piece of infrastructure and it is appropriate that some consideration be given to its naming as well as the process by which this is to be

determined. In the past proposals for naming were usually moved through the Roads and Transportation Functional Committee. Any proposal put forward would be referred to the Councils Heritage Officer, City Archaeologist, Conservation Officer and the Local Studies Section of the Library Service for comment in the context of the history of the location and general area. The related report and recommendation was then brought before Party Whips in the first instance and, if agreed, then referred to the Functional Committee for consideration and the making of a recommendation to Council for final approval.

A number of suggestions have been made in recent months with regard to the naming process for the new bridge and in particular the issue of a public invitation for nominations. Members have agreed that such an approach is appropriate in this case and the process for determination and the role of Council Committees now needs to be considered and agreed.

In accordance with the view expressed at recent Whips Meetings the process could operate as follows-

- During quarter 4 2018, a public notice to issue inviting nominations. The
  nominations should be submitted in writing. Nominations should honour and
  celebrate an event or person or group/organisation of major significance that
  reflects positively on the City of Cork or its evolution or reflect significance that
  reflects positively on the City of Cork or its evolution or reflect significant local
  features/geographical location. Sample guidance attached for Members
  consideration. A minimum period of one month would be necessary for
  submissions.
- The Councils Heritage Officer, City Archaeologist, Conservation Officer and the Local Studies Section of the Library Service would be afforded an opportunity to review the nominations and comment where appropriate in the context of the history of the location and general area. Party Whips would then review the nominations and agree a shortlist of five or six following consultation with their representative groups. This could be done in one or more stages (depending on the number of nominations received).
  - Public notice would be issued of the final and any intermediary shortlist following agreements of Whips.
- Members of the public could be invited to comment on the final shortlist of names over a period of one to two months.
- The shortlisted names would be further considered by Whips after the consultation period and a final decision on the name made by Council. Members may wish to further consider the use of alternative selection processes for the making of the final decision.

If Council is happy to proceed on the basis outlined the initial notices inviting the submission of nominations would be placed in the coming weeks. I recommend that consideration be given to the foregoing together with the attached draft guidelines with a view agreement on the final process to be used for naming the new bridge.
