# 1. **RESURFACE HARRINGTON SQUARE**

'That Cork City Council resurface all of Harrington Square for health and safety reasons.

Currently there is hazardous condition of Harrington Square surface, which is uneven and poses a significant danger to the community.

It has come to my attention that the current condition of Harrington Square presents a genuine risk to the well-being of residents, visitors, and pedestrians alike. - 2. Following the assessment, the City Council should procure and install highly visible signage in the identified areas. The signage should clearly convey the message that Richmond Hill is not suitable for large trucks and provide alternative route suggestions suitable for arctic truck drivers.
- 3. Adequate funding and resources should be allocated to ensure the timely implementation of the signage installation. This investment will not only enhance the safety of road users but also contribute to the efficient flow of traffic in the area.

#### Conclusion:

To prevent further incidents of arctic trucks becoming stuck or causing traffic disruptions on Richmond Hill, it is essential to invest in appropriate signage. This motion seeks to prompt Cork City Council to take proactive measures and allocate the necessary resources to install highly visible signage that alerts arctic truck drivers to the unsuitability of Richmond Hill and offers alternative routes.

I kindly request that this motion be discussed and voted upon in the upcoming Council meeting to address the concerns of residents and improve the overall safety and functionality of our roadways.'

The club continues to support this building project in our community, and as part of this ongoing co-operation, in late 2019 in order to accommodate the ongoing construction, the entrance to Mayfield United's club grounds (Mayfield Park) was moved to join the entrance at the adjacent Dunard housing estate, which is a City Council housing development.

The combining of the football club entrance and the housing estate entrance means that an ever increasing and significant volume of traffic is using just one entrance point. This has subsequently resulted in major road damage with multiple potholes arising and causing dangerous conditions for both drivers and pedestrians who use this road.

In the short term, can these potholes be properly repaired until the entrance road to Mayfield United's pitches is fully resurfaced.'
