## 4. **QUESTION TIME**

# 4.1 GRAVEYARD IN CONTROL OF CITY COUNCIL

In response to the following question submitted by Comhairleoir K. O'Flynn, a written reply was circulated as outlined below:-

How many plots are in the pre extended Cork City area?

How many plots transferred from Cork City Council?

What provision going forward is City Council making for additional parts to service the needs of a city expected to double in size over the next 20 years?

## REPLY

As of the 30<sup>th</sup> April 2021, there are 1,711 plots available for purchase in the pre extended Cork City area. This includes 315 plots at St. Catherine's Cemetery, Kilcully and 1,396 plots at St. Michael's Cemetery, Blackrock.

A total of just under 1,950 plots, immediately available for sale, transferred from Cork County Council to Cork City Council on the date of the Boundary Extension. Of these, 1,848 remain available for sale as of the 30<sup>th</sup> April 2021.

Cork City Council are presently working on preparing a Part 8 Application for an extension to St. Catherine's Cemetery, Kilcully which will deliver approximately 3,500 additional plots in that specific cemetery.

In addition to this, a number of cemeteries in the Transition area (including for example St James and St. Senan's Cemeteries) can cater for additional future demand as they have significant expansion potential of up to 14,000 new plots which can be developed as and when required.

The option of an appropriate burial space for urns within existing cemeteries will be explored in the medium term which will also have an effect on the demand for new plots going forward.

As outlined above there is more than adequate provision across the City in existing graveyards to cater for burials needs going forward. It also must be borne in mind that annually burials comprise a mix of burials taking place in newly purchased plots as well as existing plots. Thus not every burial requires the purchase of a new plot, with many burials taking place in existing family plots e.g. in St. Michaels cemetery. All of these elements are factored into the determination that there is adequate provision of expansion potential to cater for the communities of the City going forward, even considering the projected 50% increase in population over the next 20 years.

#### 4.2 CULCLAN CONSTRUCTION

Can the CE confirm that Cork City Council gave permission to Culclan Construction Limited to gain access to its own property through Cork City Council land at Tannery Gardens/Cushing Road. This company cut and removed a lock and boundary fencing on Cork City Council property and then proceeded to cut down all the trees on its own property which I believe is illegal during nesting season

#### REPLY

With regard to the recent event as highlighted, this is currently being looked into further by the Housing Directorate with regard to the access and right of way issues raised.

A further report will be provided in due course on the matter by the Housing Directorate.

With regard to the complaint on removal of trees during nesting season, the enforcement of such matters is the responsibility of the National Parks and Wildlife Service.

#### 4.3 VACANT DWELLINGS

In response to the following question submitted by Comhairleoir M. Nugent, a written reply was circulated as outlined below:-

Can the CE report on how many vacant dwellings there are in the City Administrative Area including what resources are available to turn any of these into homes for people outlining progress been made in this regard?

# REPLY

There is a national website located at <u>www.vacanthomes.ie</u> which is administered by Mayo County Council. This is a central database that relies on members of the public to notify of a vacant property through its online complaint form. Those reports are then filtered through to Cork City Council, where the Vacant Homes Officer will seek to identify the owners, engage at an early stage with them, and provide them with information on the supports available to bring the property back into use. It can be difficult to comprehensively establish ownership or whether such properties are vacant or not. Some address referrals on the website also make it difficult to establish the correct location of the site, and properties remain unregistered on Land Direct and the Registry of Deeds. Also, a portion of the sites referred have been redeveloped and others are dealt with under the derelict sites process.

There are two main funding schemes available to an owner of a vacant property to bring it back into residential use in partnership with the Housing Directorate or an Approved Housing Body:

- Repair and Lease Scheme: this is intended for owners of vacant homes who cannot afford, or access, the finance required to bring properties up to the required standard for rental. Funding of up to a maximum of €60,000 is available to bring a property up to standard, in return for which the property must be made available for rent for social housing for a period of at least five years, with the funding being deducted from the rent over an agreed timeframe.
- Buy and Renew Scheme this is a companion to the Repair and Lease Scheme and provides the option for suitable properties to be purchased by the local authority or an Approved Housing Body. A particular focus of the scheme is older vacant homes to help tackle the problem of dereliction.

A total of 59 no. homes have been brought back into use through the above funding programmes since their inception – Cork City Council's Housing Directorate has successfully brought a total of 51 no. homes back into use under the Buy and Renew Scheme, the Repair and Lease Scheme has delivered 2 no. homes through Peter McVerry Trust in partnership with the local authority, and a further 6 no. homes have been delivered by the Approved Housing Body sector through the Capital Assistance Scheme (Buy and Renew).

Not all vacant homes are derelict sites. That said, there are currently 87 sites on the Derelict Sites Register, and so far this year 10 sites have been removed from the Register while 31 new files have been opened. Cork City Council is in the process of inspecting over 100 properties this year. We welcome continued engagement with the public in terms of derelict sites referrals and encourage informal engagement with owners of sites with a view to removing dereliction, and returning properties to active

use the City Council has commenced the CPO process on a number of sites currently on the Derelict Sites Register

#### 4.4 **DERELICT SITES**

In response to the following question submitted by Comhairleoir E. Ryng, a written reply was circulated as outlined below:-

Could the CE report what the Council took in Derelict Site levies in 2019, 2020 and 2021 to date?

How many sites are currently deemed derelict by the Council and can the CE outline the level of action the Council has taken?

#### REPLY

The levy collection figures are as follows:

2019 - €189, 975 2020 - €163,231 2021 to date - €155,240, with further payments expected.

There are currently 89 on the Derelict Sites Register.

In 2021 an additional 100 sites will be inspected. Cork City Council has initiated CPO process for sites in the North Main Street, John's Street and Barrack's Street. This is in addition to regeneration and other measures to improve the fabric of the city centre. Additional CPOs will be considered through 2021.

Cork City Council is providing ongoing support for those with derelict or vacant sties. Information on supports is made available and staff work with property owners in relation to planning, grants and other supports that are available to remove dereliction. This will continue to be augmented in 2021.

Cork City Council engages with site owners in relation to the removal of dereliction and work informally with site owners where assistance can be provided to pre-empt dereliction.

Dereliction is complex in nature, and the collection of levies can be difficult, as site owners in many some cases choose not to engage, or may not have the financial resources to pay the levy.

We offer payment plans and work consistently with site owners to address matters of dereliction and payment of the levy.

The year 2020 in particular posed challenges for the collection of the levy. Covid restrictions meant sites could not be inspected to ascertain if still derelict, sites were not redeveloped or sold.

A number of sites on the derelict sites register are currently for sale, and a significant number are involved in the planning process. This is a positive step it can lead to the removal of dereliction. The levy is generally discharged during the sale process, and some cases it can act as a catalyst for entry into the planning process. We actively engage with the site representatives in relation to the sale process and the discharge of the levy.

We also operate a bond option as an alternative to the imposition of a levy on site, this enables us to introduce timescales for the removal of dereliction and a suspension of the levy whilst an agreement is in place. Site owners have also stated, the costs involved in the planning process can be prohibitive, perhaps at a national level this matter could be addressed, where the planning costs to redevelop a derelict site could be reviewed.

#### 4.5 <u>PEDESTRIAN AND CYCLE LINK FROM GRAND ROAD THROUGH</u> <u>VERNON MOUNT VALLEY</u>

In response to the following question submitted by Comhairleoir S. O'Callaghan, a written reply was circulated as outlined below:-

To ask the Chief Executive for an update on the planned pedestrian and cycle link from the Grange Road through the Vernon Mount Valley and over the South Ring Road to Tramore Valley Park, including details about when work on the project is likely to commence.

## REPLY

The Grange Road to Tramore Valley Park Pedestrian and Cycle Scheme is currently at detailed design stage. It is anticipated the tender documents for the scheme will be ready for issue over the summer. Subject to approval to the tender assessment thereafter it is envisaged that works could be commenced on site towards end of Q3 2021 or early in Q4. The construction of the scheme to take approx. 18 months. Members will be provided with further updates as the scheme progresses through the tender and contractor appointment stages.

## 4.6 **<u>30KM SPEED LIMIT - ST FINBARR'S PARK</u>**

In response to the following question submitted by Comhairleoir C. Finn, a written reply was circulated as outlined below:-

To ask the CE when the 30km speed limit will be actioned for St Finbarr's Park?

## REPLY

St. Finbarr's Park was selected in early 2020 as a location for a proposed 30 km/h slow zone as part of the 2020/2021 programme of Speed Limit interventions. This was to be a two year rolling programme with the statutory elements being undertaken in the first year followed by installation of on-street signage in year two. This programme timetable has unfortunately been delayed due to COVID e.g. 4 month construction ban and the prioritisation of other COVID related works such as the Pedestrianisation of City Streets, installation of bike parking city wide and installation of Drive Feedback signs. The changing of any speed limit requires a lengthy statutory process, prior to the erection of appropriate signage. The statutory process for the 2020/2021 programme of works has commenced and the pre implementation surveys are being carried out at present in advance of drafting the Special Speed Limit byelaws. Installation of on-street signage for streets included in the adopted Bye-Laws will commence in Q4 2021.

## 4.7 <u>FUNDING TO LOCAL AUTHORITIES TO RECRUIT MORE STAFF TO</u> <u>ASSIST IN EXPANDING WALKING & CYCLING FACILITIES</u>

In response to the following question submitted by Comhairleoir D. Boyle, a written reply was circulated as outlined below:-

To ask the Chief Executive that further to the announcement made in January of this year, that the Minister for Transport was providing additional funding for local authorities to recruit more staff to assist in expanding walking and cycling facilities, how many such staff have recruited, how have they been deployed, and have all such positions now been filled?

## REPLY

The Department of Transport and the National Transport Authority (NTA) are providing funding for additional local authority staff to support both the Bus Connects Programme and the planned NTA investment in new/upgraded cycling and walking infrastructure. To date Council has secured approval and has filled / is in the process of filling the first six staff positions. A further seventeen positions will be filled over the coming months subject to Departmental approval. The staff recruited on foot of the additional funding will cover a broad range of disciplines including administration/ programme coordination, project management, landscape architecture, quantity surveying, communication/engagement, graphic design, technician services, engineering etc. The additional posts are essential to the design, planning and delivery of the expanding work programme to be funded by the National Transport Authority and will be supported/complimented by the existing skills within the local authority. As Members will be aware, that the Programme for Government provides for a significant increase in transport investment over the coming five years. This investment is targeted at the development of sustainable transport infrastructure, particularly cycling, walking and bus related infrastructure and Members will be kept appraised of progress on the expanding schedule of projects.

## 4.8 SAFE TO SCHOOL FUNDING

In response to the following question submitted by Comhairleoir K. McCarthy, a written reply was circulated as outlined below:-

To ask the CE on the city schools, which received Safe to School funding through the NTA and the associated Green Schools An Taisce initiative in 2019, 2020 & 2021, and how much was allocated to each school?

## REPLY

The NTA have allocated €500,000 of funding for a Safe to Schools Programme for Cork City in 2021 (the first year that such funding has been made available) and undertook a process with An Taisce to invite schools to participate in the programme. The applications were reviewed by the NTA and An Taisce and the following six schools were selected for inclusion in the 2021 programme.

- Bishopstown Community School
- Gaelscoil na Dúglaise
- Glanmire Community College
- Scoil Naomh Caitríona, Bishopstown
- Scoil Naomh Iosaf, Riverstown.
- St. Luke's NS

The funding is not allocated specifically to each school. In order to identify the specific interventions at each of the six chosen schools a consultant will be appointed to assess the issues at each location and determine appropriate Safe to School measures to be implemented on a school by school basis.

# 4.9 <u>ROADS TO BE CONSIDERED FOR SPECIAL 30KM/H SPEED LIMITS IN</u> <u>THE CITY</u>

In response to the following question submitted by Comhairleoir O. Moran, a written reply was circulated as outlined below:-

"To ask the Chief Executive for the list of roads and areas to be considered for special 30km/h speed limits in the city, and what barriers if any exist prevent implementing these immediately?"

## REPLY

The setting of speed limits is carried out in accordance with the 2015 Guidelines for Setting and Managing Speed Limits in Ireland. The use of these Guidelines, a statutory document, is mandatory when setting and managing speed limits. The 2004 Road Traffic Act provides the legislative basis for speed limits generally, providing for the application of default speed limits in respect of various road types.

A built-up area is defined in the Local Government Act 2001, and section 5 of the Road Traffic Act 2004 sets a default speed limit of 50 km/h for these built up areas.

Since 2016, the Dept have been providing an annual grant to allow for the introduction and expansion of 30 km/h slow zones in housing estates and each year since 2016, Cork City Council has introduced additional 30km/h zones. 30km/h speed limits are currently in effect on over 300 streets across the city and Cork City Council will continue this programme to increase this number over the coming years, provided funds are made available to continue this programme. Cork City Council maintain a list of requests and on an annual basis, these requests are assessed and if locations are deemed suitable brought forward to the members for inclusion in the Special (Speed limit) byelaws.

In addition to this, Cork City Council carry out a review of speed limits every five years as required by the guidelines. The last review was carried out in 2017 with the next review due to be carried out in 2022. As outlined in the guidelines, an informal non-statutory consultation process can be carried out to advertise for the submission of requests for speed limit changes to be included consideration in the review. This consultation process will be carried out in Q4 of 2021 to inform the 2022 Speed limit review.

While the Speed Limit Guidelines do not require a local authority to establish definitively the 85th percentile speed using a traffic speed study before applying a special speed limit of 30 km/h, the guidelines do continually refer to the need for speed limit to be set appropriately to reflect the mean and 85th percentile speed of traffic to ensure the speed limits in built up or urban areas are 'self-regulating' or 'self-explaining'. Speed limits in urban areas need to be selected to ensure that they are appropriate and consistent with the physical characteristics, function and context of the network. In order to implement appropriate speed limits and determine the 85<sup>th</sup> percentile, Cork City Council carry out pre and post implementation surveys. The pre implementation surveys are carried out for a period of one week duration. Following this the data captured is retrieved and analysed. The carrying out of speed surveys to inform the process of setting speed limits is not a barrier to the implementation of special speed limits.

The changing of any speed limit on a public road, is a reserved function of Elected Members and requires a lengthy statutory process, including selection of areas, mapping selected roads/streets, notification of LACs, An Garda Síochána and TII, public consultation for minimum of 30 days, assessment of submissions received, preparation of a report to Council Committees followed finally by a recommendation to full Council for adoption. Following adoption of the byelaws the appropriate signage is erected to give effect to the byelaws. Such installations are added to a programme of works and is subject to funding and resources.
