#### 1. DRAFT CORK CITY DEVELOPMENT PLAN 2022-2028

An Chomhairle considered the proposed amendments to the Draft Cork City Development Plan.

An tArdmhéara outlined the process and procedure for the meeting. The Chief Executive briefly addressed the meeting and gave a background to the first Cork City Development Plan since the extension of the city.

Mr. F. Reidy, Director of Services, Strategic and Economic Development advised members of the voting procedure and outlined next steps from tonight's meeting.

That the Members of Cork City Council, in accordance with Section 12(6) of the Planning and Development Act, 2000 (as amended), having considered the Draft Cork City Development Plan 2022 – 2028 published on 6th July, 2021 and the Chief Executive's Report dated 20th December, 2021, having engaged in a series of workshops of the Full Council and the Local Area Committees held on 26th January,

8th 10th, 11th, 15th, 23rd and 24th February and 2nd, 3rd, 7th and 9th March, 2022 Resolves to Amend the Draft Cork City Development Plan as follows:

## Amendment 184 Schedule 3 Hop Island Rochestown

## **Objective 10.x Hop Island**

- 1. The provision of a detailed Flood Risk Assessment addressing potential flooding of the site and site access having regard to recent flood events and available flood mapping data prepared by a suitably qualified individual. These shall comply with the requirements of The Planning System and Flood Risk Management Guidelines for Planning Authorities (2009).
- 2. A Habitats Directive Screening Report shall be required to consider the potential impacts of development on the Cork Harbour SPA and any ither Natura 200 site identified to be relevant.
- 3. The island contains Hop Island House, a heritage building listed on the National Inventory of Architectural Heritage. Any proposed development must have regard to the character of the existing house and its associated Demense Landscape.'
