#### 1. REPORT FROM CHIEF EXECUTIVE

The Chief Executive presented her Report on the 2023 Draft Budget for Cork City Council. A number of Members spoke on the issues and challenges associated with the Draft Budget 2023.

<u>CHANGE IN CHAIR</u> An tArdmhéara vacated the chair at 7pm and An Leas Ardmhéara, Comhairleoir D. Boylan took the in her absence.

# 2. <u>BUDGET 2022 AMENDMENTS</u>

**2.1** The following amendment to the Draft Budget was proposed by Comhairleoir D. Cahill and seconded by Comhairleoir T. Shannon.

'To increase the expenditure budget for Ward Funds in B0405 by 15,500 and as a result decrease the expenditure budget in H1101 (Agency & Recoupable Services) by 15,500.'

An Chomhairle agreed unanimously to adopt this proposal without taking a vote.

An Leas Ardmhéara declared the proposal adopted.

2.2 The following amendment to the Draft Budget was proposed by Comhairleoir D. Cahill and seconded by Comhairleoir T. Shannon.

'To increase the expenditure budget for Tidy District Grants in D0905 by 14,500 and as a result decrease the expenditure budget in H1101 (Agency & Recoupable Services) by 14,500.'

An Chomhairle agreed unanimously to adopt this proposal without taking a vote.

An Leas Ardmhéara declared the proposal adopted.

**2.3** The following amendment to the Draft Budget was proposed by Comhairleoir D. Boyle and seconded by Comhairleoir S. Martin.

'To increase the expenditure budget for School Wardens in B0801 by €20,000 and as a result decrease the expenditure budget in H1101 (Agency & Recoupable Services) by 20,000.'

An Chomhairle agreed unanimously to adopt this proposal without taking a vote.

**2.4** The following amendment to the Draft Budget was proposed by Comhairleoir L. Bogue and seconded by Comhairleoir O. Moran.

'To increase Commercial Rates from 3.8% to 6% and to provide 3 bands in the rates rebate scheme which will result in the reduction of payments for small to medium sized enterprises. The proposed amendment to the Rates Rebate Scheme is as follows:

10% rebate for rate payers with an annual rates liability of between €0 and €4,000

5% rebate for rate payers with an annual rates liability of between €4,001 and €10,000

3% rebate for rate payers with an annual rates liability of between €10,001 and €30,000'
