1.1 **WREATH LAYING AT ST. FINBARRS CEMETERY**

An tArdmhéara advised An Chomhairle that wreaths were laid on Sunday 1st November 2020 at the graves of Terence MacSwiney and Joe Murphy in St. Finbarr's Cemetery, to commemorate the centenary of their deaths on hunger strike in 1920.

1.2 **LORD MAYOR'S SCHOOL VISITS**

An tArdmhéara advised An Chomhairle that on 23rd October 2020 he made a live broadcast to the city's 119 primary and secondary schools as part of a reimagined Lord Mayor's school visits.

4. **QUESTION TIME**

4.1 **EVENTS CENTRE**

In response to the following question submitted by Comhairleoir M. Finn, a written reply was circulated as outlined below:-

Given that CE's items have not been reached on the last two council meeting agendas, can the CE give an up-to-date date report on the proposed Event Centre, during Question Time, as requested before the summer?

REPLY

BAM, Live Nation Gaiety (LNG) and Cork City Council are continuing to meet on the Cork Events Centre and all parties including the Government of Ireland recently re-affirmed their commitment to deliver this project

At present in light of Covid 19, roadmaps aren't in place for the reopening of the global live entertainment industry. Despite this uncertainty, the parties continue to progress the project.

All parties are intent on bringing the funding agreement (which dictates the terms on which government support is granted) to as close a point as possible to where it can be signed off once revenue streams are restored in the events industry.

4.2 **REPORT INTO SAFETY OF 5G**

In response to the following question submitted by Comhairleoir T. Moloney, a written reply was circulated as outlined below:-

In light of the passing of my motion 21.1 at Ordinary Meeting – Monday, 13th January, 2020

Motion

'I am asking Cork City Council to conduct a detailed report into the safety of 5G. People are extremely worried and voicing their concerns about the harmful effects of radiation. Concerns must be addressed as there could be implications for the public. I call on this Council to support a report and alleviate the concerns of the public of this city.'

Can the CE tell me what steps have been taken to carry out this detailed report?

Huge 5G masts are being erected/installed right across the city without any consultation with the residents of these areas and it is imperative that this report is carried out.

REPLY

The City Council has no function in evaluating the safety of 5G. It is the role of national and international experts and certifying bodies, who have the skills and expertise to evaluate such technologies before they are licensed for use.

Information has been published on 5G by **ICNIRP** (<https://www.icnirp.org/en/frequencies/radiofrequency/index.html>), the **UK Government** (<https://www.gov.uk/government/publications/5g-technologies-radio-waves-and-health/5g-technologies-radio-waves-and-health>) and **OFCOM** (https://www.ofcom.org.uk/data/assets/pdf_file/0015/190005/emf-test-summary.pdf)

The European Commission on 3rd June, 2020, published a Frequently Asked Questions (FAQ) on 5G on their website under the "Digital Single Market" heading. The FAQ includes 14 frequently asked questions about 5G. They address the

technology (5), benefits (4) and electromagnetic fields (5). (<https://ec.europa.eu/digital-single-market/en/faq/5g-faq>)

In response to the statement that the Council is not consulting with the residents in relation to erection/installation of masts across the City, the licensing process for this overground electronic communications infrastructure and any associated physical infrastructure' i.e. a streetwork solution is set out in Section 254 (1) (ee) of the Planning and Development Act.

The Government's National Broadband Plan is a framework for the provision of high speed broadband through a combination of commercial and state investment. Companies apply and are approved as registered providers for the communications industry and this is authorised by ComReg to provide electronic communications networks and services.

This authorisation from ComReg allows registered companies to apply for licences for over ground electronic communications infrastructure.

Registered providers work closely with mobile operators to identify locations known as 'blackspots' for mobile and wireless broadband. It is on this basis that licence applications for streetwork solutions are made. These proposed sites/locations are areas where coverage for mobile phones and data devices is required.

In considering a licence under Section 254 for such infrastructure the Planning Authority in consultation with the Roads Operations Division of the Council must have regard to four considerations as prescribed by the Act:

- (a) the proper planning and sustainable development of the area,
- (b) any relevant provisions of the development plan, or a local area plan,
- (c) the number and location of existing appliances, apparatuses or structures on, under, over or along the public road, and,
- (d) the convenience and safety of road users including pedestrians.

Unlike a planning application, there is no requirement for the applicant to put up a site notice to place an ad in the newspaper. Moreover, the Section 254 licensing process does not provide for the consideration of third-party submissions as part of the decision-making process.

Members of the public can appeal the decision to issue a licence to An Bord Pleanála, who request a fee for such service.

4.6 **MARKET GARDENS, TOGHER ROAD**

In response to the following question submitted by Comhairleoir H. Cremin, a written reply was circulated as outlined below:-

Can the CE inform the Council has Market Gardens on Togher Rd. being taken in charge and, if not, can the CE give the specific reasons why this hasn't happened to date.

REPLY

Market Gardens on Togher Road is a City Council estate which was developed privately and purchased outright by Cork City Council.

The final task is to resolve any formal statutory processes and re-distribute the appropriate responsibilities to the relevant stakeholders, which is normally predicated on standards of completion and proof of same.

Housing has money allocated under the Loan funding for this process. Works are on-going and expected to be completed in 2021.

4.7 **DERELICTION IN CITY CENTRE**

In response to the following question submitted by Comhairleoir M. Nugent, a written reply was circulated as outlined below:-

Can the CE outline the City Council's strategy in dealing with dereliction in the city centre and if a safety audit of buildings is to take place?

REPLY

Cork City Council has a broad, cross-functional approach to addressing dereliction and building safety in Cork City.

The Fire and Building Control Department has well established inspection practices and procedures in dealing with Dangerous Structures under the Local Government Sanitary Services Act 1964. Inspections and investigations are carried out as a result of specific complaints from the Gardaí, emergency services, other Cork City Council Departments and the general public.

The department is committed to treating any report of a Dangerous Structure as a priority issue and will promptly investigate any report. Under the Local Government Sanitary Services Act 1964 we cannot insist works beyond making safe and removing the danger to public safety. It is important to note, ultimately, responsibility for dangerous structures and places rests with private property owners.

A revised Derelict Sites policy was adopted by Council in late 2019 and it is aimed at ensuring a targeted and streamlined approach to addressing dereliction in the city. Sites are inspected and there is an engagement process with owners of sites following which appropriate action is taken under the Derelict Sites Act 1990. As part of current practice, the Derelict Sites team works in consultation with the Fire and Building Control team. This practice is under continuous review but is subject to the application of the processes set out by law.

The reasons for dereliction can be complex, often making it difficult to identify and engage with site owners. However, a number of sites have been prioritised and the Derelict Sites team will strive to actively engage with the owners involved in an effort to reduce and ultimately remove dereliction.

There was a significant number of new builds and purchased schemes added to stock during this time period, the majority of which have now been allocated.

A further 15 units in the Phase 3 area of the CNWQR Project were vacated as tenants moved in to new homes in Phase 2A.

4.9 **COKE ZERO BIKE STATIONS ON NORTHSIDE**

In response to the following question submitted by Comhairleoir J. Maher, a written reply was circulated as outlined below:-

To ask the CE

What are the plans to roll out an extension of the Coke Zero bike stations on the northside of the city?

REPLY

The Public Bike Scheme is managed by the National Transport Authority (NTA) and currently comprises of 32 public bikes stations with approx. 330 bikes in circulation. There are a total of 8 stations are on the north side of the City and these are located at Popes Quay , Camden Quay , Coburg Street , Lower Glanmire Road, Penrose Quay and Kent Station . The Public Bike Scheme has been very successful in Cork since its introduction in 2016 and it currently has over 14,000 subscribers. In response to Council requests, the National Transport Authority (NTA) has confirmed that it will be extending the scheme. A key requirement for the siting of new stations is the relative proximity to adjoining stations so that if a user arrives at a station to collect a bike and the rack is empty or to return a bike and the rack is full that an alternate station is available with approx. 300m. With this in mind, the planned extension provides for new stations at big trip attractor locations at UCC, CUH and CIT. In all 11 new stations are to be provided at College Road/UCC, Mardyke Walk, Dennehy's Cross, County Hall, Wilton Road, Melbourne Road and Model Farm Road. The Authority is currently making arrangements for the installation of the new stations as well as a number of advertising boards which are normally used to help part defray the operational costs of such schemes. The Authority has also confirmed that it is undertaking an audit of existing facilities with a view to addressing any maintenance issues. Members will be kept apprised of progress in relation to the planned extension.

6.4 **ENVIRONMENT, WATER & AMENITY STRATEGIC POLICY COMMITTEE – 21st SEPTEMBER 2020**

An Chomhairle considered and noted the minutes of the Environment, Water & Amenity Strategic Policy Committee from its meeting held, 21st September 2020.

6.4.1 **MOTIONS**

6.4.1.1 **POLICY TO SUPPLY SKIP BAGS**

An Chomhairle considered and approved the report of the Director of Services, Roads & Environment Operations, dated 11th September 2020 on the following motion referred to the Committee:-

‘That Cork City Council Litter Department implement a policy with existing companies that supply skipo bags to shops and all local suppliers. Names and addresses should be taken when sold to the public so that if illegal dumping of these bags take place the person or persons can be identified’

(Proposer: Cllr. K. Collins 20/175)

The report of the Director of Services stated that Cork City Council litter department has investigated the matter and found that over the past 3 years the number of complaints has been low.

Year	No of Skippo Bag complaints
2020	1
2019	7
2018	8

The majority of these complaints have been resolved within a number of days by the Litter Wardens by advising the skipo bag owners to dispose of bags correctly and to hold onto receipts for proper disposal. Cork City Council will discuss further with the waste contractors to examine if bags sold by them can be tracked and traced.

6.4.1.2 **INSTALL CCTV IN ALL CEMETERIES**

An Chomhairle considered and approved the report of the Director of Services, Roads & Environment Operations, dated 11th September 2020 on the following motion referred to the Committee:-

‘That Cork City Council install CCTV in all cemeteries in the city.’

(Proposer: Cllr. K. O’Flynn 19/451)

The report of the Director of Services stated that Cork City Council has installed CCTV cameras at selected locations in four of its cemeteries to deter various activities that were happening on a consistent basis after dusk.

The Council has a total of 13 cemeteries and at present there is no need or requirement to extend the CCTV service to the remaining 9 cemeteries.

The behaviour of those visiting the cemeteries both during the day and after dusk is continuously monitored and appropriate measures will be taken should it be necessary to deter certain activities.

6.4.1.3 **CHECKS FOR PROOF OF REFUSE DISPOSAL**

An Chomhairle considered and approved the report of the Director of Services, Roads & Environment Operations, dated 11th September 2020 on the following motion referred to the Committee:-

‘In light of the level of illegal dumping across the city and the passing of new laws in relation to households having to prove they are disposing of their rubbish legally, Cork City Council should now put in place a management system to carry out checks across the city. Proof of refuse collections in all areas possibly starting where illegal dumping is most prevalent can be done by reassigning staff, employing new staff or a suitable alternative being put in place by Cork City Council.’

(Proposer: Cllr. T. Moloney 20/206)

The report of the Director of Services stated that Cork City Council’s Environment section has been actively carrying out work under the Waste Presentation Bye-laws since May 2019. Areas of the city where illegal dumping is most prevalent have been a main focus of these investigations.

Since May 2019 information has been sought from approximately 500 properties, 90 door to door inspections have been carried out and 40 Fixed Penalty Notices have been issued.

6.4.1.4 **PILOT PROJECT FOR DOG WALKING AREA**

An Chomhairle considered and approved the report of the Director of Services, Roads & Environment Operations, dated 11th September 2020 on the following motion referred to the Committee:-

‘That City Council would consider putting in place a pilot project for a dog walking area (without a leash) in one of our parks that would be big enough to facilitate this. Tramore Valley and the loop at the eastern end of the walkway at Ballincollig park have been suggested by several constituents for this pilot project.’

(Proposer: Cllr. H. Cremin 20/211)

The report of the Director of Services stated that the City Council will explore the feasibility of providing a designated area for a dog walking area to establish if this can be accommodated within one of its existing parks without compromising other uses and activities.

Issues to be considered in the provision of a dog run are the size of area required, suitable fencing, segregation of large and small dogs, supervision, cleaning and maintenance, capital and revenue costs.

The findings from this exercise will be reported back to this committee for consideration.

6.4.1.5 **JAPANESE KNOTWEED ACROSS THE CITY**

An Chomhairle considered and approved the report of the Director of Services, Roads & Environment Operations, dated 11th September 2020 on the following motion referred to the Committee:-

‘That City Council give an updated report on the measures taken in relation to the tackling of the ongoing issues with Japanese knotweed across the City specifically the walkways at Model Farm Rd./Carrigrohane Rd. and Mardyke/North Mall.’

(Proposer: Cllr. H. Cremin 20/212)

The report of the Director of Services stated that the City Council carried out an Invasive Flora Study of the City in 2016.

The study identified the areas infested with Japanese Knotweed and the approximate area covered at each location.

Locations were prioritised for treatment in the context of their proximity to amenities, water courses and residential properties. The only effective eradication treatment is the application of Glyphosate during August/September. This is the fourth year of the programme and the results to-date are very satisfactory.

Model Farm Rd/Carrigrohane Rd and Mardyke/North Mall are receiving their fourth treatment and this should see the complete eradication of the plant at these locations this year.

6.4.1.6 **WASTE COLLECTION HOURS**

An Chomhairle considered and approved the report of the Director of Services, Roads & Environment Operations, dated 11th September 2020 on the following motion referred to the Committee:-

‘That Cork City Council take all necessary steps to ensure that, outside of Cork city centre, waste collections are only permitted to take place between 6.00 am and 9.00 pm on weekdays and between 8.00 am and 8.00 pm at weekends and on bank holidays.’

(Proposer: Cllr. S. O’Callaghan 20/265)

The report of the Director of Services stated that all authorised waste collectors are obligated to work within the conditions of their permit which are issued by the NWCPO (National Waste Collection Permit Office) based in Offaly. Cork City Council’s Waste Enforcement section carryout roadside inspections of vehicles as well as responding to individual complaints and ensure that collectors are operating within the terms of the conditions attached to their permit’s conditions.

6.5 **INTERNATIONAL RELATIONS AND TOURISM STRATEGIC POLICY COMMITTEE – 21st SEPTEMBER 2020**

An Chomhairle considered and noted the minutes of the International Relations & Tourism Strategic Policy Committee from its meeting held, 21st September 2020.

An Chomhairle considered and noted the report of the Director of Services, Strategic and Economic Development, on Cork City Council's EU activities and projects.

An Chomhairle considered and noted the report of the Director of Services, Strategic and Economic Development, on current activities to support the tourism sector in Cork in light of the COVID 19 emergency.

6.6 **COMMUNITY, CULTURE & PLACEMAKING STRATEGIC POLICY COMMITTEE – 21st SEPTEMBER 2020**

An Chomhairle considered and noted the minutes of the Community, Culture & Placemaking Strategic Policy Committee from its meeting held, 21st September 2020.

6.6.1 **NOTICES OF MOTION**

6.6.1.1 **WATER BOTTLE FILLING STATIONS**

An Chomhairle considered and noted the report of the Director of Services, Community, Culture & Placemaking dated 7th September, 2020 on the following motion referred to the Committee:-

‘That Cork City Council introduce water bottle filling stations on the city centre island and in our public parks and walks ways.’

(Proposer: Cllr. K. O’Flynn 19/421)

The report of the Director of Services stated that Irish Water is in the process of developing a policy in relation to drinking water points in public areas and are in discussions with the Regulator as to how they should be progressed.

Cork City Council's Parks department has successfully applied to the Healthy Ireland Fund which will provide 50% grant funding towards the installation of 5 no drinking water fountains in our Parks and this is being progressed.

Cork City Council's Environmental Awareness Office has been making progress in the fight against single use water bottles with a number of initiatives:

- Cork City Council's Waste Prevention Grant Scheme (2020) has granted funding of €1,000 to a secondary school towards the installation of water bottle refill

stations in the school in order to eliminate single use plastics. Promotion of the project is anticipated to create greater uptake from schools for the 2021 scheme.

- Elimination of single use plastics from Cork City Marathon – the 2019 event had a refill finish line where filtered water in reusable tumblers was provided at the finish line. The 2020 event was due to convert one of the main water stations on the course from single use water bottles to water-filled Oohos (seaweed-based compostable pouches that can be eaten or discarded to biodegrade within 4-6 days).
- Other events such as Carnival of Science and SeaFest sought to eliminate single use plastics through the introduction of water refill stations and the banning of sale of plastic water bottles by vendors.
- The City Council’s Environmental Awareness Office received funding from the EPA’s Local Authority Prevention Network in 2018 to promote Refill.ie at a local level in order to increase the number of Refill.ie members in Cork City and increase the awareness of Refill.ie amongst the general public. The project was delivered by Cork City Council in partnership with Refill.ie and Cork Environmental Forum. Over the three month period, approximately 50 premises were visited and 28 premises signed up for the Refill.ie scheme. All of these businesses were issued with stickers to be displayed on their premises. In addition, each of the premises was added to the Refill.ie Tap Map. At present, there are over 60 premises in Cork City signed up to Refill.ie which means that they provide tap water refills to the general public free of charge.

In terms of public water bottle refill stations, Cork City Council is beginning with installation of five water bottle refill stations in a number of Cork City Parks this year. Depending on the information collected regarding installation, location, use, cost, maintenance, etc. the installation of further units elsewhere in the City will be considered.

6.6.1.2 **PLACING OF SIGNS BY COMMUNITY GROUPS**

An Chomhairle considered and noted the report of the Director of Services, Community, Culture & Placemaking dated 21st September, 2020 on the following motion referred to the Committee:-

‘That Cork City Council will support the placing of signs by community groups and local initiatives, such as the ‘Beasts of the Bride’, highlighting the importance of nature and biodiversity in the city.’

(Proposer: Cllr. O. Moran 20/234)

The report of the Director of Services stated that the City Council will support the placing of appropriate signs at suitable locations by community groups and local initiatives, highlighting the importance of nature and biodiversity in our city. Signage and locations to be approved by City Council.

6.6.1.3 **GREEN SPACE IN HOUSING DEVELOPMENTS**

An Chomhairle considered and noted the report of the Director of Services, Community, Culture & Placemaking dated 7th September 2020 on the following motion referred to the Committee:-

‘That this Council continues to insist on the importance of appropriate amounts of green space to be included with each housing development in its administrative area.’

(Proposer: Cllrs. D. Boyle and C. Finn 20/238)

The report of the Director of Services stated that the provision of appropriate and adequate open space is an important component of any housing development. This is reflected in the current City Development Plan, as well as various National Planning Guidelines, which contain quantitative and qualitative requirements for the provision of public and private open space in residential developments. These are applied to each planning application and Part 8 proposal for housing development in the City. The development plan process will consider and reflect these important requirements in the new city development plan.

6.6.1.4 **VIRTUAL PLATFORM FOR ARTISTS**

An Chomhairle considered and noted the report of the Director of Services, Community, Culture & Placemaking dated 7th September 2020 on the following motion referred to the Committee:-

‘That with the postponement this year of several significant city festivals, this Council facilitate and where possible resource greater virtual platforms for artists particularly musicians.’

(Proposer: Cllr. C. Finn 20/243)

The report of the Director of Services stated that Cork City Council Arts Office hosted a webinar in July 2020 that delivered practical guidance including technical tips for virtual production for music-based and other artistic events. A CPD programme is in development that will include support for collaborative artistic production for online and blended platforms with the support of the Creative Ireland Jobs Stimulus Package.

6.6.1.5 **SUPPORT CORK (CORK RECOVERS) FESTIVAL**

An Chomhairle considered and noted the report of the Director of Services, Community, Culture & Placemaking dated 7th September 2020 on the following motion referred to the Committee:-

‘Given the cancellation of the October Jazz Festival, that Cork City Council initiates moves to have a Support Cork (Cork Recovers) festival instead to support business in the city and provide a welcome social outlet for people.’

(Proposer: Cllr. M. Finn 20/280)

The report of the Director of Services stated that Cork City Council Arts and Events Office has been engaging in recovery planning within the context of ongoing restrictions to public gatherings and in a manner compliant with public health advice. Events that are planned to take place in Autumn/Winter include Culture Night 2020 on 18th September which will include a blended programme of online and Covid-compliant real-life events across 60+ venues. We are currently in the process of procuring services to deliver a distributed approach to the annual Glow Christmas Festival.

As well as Cork City Council led events there are a wide variety of independent events planned that have been supported by Cork City Council. All will be adapted to take account of Covid-19. These include:

- Cork Folk Festival: 1st – 4th October
- Indie Film and Music Festival: 4th – 11th October
- Cork International Short Story Competition: 6th – 10th October
- Cork Pride: 19th – 25th October
- Cork Film Festival 5th – 15th November
- Evening Echo Shalom Park Ceremony, 18th December.

Further to the reopening of some cultural venues in Summer such as the Crawford Art Gallery, Triskel Christchurch and St. Peter's, the coming months will see the reopening of more cultural venues including The Everyman.

6.6.1.6 **EXTEND OPENING HOURS IN CORK CITY LIBRARY**

An Chomhairle considered and noted the report of the Director of Services, Community, Culture & Placemaking dated 16th September 2020 on the following motion referred to the Committee:-

‘That Cork City Council investigate extending opening hours of public spaces such as Cork City library for the use of students as study spaces should the need arise due to social distancing measures in third level institutes in Cork City.’

(Proposer: Cllr. L. Bogue 20/301)

The report of the Director of Services stated that the City Library has a long tradition of providing study spaces for both second level and third level students, it is a much sought after space for study in the city.

Due to Covid-19 restrictions and adhering to best practice following public health guidelines, social distancing measures are also part of Cork City Library study provision facilities similar to those within the third level institutions.

Currently the capacity for students studying in the City Library is 16. The maximum stay for study is 120 minutes and masks must be worn during the stay. Staff take contact tracing details from those using the space. Providing these 16 spaces is now a much more staff intensive process than pre-Covid.

To extend the opening hours would require;

1. the recruitment of additional staff
2. the provision of additional security.

While the ethos of Cork City Libraries is and always has been to support students, including third level and life-long learners, the addition of 16 study spaces would have minimal impact on increasing the study opportunities for students within the city while incurring a significant cost to Cork City Council.

‘Now that the new housing estate is completed on the Deanrock site, the junction at Togher Road, Clashdub Road and Vicars Road needs to be addressed immediately. Councillors were told that full and detailed plans will be put in place for the whole of Togher Road on completion of these houses. A filter light turning right from Clashdub Road onto Togher Road needs to be done as a matter of priority. Cllr. Henry Cremin has also requested that a pedestrian crossing/zebra crossing be placed close to the bus stops allowing people to cross safely at this point accessing the housing est., credit union etc.’

(Proposers: Cllr. T. Moloney, Cllr. H. Cremin 20/204)

The report of the Director of Services stated that works to Deanrock Junction are set to begin in mid-October. These will include new traffic lighting to provide additional safety for right turning traffic. As funding is limited, works are confined to works at the junction.

As those voting against the motions were greater than those voting for, An tArdmhéara declared the vote and the motions defeated.

6.21.3 **ENGAGEMENT WITH TAXI REPRESENTATIVES**

An Chomhairle considered and approved the following motion:-

‘Cork City Council calls on the government to have meaningful engagement with taxi driver representatives and introduce the necessary reforms to give taxi drivers a break and to keep our taxis on the road. These would include a pause on the issuing of new licences until normal levels of economic activity return, reform of the Taxi Advisory Committee, continued access to bus lanes and a temporary two-year

extension to the rule that requires taxis to be less than ten years old. Taxis provide an essential service in our transport network, many people with disabilities rely on taxis daily and taxi drivers should be recognised by this government for the contribution they make.’

(Proposer: Cllr. M. Nugent 20/349)

(Proposer: Cllr. L. Bogue 20/254)

The report of the Interim Director of Services advised that as this matter is the subject of a legal review it is not appropriate to comment at this time.

On the proposal of Comhairleoir L. Bogue, An Chomhairle agreed to refer the motion back to the Housing Strategic Policy Committee for further consideration.

An Chomhairle agreed to suspend the meeting at this point due to the late hour.
