'That Cork City Council write to Minister Eamon Ryan, seeking clarification on his recent remarks in this Chamber (21/10/2024) concerning public transport enhancements under Project Ireland 2040. Minister Ryan mentioned that Cork City "needed to double its size." According to the National Planning Framework (NPF), the target for Cork City is a population growth of 50% to 60% by 2040, calculated using modelling, projecting a population of 335,853. However, the Minister's statement implies a different scenario, suggesting the current population of approximately 226,000 will increase to 452,000, which is 116,114 more than the NPF estimate. Can the Minister explain this discrepancy and clarify the demographic composition of the additional population, as well as how they will be employed, housed, and integrated?'

1. YELLOW BOX OUTSIDE PYNES VALLEY, BALLYVOLANE

'It has become apparent that the area outside the estate of Pynes Valley in Ballyvolane poses a significant danger to the community due to ongoing issues with traffic safety. Cars are frequently disregarding traffic lights and speeding through the area, resulting in several accidents. The absence of a yellow box exacerbates this problem, making it a black spot for dangerous driving.

In the interest of public health and safety, we urge immediate action to address these concerns. Painting a yellow box outside Pynes Valley estate is a crucial step in preventing further accidents and ensuring the well-being of all residents and users of the North Ring Road. I call on Cork City Council to prioritize this improvement for the benefit of the entire community.'

2. **RESURFACE LONG LANE, DUBLIN HILL**

'That Cork City Council prioritize the resurfacing of the entire Long Lane in Dublin Hill and include it on the agenda for the year 2025 under estate resurfacing. The current state of Long Lane, which has not been resurfaced for 32 years, has deteriorated significantly, posing a safety risk to pedestrians who frequently use it as a walkway in the Dublin Hill area.

It is essential that we address this issue promptly to ensure the safety and well-being of residents and pedestrians in the surrounding areas. Neglecting the maintenance of Long Lane not only jeopardizes the health and safety of individuals but also exposes the Council to potential legal repercussions.

I urge the Council to prioritize the resurfacing of Long Lane as a critical infrastructure project to provide a safe roadway for pedestrians and residents in Dublin Hill. Let us take proactive steps to fulfil our duty as a Council and uphold the standards of safety and maintenance expected in our community.'

3. <u>INSTALLATION OF TRAFFIC LIGHT AND ZEBRA CROSSING AT CRANN</u> <u>DARACH</u>

The high volume of traffic, especially during peak hours, creates hazardous conditions for pedestrians, including children, parents, and elderly residents, who seek to cross the road safely. Waiting times of up to five to fifteen minutes for a vehicle to yield and allow safe passage have become all too common. This not only inconveniences the community but also poses a real danger to pedestrians.

In light of these concerns, I respectfully urge the City Council to promptly address this issue by installing either a traffic light or a zebra crossing near Crann Darach. These safety measures are essential for safeguarding the well-being of all road users and mitigating the risks associated with crossing the road in this bustling area.'

4. ZEBRA CROSSING AT THE OLD KEETING KITCHEN BUILDING

'I, Cllr. Ken O'Flynn, propose the implementation of a zebra crossing at the Old Keeting Kitchen building to facilitate access to Gordon Hill and provide a safe crossing point for the residents of the area to access the Glen River Park.

The primary objective of this motion is to address the health and safety concerns of the residents of Ballyhooley Road. In recent years, traffic conditions in the area have deteriorated significantly, with excessive speeding becoming a common occurrence. 9. JUNCTION ADJACENT TO NEW INN SCHOOL

'That Cork City Council put the necessary road safety measures in place at the Y-junction of Church Hill, Barnavara Hill and Old Youghal Road (directly outside New Inn Primary School).

Crossing the roads in any direction is currently quite hazardous, given the speed of cars and the existing bends preceding the junction in all directions.

There are currently no safe locations for crossing i.e. zebra or pelican crossings. This is an accident waiting to happen.

The footpaths in this area can no longer be considered fit for purpose and urgently need to be reinstated.

In many areas, there is overgrowth blocking the somewhat substandard footpaths in various locations. Certain locations even have no footpaths which forces pedestrians on to the busy roads.

The population in the area in recent years has increased quite significantly, especially on Church Hill and nearby Crawford Woods Estate not to mention the greater Glanmire area, and it will continue to increase in the coming years.

Given these factors and that there is a growing National School located at this junction, New Inn National School, I would consider there to be a significant risk to life, if the junction and adjacent roads infrastructure is left as is.

- Reduce the speed limit to 30km/hr and ensure its implementation. It requires more visible signage in order to highlight and confirm this important safety measure.
- Install traffic calming infrastructure, (e.g. speed ramps, improved signage, etc.) on Old Youghal Road, Church Hill and Barnavara Hill, which are the adjacent approach roads to the school and this very busy junction.
- Provide zebra or pelican crossings and fit for purpose footpath infrastructure adjacent to the school, in order to enhance and ensure public safety, especially when children are being dropped off and collected after school.
- Road markings at the junction of Church Hill and Old Youghal Road need to be enhanced, to ensure the safe flow of traffic going down Church Hill from Old Youghal Road, and also traffic coming up Church Hill and safely crossing this Y-junction, safely continuing on to Old Youghal Road towards Mayfield.'

10. **CORK CITY LIVING CITY INITIATIVE**

'That Cork City Council implement a review of the Living City Initiative Special Regeneration Areas (SRAs) boundaries in Cork City.

There is a huge amount of pre-1915 housing stock in the St. Lukes area (including Gardiner's Hill, Ballyhooley Road and Old Youghal Road) that would hugely benefit from being included in the St. Lukes SRA boundary. These pre-1915's properties which are predominantly traditional construction, typically don't qualify for many SEAI grants (as the B2 BER target is too onerous), or indeed the vacant homes grant - but nonetheless these properties are extremely costly and complex to renovate.

I believe the Living City Initiative is not being applied to anywhere near its full potential in Cork City. It is within Cork City Council's gift to extend the LCI Special Regeneration Areas (SRAs) to which the Tax Relief applies by updating the boundaries.

This could be done with immediate effect.

I would propose adding Gardiner's Hill, Ballyhooley Road, Old Youghal Road, Middle Glanmire Road and Lovers Walk area (*if not already included*) to the St. Lukes SRA for maximum effectiveness.'
