# 2. Minutes

# 3. PPN Report

### 4. SICAP – a) KPI Requests 2022

Cork City Partnership as the SICAP LDC have requested a reduction on the KPI 1 by 20% in terms of their engagement Local Community Groups (LCG) as staff supports have altered towards Ukrainian supports. According to the IRIS system individual group capacity has increased. Fergal D agreed the terms on the new proposals from Pobal on 20% reduction.
