### 1. Welcome

The Chair welcomed the committee members

#### 2. Minutes

The minutes of 21st of July 2022 minutes were approved with no matters arising.

- 3. Membership of LCDC PPN Representatives, Terms of Office, and Replacements A background explanation of the Cork City PPN current membership was delivered by Council support staff. Positions will be elected/filled at the next plenary meeting on November 21<sup>st</sup> 2022. The Meeting discussed the need to review the Cork City PPN Representation given the next plenary meeting on 21<sup>st</sup> November 2022. PPN Representative Request Application form will be forwarded to Cork City PPN ahead of their Plenary.
- 4. Ukraine Community Response Forum Update

The LCDC received an update on the Ukraine crisis and what Cork City have in place in dealing with refugees. Roughly 47,000 Ukrainian refugees in Ireland, 108 arriving per day & there is 6 settings in Cork. The Ukrainians have been linked in with all the services such as ETB, Nano Nagle, Libraries etc

#### 5. For Information - Staff Update

Both Social Inclusion Development Officers are now in place. Healthy Ireland Post has been filled. Age Friendly Co-ordinator post will be advertised over the next few weeks.

#### 6. PPN Report

PPN Resource Worker gave a presentation on Cork City PPN and its progress to date.

### 7 SICAP - Pobal Review - Empowering Communities Programme (ECP)

DRCD have approved a fund of (€140,000) to target an area who scored high on the deprivation Index. A specific site map was identified according to the DRCD criteria for this programme with a target specific population of 300. Using the deprivation index map and local needs knowledge of the area, Cork City Council and Cork City Partnership agreed the Killala gardens area of Knocknaheeny would be best placed to benefit from such a programme. Given the area would benefit from preregeneration work and preparation for the regeneration. Cork City Partnership will be delivering the Programme and will submit a plan.
