1. Welcome

The Chair welcomed the committee members

2. Minutes

On the proposal of Fergal Dennehy, seconded by Ann Doherty the minutes of $19^{\rm th}$ of May 2022 minutes were approved with no matters arising.

3. Ukraine Community Response Forum Update:

Ann Doherty gave an update on the Ukraine crisis and what Cork City have in place in dealing with refugees. The Covid response team are meeting fortnightly. Student accommodation needs to be vacated shortly. We must be very careful in re-housing the refugees so not to be re-traumatising them. The subgroups are working very well. Roughly 43,000 Ukrainian refugees in Ireland which is far more than initially thought. There is uncertainty about lease holdings and there will be a call for pledged properties.

Kieran congratulated the Cork City SICAP Sub-Group, the LCDC and Programme Implementor for its part in the overall DRCD SICAP Award. This is a hugely significant international award.

6 SICAP

Fergal the SICAP Sub-Group met before this meeting and deliberated on the report of additional SICAP Lot funding for the Ukrainian supports. Fergal proposed that the LCDC would pass final approval to the SICAP Sub-Group on the addition of the Ukraine supports programme and funding distribution. The SICAP Sub-Group would then approve these changes to the 2022 SICAP Annual Plan pending a full report from Kieran in mid-August. A full LCDC members meeting will not take place before the deadline for changes to the SICAP Annual Plan need to be made. This was proposed by Fergal Dennehy and seconded by Denis Leamy.
