This important bill was introduced in the context of the International Court of Justice (ICJ) Advisory Opinion from July 2024 which deemed Israeli settlements on occupied Palestinian land illegal and stated that all countries were obliged not to trade with them.'

28.1 DEVOLVE ACTIVE TRAVEL BUDGET TO TARGET EXISTING FOOTPATHS

'That Cork City Council call on Government to devolve at least 10% of the Active Travel Budget to target old and existing footpaths and bring them up to a safe and healthy standard. The practice of insisting on the inclusion of a cycle lane or nothing happens needs to stop. Walking is the most popular and efficient means of active travel and needs to be encouraged and facilitated more.'

28.2 LICENCING OF QUADRICYCLE DRIVERS

'This Council calls on the Government to:

- 1. Introduce legislation to allow individuals aged 16 and over to drive light quadricycles (such as the Citroën Ami) on Irish roads, following the example of several European countries.
- 2. Establish a clear framework for driver training and safety requirements to ensure young drivers are adequately prepared, potentially through a modified version of the Essential Driver Training (EDT) scheme.
- 3. Recognise light quadricycles as a safer and more environmentally friendly alternative to scooters and motorcycles, offering increased protection and zero emissions for young drivers.

Rationale:

Ireland is one of the few European countries that does not permit teenagers to drive light quadricycles, despite their availability and affordability. Countries such as France, Spain, and Italy allow 14 to 16-year-olds to operate these vehicles under specific training and licensing schemes. Introducing similar legislation here would promote safe, sustainable mobility options for younger people and reduce reliance on higher-risk two-wheeled vehicles.

This motion calls for modernisation of road traffic laws to reflect advancements in light vehicle technology and provide practical transport solutions for young people across Ireland.'

28.3 **DISTRICT COURT FAMILY LAW**

'That Cork City Council write to the Minister for Public Expenditure Jack Chambers and the Minister for Justice Jim O'Callaghan calling on them to increase the legal aid fees payable to solicitors on the District Court Family Law Solicitors Panel so as to ensure that more solicitors are able to do family law legal aid work and with a view to clearing the backlog in family law applications in the District Court in areas such as applications for domestic violence orders, disputes regarding custody and access to children and maintenance applications.' (Proposer: Cllr. S. O'Callaghan 25/115)

28.4 EDUCATION FOR CHILDREN WITH ADDITIONAL NEEDS

'That Cork City Council write to the Minster for Education urgently calling on her to: (i) immediately expand the number of special school places, special classes and special education teaching hours in Cork and across the State; (ii) ensure that every child currently without a suitable school place for the 2025/26 school year gains access to a school place within a reasonable distance from their home; and (iii) radically overhaul an education system that fails to uphold the rights of children with additional needs.'

have had to leap into ditches to avoid oncoming traffic. The narrowness of the road and the behaviour of other drivers exacerbate the situation, making it perilous, especially for children attempting to access local bus stops (routes 215 and 203).

3. **Previous Incidents**: Tragically, there has already been one fatal accident on this road, underscoring the urgent need for intervention to prevent future incidents.

4. **Community Initiatives**: In response to the safety concerns, residents have taken it upon themselves to place traffic cones and barriers outside their homes in an attempt to slow down traffic, demonstrating the severity of the problem.

Proposed Actions:

1. **Traffic Calming Measures**: The Council should assess and implement appropriate traffic calming measures along Kiln Road. This could include speed bumps, signage to reduce speed, and enhanced visibility for drivers.

2. **Pedestrian Infrastructure**: Investment in adequate footpaths and safe crossings for pedestrians should be prioritized to protect walkers, especially children.

3. **Community Engagement**: The Council should actively engage with the community to understand their concerns fully and to gather suggestions for making Kiln Road safer.

4. **Regular Monitoring**: A plan for regular monitoring of traffic speed and safety conditions on Kiln Road should be established, ensuring that any additional measures needed can be promptly addressed.

Conclusion:

The safety and well-being of the residents of Killeens is of utmost importance. By acting swiftly to implement traffic calming measures on Kiln Road, Cork City Council can demonstrate its commitment to community safety and help prevent future tragedies. We urge the Council to prioritize this matter and take decisive action.'
