## LOCAL COMMUNITY HERITAGE AND BIODIVERSITY GRANT SCHEME

Applications are sought by Cork City Council, for the Local Community Heritage and Biodiversity Grant 2025. This grant scheme is an action from the Cork City Heritage and Biodiversity Plan 2021 – 2026 Heritage and Biodiversity Plan - Cork City Council which outlines the aims and objectives of Cork City Council with respect to Heritage and Biodiversity. Grant aid is distributed in accordance with these aims and objectives. For the purpose of these grant schemes Heritage is deemed to include Archaeology, Built, Natural and Cultural Heritage.

## **Local Community Heritage and Biodiversity Grant Scheme**

This grant scheme is aimed at providing core funding in the form of small grants for local, community-based Heritage and Biodiversity groups and individuals who are involved in ongoing work that benefits the Heritage and Biodiversity of Cork City. Funding of between €200 and €1,000 is available per grant. Examples of eligible activities include holding public talks and meetings, exhibitions, flyers and information leaflets, training and community events, Heritage Week projects and projects promoting the activities of Heritage and Biodiversity groups and organizations.

The closing date for submission of applications is 11am on the 4<sup>th</sup> of February 2025.

#### LOCAL COMMUNITY HERITAGE AND BIODIVERSITY GRANT SCHEME CRITERA

- Projects must be located in or refer to the Cork City's administrative area.
- The work in respect of which funding is sought must be Heritage and Biodiversity related.
- The project should link to an objective or action from the Cork City Heritage and Biodiversity
   Plan 2021 2026 Heritage and Biodiversity Plan Cork City Council
- The work in respect of which funding is sought must be carried out on a not-for-profit basis.
- Applications should be accompanied with details of matching funding and efforts to secure other sources of income. Where applicable details of funding from other sections from Cork City Council must be outlined.
- This grant cannot fund projects retrospectively.
- Applications should be accompanied by relevant supporting documentation e.g. history of organisation, past projects etc.
- Your organization must demonstrate on request observance of standard codes of practice in general welfare issues including child and vulnerable adult protection policy, health and safety,

fire regulations, appropriate insurance, disability access and equal opportunities where applicable.

- Cork City Council will accept no responsibility or liability for costs and expenses incurred as a
  direct or indirect consequence of the project/publication or statements in connection with the
  project/ publication to include without limitation statements in any project which are alleged to
  be plagiarism, libelous, offensive, or defamatory.
- Applications by individuals will only be supported for a defined project e.g. leaflet, exhibition etc.
- The funding for equipment, building maintenance, travel or stationery expenses, research, or administration costs, for individuals and groups will not be supported unless it is clearly demonstrated that it is an integral part of the project.
- Applications for signage is not high priority and will be dealt with on an individual basis.
- Procedures should be put in place for the documentation and evaluation of the project.
- If there is change in the topic of the project or if it is not going ahead, you must inform the Heritage Officer at the earliest possible instance.
- The applicant must publicise the project e.g. exhibition, walk, talk, press release, poster etc.
- Priority will be given to applicants who organise an event in Heritage Week
- The support of Cork City Council for the project must be acknowledged in writing and with the Heritage and Biodiversity Plan and Cork City Council logo. This can be provided on request.

#### **Finance and Drawdown of Funds**

- All projects must be completed by 2pm on the 5<sup>th</sup> of December 2025
- The full 100% of the grant can be drawn down on completion of the project and only on producing a brief report, the relevant eligible invoices/receipts and photos. These invoices/receipts and photos must be originals or good quality legible scanned emails.

#### **Application Form**

- Applicants must complete all sections of the form and submit by the closing date of 11am on the
   4<sup>th</sup> of February 2025.
- The application form should ideally be sent in by email.
- Application forms are available in Irish on request.
