'That Cork City Council write to the Minister for Justice Helen McEntee calling on her to consider introducing the following measures to tackle the anti-social behaviour and open drug use that is occurring on a daily basis on the streets of Cork:

- the allocation of extra manpower, resources and funding to An Garda Síochána in Cork with the goal of ensuring that there is an increased Garda presence on the streets of Cork;
- increasing the maximum sentence for threatening, abusive or insulting behaviour in a public place from 3 months imprisonment to 1 year imprisonment;
- increasing the maximum sentence for intoxication in a public place from a €500 fine to 1 year imprisonment;
- increasing the maximum sentence for aggressive begging from 1 month imprisonment to 1 year imprisonment;
- the introduction of mandatory minimum sentencing for various public order offences where there has been repeat offending within a specified period.'

'In light of the remarkable achievements of Irish athletes on the global stage, particularly at the recent Olympics, and acknowledging the ongoing need to nurture and develop new and emerging talent within our City and beyond, I propose that Cork City Council formally supports the development of an indoor running track to serve the athletics community in the Cork area.

Rationale:

- 1. **National and Local Athletic Success:** The success of Irish athletes, including those hailing from Cork and Munster, has shone a spotlight on the importance of providing world-class training facilities. To build on this success and ensure future generations have the opportunity to excel, we must invest in the necessary infrastructure.
- 2. **Current Facility Deficit:** Despite the strong tradition of athletics in Cork, there is a glaring lack of sufficient indoor facilities to support athletes, particularly during the winter months. This deficit puts our local talent at a disadvantage compared to athletes in other regions who have access to indoor tracks.
- 3. **Fostering New Talent:** An indoor running track would not only benefit elite athletes but also provide a vital resource for schools, clubs, and community groups across Cork. It would enable year-round training, foster grassroots participation, and help identify and develop the next generation of Irish sports stars.
- 4. **Health and Wellbeing:** Beyond the competitive aspect, such a facility would contribute to the overall health and wellbeing of our citizens by promoting physical activity in a safe and accessible environment.

Conclusion:

Given the clear benefits to our community and the potential to enhance Cork's reputation as a hub for sporting excellence, I ask that Cork City Council:

- 1. **Endorse the proposal** for the development of an indoor running track.
- 2. **Seek out potential partnerships** and funding opportunities at the local, national, and EU levels to bring this project to fruition.
- 3. **Initiate a feasibility study** to identify the most suitable location and scope for this facility within Cork City.

By supporting this motion, we can take a significant step towards ensuring that Cork continues to produce top-tier athletes and remains a leader in sports development.

I respectfully request that this motion be considered and supported by the members of Cork City Council, with a view to taking actionable steps towards the development of this much-needed facility.'
